The KING's Most Excellent Majesty in Council. 7 HEREAS it has been represented to His Majesty at this Board, that in consequence of the Progress of the French Arms in the Territories of the Grand Duke of Tuscany, the Payment of Bills of Exchange, drawn or negociated in the Town of Leghorn, may be deemed unlawful, by virtue of the Provisions contained in an A& passed in the Thirty-fourth Year of His Majesty's Reign, intituled, "An Act for preventing Money " or Effects in the Hands of His Majesty's Subjects, -" belonging to or disposeable by Persons resident in " France, being applied to the Use of the Persons " exercifing the Powers of Government in France; and for preferving the Property thereof for the "-Benefit of the individual Owners thereof;" and in an Act passed in the same Session, intituled, "An . Act for more effectually preferving Money or " Effects in the Hands of His Majesty's Subjects, belonging to or disposeable by Persons resident in " France, for the Benefit of the individual Owners " thereof;" unless His Majesty shall licence the Payment of fuch Bills, in pursuance of the Powers given by the said several Acts; His Majesty, taking the same into His Royal Consideration, is pleased, by and with the Advice of His Privy Council, to order, and it is hereby ordered, That it shall be lawful for any Person residing or being in Great

Britain to pay any Bill drawn or indorfed in the faid Town of Leghorn, and fent from thence on or before the Day on which the Armies of France entered the faid Town of Leghorn; provided fuch Bill shall have been made payable at no greater Distance of Time than Usance of Three Months from the Date thereof, or Three Months from Sight thereof; provided also that all and every Person and Persons, who shall take the Benefit of such Licence hereby granted, fhall fo take the fame, upon Condition, that in case of any Proceeding, Criminal or Civil, under the Provisions of the said Acts of Parliament, or either of them, for any Thing alledged to have been done contrary thereto, any Question shall arise, whether the Thing fo done was authorized by the Licence hereby given, the Proof that such Thing was done, under the particular Circumstances, and according to the special Terms and Conditions required by this Order, shall lie on the Persons claiming the Benefit of fuch Licence. The KING's Most Excellent Majesty in Council.

THEREAS His Majesty was graciously pleased, by His Royal Proclamation bearing Date the Twenty-fixth Day of December, 1792, to promise and declare, that the Bounties of Five Pounds for every Able Seaman, and Two Pounds Ten Shillings for every Ordinary Seaman, fit for His Majesty's Service, should be paid in the Manner thereby directed to every fuch Able and Ordinary Seaman, not above the Age of Fifty nor under the Age of Twenty Years, who should, on or before the Twenty-eighth Day of February then following, enter themselves to serve in His Majesty's Royal Navy, either with the Captains or Lieutenants of His Majesty's Ships or Vessels, or Officers employed on Shore for raifing Men for the Service of the Royal Navy: And whereas His Majesty was also graciously pleased, by his said Proclamation, to declare, that all Able-bodied Landmen, not above the Age of Thirty-five nor under the Age of Twenty Years, who should so enter themselves as aforesaid, should receive the Sum of Thirty Shillings each Man, as His Majesty's Royal Bounty! And whereas His Majesty was also graciously pleased, by His Royal Proclamation bearing Date the Sixteenth Day of the faid Month of February, 1793, to promise and declare, that a Reward of Twenty Shillings for every Able and Ordinary Seaman, fit to ferve on board His Majesty's Ships, should be paid to any Person who should discover any Seaman or Seamen who might conceal him or themselves, so that such Seaman or Seamen should be taken for His Majesty's Service, on or before the Thirtieth Day of April then next, by any of His Majesty's . Sea Officers appointed to raise Men on Shore, or by the Captains or Commanders of any of His . Majesty's Ships or Vessels in the Ports or on the

Coasts of this Kingdom: And whereas the Time limited by the faid Proclamations for Payment of the faid Bounties and Reward; hath been prolonged and extended to the Thirty-first Day of August next; and it being judged expedient for His Majesty's Service that the faid Bounties and Reward should be continued to be paid for some Time longer; His Majesty, with the Advice of His Privy Council, doth therefore order, and it is hereby accordingly ordered, that the Time limited for Payment of the faid Bounties and Reward be prolonged and extended, from the faid Thirty-first Day of August next to the Thirty-first Day of October following: Whereof all Perfons concerned are to take Notice, and govern themselves accordingly.

Copy of a Letter from Vice Admiral Kingfmill, Cmoe mander in Chief of His Majesty's Ships and Veffels at Gork, to Mr. Nepeun, dated L'Engageantes Cork Harbour, July 31, 1796.

DLEASE to inform my Lords Commissioners of the Admiralty, that His Majesty's Ships Cerberus and Sea-Horie arrived here Yesterday Asternoon: During their Cruize they captured a French Privateer Cutter, called the Calvados, mounting Six Guns, Ten Swivels, and Thirty-eight Men, which had been out Ten Days from Brest, but not made any Prize, and they sent her to Plymouth.
