Provided alfo, that every Perfon who shall take the Benefit of this Licence and Authority, shall take the fame upon Condition, that if in cafe of any Proceeding, Civil or Criminal, under the Provisions of any of the Acts herein before mentioned, for any Thing alledged to have been done contrary.
