And it is hereby further notified, that all Out-Penfioners in South Britain and Wales (except as aforefaid) who shall not appear at the Times and Places herein appointed, will be considered as otherwise provided for by Government, or as Dead; and they will accordingly be struck off the Books of the Out-Pension of the said Hospital, without any Prospect of being restored thereto.

Such Deferters, if able-bodied Men and fit for Service, shall be appointed to such Regiments as His Majesty may be pleased to command; and shall not be liable to be claimed by any other Corps to which they may formerly have belonged.

And whereas many of the faid Deferters may have enlisted in other Regular Corps, and are now ferving therein, His Majesty is graciously pleased to extend to such Descriters the Benefit of this Pardon; and to direct that they shall continue to serve in the Corps wherein they now are, without being under the Necessity of declaring themselves Deserters, in order to entitle them to the Benefit of this Pardon; and they shall not be liable, as any future Time, to be claimed by the Regiments in which they formerly ferved: But this Clause is not to extend to Deferters enlisted by the Corps raising Recruits for general Service; which Deferters are only to be entitled to their Pardon on declaring themselves at Chatham Barracks to be fuch, and being there transferred to ome established Regiment.

And whereas feveral of the faid Deserters have been apprehended, and are now in Gaol, or in Regimental Custody, His Majesty is likewise pleased to grant them his free Pardon, of which they are to have the Benesit upon their Arrival under Escort at Chatham Barracks, where they will be disposed of in the Manner above-mentioned.

Any Soldier who may defert after these His Majesty's gracious Intentions are made public, shall not be included in the above Pardon, but be proceeded against with the utmost Severity.

ALL Officers on the Half-Pay of the British Establishment, resident in Great Britain and Ireland, are hereby required to transmit to the Secretary at War, within One Month from the Date hereof, an Account in Writing of their Age, past Services and present Places of Abode: And such as think themselves from Age or Insimities unsit for further Service even in this Country, are to accompany their Reports with sufficient Vouchers of their Inability, and the Causes thereof: The Officers resident Abroad are to make their Reports in Six Months;

Months; those in the East Indies excepted, who are

allowed Twelve Months.

Should any of the faid Officers neglect to pay due Attention to this public Notice, within the respective Periods above limited, they will be confidered as otherwife provided for, or dead; and their Names will be struck off the Half-Pay Lift accordingly.

MINUTES of the Forms and Ceremonies obierved in the House of Peers on Opening the new Par-

House of Lords, September 27

THE Lord Chancellor acquainted the House, that His Majesty not thinking fit to be personally present here this Day, had been pleased to cause a Commission to be issued under the Great Seal, in order to the Opening and Holding of this Parliament.

Then Three of the Lords Commissioners being seased on a Form, placed between the Throne and the Woolfack, the Lord Chancellor in the Middle, with the Lord Archbishop of Canterbury on his Right Hand and the Lord President on his Left, commanded the Gentleman Usher of the Black Rod to let the Commons know the Lords Commissioners desire their immediate Attendance in this House, to hear the Commission read; who being come,

The Lord Chancellor faid,

" My Lords, and Gentlemen of the House of Commons,

His Majesty, not thinking fit to be present here " this Day in His Royal Person, has been pleased, in order to the Opening and Holding of this Par-" liament, to cause Letters Patent to be passed under "his Great Seal, constituting us, and feveral other Lords therein named, his Commissioners to do all " Things in His Majesty's Name, on his Part ne-" cessary to be performed in this Parliament. This " will more fully appear by the Letters Patent them-" felves, which must now be read."

Then the faid Letters Patent were read by the Clerk: Which done,

The Lord Chancellor faid,

My Lords, and Gentlemen,

" We have it in Command from His Majesty to " let you know, that His Majesty will, as soon as " the Members of both Houses shall be sworn, in " Person declare to you the Causes of his Calling " this Parliament; and it being necessary a Speaker " of the House of Commons thould be first chosen, " it is His Majesty's Pleasure that you, Gentlemen of the House of Commons, repair to the Place " where you are to fit, and there to proceed to the " Choice of some proper Person to be your Speaker, " and that you present such Person whom you shall " fo choose, here Tomorrow at Twelve o'Clock, " for His Majesty's Royal Approbation."

House of Lords, September 28. Several Lords took the Oaths.

Then Three of the Lords Commissioners, being in their Robes, and feated as on the preceding Day, commanded the Gentleman Usher of the Black Rod to let the Commons know, that the Lords Commiffioners defired their immediate Attendance in the House of Lords:

Who being come, Mr. Addington faid,

« My Lords,

" In obedience to His Majesty's Commands, the Commons of Great Britain have proceeded to the Election of one of their Members to be their " Speaker, and their Choice has fallen upon me, " whom they now present for his Majesty's Royal " Approbation."

Then the Lord Chancellor acquainted the Commons, that they were commanded by His Majesty to acquaint them, that His Majesty was perfectly satisfied with the Choice they had made, and doth allow and confirm Mr. Addington to be their Speaker; and doth also, in pursuance of their Request, grant and allow them all their ancient Rights and Privileges, as hath been accustomed.

Then the Commons withdrew.

St. James's, September 28.

This Day Mahomet Cagga, Ambassador Extra-ordinary and Plenipotentiary from Tunis, was at Court, and had a private Audience of His Majesty: To which he was introduced by his Grace the Duke of Portland, His Majesty's Principal Secretary of State for the Home Department, and conducted by Sir Clement Cottrell Dormer, Knt. Master of the Ceremonies.

An Estafette from Ratisbon is just arrived at this Place, informing us, that, on the 11th Instant, the Austrian Generals Frolich and the Prince Furstenberg had made a successful Attack on the Enemy's Forces assembled near Munich, and forced them to a precipitate Retreat, with the Loss of about 2000 Men killed and wounded, and of 1500 taken Prisoners. This Victory was chiefly decided by a skilful Manœuvre of General Hotze, in confequence of which he had effected a Passage over the Danube, near Donawerth, with a considerable Body of Imperial Troops, with whom he attacked most vigorously the French Corps besieging Ingolstadt, and obliged thesh to raise the Siege with great Loss.
