PRESENT,

The KING's Most Excellent Majesty in Council.

7HEREAS His Majesty was graciously plcafed, by His Royal Proclamation bearing Date the Twenty-fixth Day of December, 1792, to promise and declare, that the Bounties of Five Pounds for every Able Seaman, and Two Pounds Ten Shillings for every Ordinary Seaman, fit for His Majesty's Service, should be paid in the Manner thereby directed to every fuch Able and Ordinary Seaman, not above the Age of Fifty nor under the Age of Twenty Years, who should, on or before the Twenty-eighth Day of February then following, enter themfelves to ferve in His Majefty's Royal Navy, either with the Captains of Lieutenants of His Majefty's Ships or Veffels, or Officers employed on Shore for raifing Men for the Service of the Royal Navy: And whereas His Majesty was also graciously pleased, by his faid Proclamation, to declare, that all Able-bodied Landmen, not above the Age of Thirty-five nor under the Age of Twenty Years, who should fo enter themfelves as aforefaid, fhould receive the Sum of Thirty Shillings each Man, as His Majesty's Royal Bounty: And whereas His Majesty was also graciously pleased, by His Royal Proclamation bearing Date the Sixteenth Day of the faid Month of February, 1793, to promife and declare, that a Reward of Twenty Shillings for board His Majesty's Ships, should be paid to

any Person who should discover any Seaman or Seamen who might conceal him or themfelves, fo that fuch Seaman or Seamen should be taken for His Majesty's Service, on or before the Thirtieth Day of April then next, by any of His Majefty's Sea Officers appointed to raife Men on Shore, or by the Captain's or Commanders of any of His Majefty's Ships or Veffels in the Ports or on the Coafts of this Kingdom: And whereas the Time limited by the faid Proclamations for Payment of the faid Bounties and Reward, hath been prolonged and extended to the Thirtieth Day of this inftant June; and it being judged expedient for His Majefty's Service that the faid Bounties and Reward should be continued to be paid for fome Time longer; His Majesty, with the Advice of His Privy Council, doth therefore order, and it is hereby accordingly ordered, that the Time limited for Payment of the faid-Bounties and Reward be prolonged and extended, from the faid Thirtieth Day of this inflant June to the Thirtyfirst Day of August next inclusive ;- Whereof all Perfons concerned are to take Notice, and govern themfelves accordingly.

PROCLAMATION,

For the Suppression of the Mutinous and Treasonable Proceedings of the Crews of Our Ships at the Nore.

GEORGE R. WHEREAS, upon the Repreferitation of Our Lords Commissioners of Our Admiralty respecting the Proceedings of the Seamen and Marines Pines on Board certain of Our Ships at the Nore, We were pleafed to command Our faid Lord Commillioners of the Admiralty to fignify to the faid Seamen and Marines Our gracious Intentions, expreffed in Our Royal Declaration, under Our Sign Manual, bearing Date at St. James's, the Twentyfeventh Day of May instant, in the Words following : "Whereas it has been reprefented unto Us, that, " notwithstanding the Declarations made in Our " Name, and by Our Authority, by Our Lords Commissioners of Our Admiralty, of Our gracious " Intentions to recommend to the Confideration of " Parliament, to augment the Wages and Allow-* ances of the Seamen and Marines of Our Fleet, * which Our gracious. Intentions and Declarations * have fince been carried into Effect by an Act of " Parliament; and, notwithstanding the Commu-" nication made by Our Right Trufty and Right "Well-beloved Coufin and Councillor Richard Earl "Howe, Admiral of Our Fleet, of Our gracious " Intentions towards the Seamen and Marines of " Our Fleet, for the Pardon of the Offences by them committed, and Our Royal Proclamation " thereupon, bearing Date the Eleventh Day of " May instant ; and notwithstanding the Sentiments " of Duty and Gratitude with which the fame were " received by the Seamen and Marines of Our other " Squadrons, yet the Crews on Board certain of " Our Ships at the Nore have not only fince the " full Manifestation of all these Our gracious In-" tentions and Declarations been guilty of divers " Acts of Mutiny and Difobedience of Orders, " but have even proceeded to other Acts of the * most heinous and treasonable Nature, by firing " upon fome of Our Ships in order to compel them " to fubmit to their Direction; have threatened ! " and taken Measures for stopping the Commerce " of the Kingdom pailing to and from the Port of « London, and have, by Terror of their Force, " compelled Two Frigates to defift from executing " a particular Service, which by Our Orders they " were directed to perform : We, thinking it right " to warn all Our Seamen and Marines on Board the " faid Ships of the heinous Nature of the Offences by " them committed, and of the dangerous Confe-" quences thereof to the Spirit and Discipline of the " British Navy, and to the Welfare of their Country, s' as well as their own Safety, do hereby earnestly " require and enjoin all Our faid Seamen and Ma-« rines, immediately on the Notification of this " Our Royal Declaration, to return to the regular " Difcharge of their Duty, as has already been done by the Crews of Our other Squadrons and Fleets, " ftationed at Portfmouth and Plymouth, and elfe-" where: And whereas We are well affured that a great Part of the Seamen and Marines on Board ۴¢ " the faid Ships at the Nore abhor and deteft the « Criminal Proceedings which are still persisted in " on Board the faid Ships, and are defirous to return " to their Duty: Now, We being defirous to ex-« tend Our Gracious Intentions of Pardon to all " fuch Seamen and Marines fo ferving on Board " Our faid Ships at the Nore, who may have returned, or shall return, upon the Notification of " this Our Royal Declaration, to the regular and " ordinary Discharge of their Duty, have authorized, " and do hereby authorize and empower Our faid " Lords Commissioners of Our Admiralty, or any

Three of them, to fignify to all fuch Seamen and Marines, who may have been guilty of any of the treafonable Acts aforefaid, or of any Mutiny or Disobedience of Orders or Neglect of Duty, and who have returned, or who shall, upon Notification hereof on Board their refpective e e " Ships, return to the regular and ordinary Dif-charge of their Duty, Our Royal Intentions to .. grant to all fuch Seamen and Marines Our molt Gracious Pardon, and to promife, in Our Name, to all fuch Seamen and Marines, who have fo " " returned, or shall fo return to the regular and ordinary Discharge of their Duty, Our most gracious Pardon accordingly : And We do hereby ** " declare, that all fuch Seamen and Marines, who fhall have fo returned, or fhall fo return to their Duty, and to whom the faid Lords Commissioners " of Our Admiralty, or any Three of them, fhall fo promife Our Pardon, fhall receive the fame accordingly, and fhall be difcharged and releafed " " • • from all Profecutions, Imprisonments and Penalties incurred by reason of any of the Acts aforefaid, or by reafon of any Act of Mutiny or Difubedience " of Orders, or any Breach or Neglect of Duty previously committed by them or any of them; hereby declaring at the fame Time, that all fuch Seamen and Marines who shall not take the Benefit of this Our gracious Pardon, shall from henceforth be confidered as liable, according to the ٠. Nature of their Offences, to fuch Punishmennt as the " Articles of War and the Law have provided for the "fame." And whereas Our Right Truffy and Right Well-beloved Coufin and Councillor George John Earl Spencer, Our Trufty and Well-beloved Charles George Lord Arden of Our Kingdom of Ireland, and William Young, Elquire, Rear-Admiral of the White, being Three of the Lords Commissioners of Our Admiralty, did caufe Our gracious Intentions expressed in such Our Declaration, to be fignified to the Crews of Our Ships at the Nore, and did require fuch Crews to return to their due Obedience accordingly : And whereas it has been reprefented to Us, that fome of the Crews of Our faid Ships have been defirous of returning to their Obedience accordingly, but have been prevented from fo doing by Violence and others of Our Ships, in the actual Difcharge of their Duty, have been fired upon, and Attempts have been made to prevent fome of Our Ships from proceeding according to the Orders of their Commanders : And whereas fuch continued Perfeverance in rebellious and treasonable Attempts against Our Crown and Dignity, after repeated Admonitions and offers of Our gracious Pardon, render it neceffary for us to call on all Our loving Subjects to be aiding and affifting in repreffing the fame; We have thought fit, by the Advice of Our Privy Council, to iffue this Our Royal Proclamation, and We do hereby firicily enjoin and command all Our Admir rals, Generals, Commanders and Officers of Our Forces by Sea and Land, and all Magistrates whatfoever, and all others Our loving Subjects, that they, in their feveral Stations, do ufe their utmost Endegvours, according to Law, to suppress all fuch mutinous and treafonable Proceedings, and to use all lawful Means to bring the Perfons concerned therein, their Aiders and Abettors, to Juffice : And We do hereby firicity enjoin and command all Our loving Subjects whatfoever not to give any Aid, Comfort, Affiftance Affiftance or Encouragement whatfoever to any Perfon or Perfons concerned in any fuch mutinous and treafonable. Proceedings, as they will answer the fame at their Peril; and alfo, to the utmost of their Power and according to Law, to prevent all other Perfons from giving any fuch Aid, Affistance, Comfort or Encouragement.

The Character which the Britith Navy have hitherto fuftained for unalterable Loyalty and determined Bravery, leave us no Room to doubt that this Defection has been occasioned through the Artifices of bafe and unprincipled Men. We fincerely feel for that Anxiety and Diffress of Mind which an Event fo alarming muft occasion to your Majesty, and devoutly pray that these deluded Men may soon be induced to return to their Duty, and by their future Conduct repair the Dishonour they have done to their Country. We are happy to affure your Majefty of the Loyalty of the People under our Charge, and their Attachment to our glorious Conftitution, and we will not cease by every Mean in our Power to cherish these Sentiments among them. That He who stilleth the Noife of the Seas, and the Tumult of the People, may turn Wars into Peace unto the End of the Earth, and blefs your Majefty with everlasting Confolation and good Hope through Grace, is the earnest Prayer of

The Meeting having heard with the deepeft Concern of the prefent difgraceful and criminal Conduct of fome of the Seamen of His Majefty's Fleet, most fincerely hope and trust, that none of the Seamen or others, who have gone from this Port to ferve in the Navy, have been induced to take Part in fuch mutinous and treasonable Conduct: And being ing fully determined to express their utmost Indignation against this foul and unnatural Treason, they do

Unanimoufly refolve, that they will not employ in their Ships or otherways countenance any Seamen or others on their Return from ferving in the Navy, unlefs they fhall produce a Certificate of their good and orderly Behaviour during fuch Service, or that (having been for a Time milled) their future Conduct had merited and procured them His Majefly's most gracious Pardon.

Refolved, That this Meeting will, to the utmoff of their Power, collectively and individually, aid and affift the Civil Magistrates in apprehending and fecuring all Perfons concerned in state treatonable and recellious Proceedings, and in detecting and bringing to condign Punishment all Perfons who have attempted, or who shall hereafter attempt, to feduce from their Duty and Allegiance, His Majesty's Forces by Sea or Land; and, generally, that they will give their Aid to such Measures as His Majesty, in his Wisdom and paternal Care of his People, may be pleafed to direct for the Suppression and Punishment of Offences of so high and dangerous a Nature,

It was moved, and unanimoufly agreed to, that the Thanks of this Meeting be given to Provoft Ballantine for calling the fame, and which was done accordingly.

AT Irvine, the 13th Day of June, 1797 Years. At a refpectable Meeting of the Merchants, Ship Owners and Ship Masters of the Town and Port of Irvine, in the Court-House, conveued agreeable to Intimation from the Magistrates,

JOHN WEBB, Efq; of Towerlands, in the Chair,

The whole Perfons convened being firmly attached to His Majefty and the British Constitution, and having a fincere Love for their Country, are deeply concerned at the diforderly and mutinous Proceedings of Part of His Majefty's Fleet at the Nore, which the Meeting regret and behold with Abhorrence; they confider it to be their Duty, and the Duty of all other Perfons who love their Country, to publish and openly declare their constitutional Sentiments on the prefent important Crisis, whereby they may, as far as in them lies, difcourage the faid diforderly and mutinous Proceedings of the Seamen.

The Meeting, to shew their Disapprobation of the Conduct of these deluded Men, have unanimonfly refolved, That after the Bleffings of Peace shall be reflored to this Kingdom, they will not employ any of the Seamen who are at prefent on Board the Ships of War declared to be mutinous, unless they bring with them and produce a Certificate from a Navy Officer, bearing that they returned to their Duty, and thereafter behaved as dutiful and loyal Subjects : And, for carrying this Refolution into Effect, the Meeting defire their Prefes to request the Lords Commillioners of Admiralty to give the necessary Directions, when the Seamen are difcharged, that Certificates, in the Manner proposed, may be given to them, in cafe such Seamen shall have merited the fame by their good. Conduct and Behaviour after Return to their Duty.

The Meeting request the Prefecto fign this Minute in their Name, and to transmit these Refolutions to the Lord Licutenant of the County of Ayr,

with a Request that his Lordship may transmit the fame to the Secretary of State. Lastly, The Meeting returned Thanks to the Prefes for calling them together, and for his Attention to
