Extract of a Letter from Captain Sir Richard Strachan, 'Bart.' of His Majesty's Ship Diamond, to Mr. Nepean, dated at Spithead, the 23d Instant.

SINCE writing my Letter of Yesterday's Date, we chaced on Shore, near Cape La Heve, a Lugger Privateer. The Crew had left her and affembled on the Top of the Cliffs; and, being joined by Numbers, prepared to repel any Attempt we might make to get her off: I fent the Boats, under the Orders of Lieutenant Rogers, to defroy her. This Service he effected with great Judgment; nd, notwithstanding a constant Fire from the Enemy, we had the good Fortune to have only One Man wounded: We suppose the Enemy have lost feveral.
