Whiteball, December 16, 1797. H IS Majesty is pleased to permit the Members of both Houses of Parliament to pass through the Gates of the Parks, at the Top of Constitution Hill and the House Guards, in their Way to the Two Houses, on Tuesday next, till Half past Eight o'Clock in the Morning.

THE Magistrates have been directed to place a fufficient Number of Constables in all the Streets leading into Pall-Mall, Cockspur-Street, Charing-Cross, and the Strand, to prevent all Carriages and Horses passing into those Streets, on Tuesday next, the 19th Instant, excepting such as are to compose a Part of the Procession to attend His Majesty to St. Paul's;

It is therefore expected, that no Perfon whatever will attempt to drive or ride into either of those Streets, on that Day, until the Procession shall have returned to St.

James's, or interrupt the Constables or Soldiers in the Execution of the Service which they are directed to perform.

The Peeresses, and other Persons, having a Right to Places in St. Paul's, are delired to pass down Holborn; and the like Orders are given to the Magistrates to provide for their free Passage, by that Route, to and from the Cathedral.

SUCH Inhabitants of Pall-Mall and the Strand as may intend to use their Carriages on the 19th Instant, are hereby defired to fend them, very early in the Morning, into the Streets and Squares to the Northward of their respective Situations: Those of Pall-Mall, into St. James's-Street, St. James's-Square, &c.. Those of Cockspur-Street, and that Neighbourhood, into the Haymarket and Leicester-Square: And those of the Strand and Streets leading from it towards the River, into Covent-Garden add

#### PROCESSION TO ST. PAUL'S

#### ANDERSON, MAYOR.

Ordered, HAT the following Regulations be adopted for the Accommodation of their Majefties and the Royal Family, the Members of both Houses of Parliament, the Foreign Ministers, the Aldermen, &c. of London, and others passing to and returning from the Cathedral Church of St. Paul on Tuesday the 19th of December, 1797

That there be Three Avenues to the Church kept with diffinct Outlets from each, for the Carriages to pass off and return. . u.

West Avenue for their Majesties, the Royal Family, the Members of both Houses of Parliamont, and the Foreign Ministers.

fage of their Majefiles, the Royal Family, the Members of both Houses of Parliament, and the Foreign Ministers; all their Carriages to pass in fingle Rank, and no other Carriage whatever to be admitted.

It being underflood that their Majetties and the Royal Family will enter the Church at the Weft Door, their Carriages are to drive in at the Weft Gate of the Church-Yard, put down at the Bottom of the Steps, draw off to the North Side of the Church, and there wait until Divine Servine is over;

then return to the Bottom of the Steps, to take up. It is recommended that the Carriages of the Menbers of both Houfes of Parliament, and of the Foreign Minifters, put down at the South-Weit Gate of the Church-Yard; and that they order their Servants to proceed with their Carriages on the South Side of the Church-Yard, Eastward, through Watling-Street and Budge-Row; to turn up Walbrook, pais the West Side of the Mansion-House, and return through the Poultry into Cheapfide; and to remain on the South Side of Cheapfide, in Three . 7 Rows, with the Horfes towards the Church, until called for.

## North Avenue for the Nobility (not in Parliament) and other Perfons from the West End of the Toun.

That the Nobility, Gentry, and others, coming into Holborn from the Welt End of the Town, be requested to proceed along Snow-Hill and Newgate-Street; turn to the Right down Warwick-Lane, and then to the Left along Paternolter-Row, and be fet down at Canon Alley, opposite the North Door of the Church; then to order their Servants to proceed with their Carriages to the End of Paternoster-Row, and turn round to the Left into Newgate-Street, then down St. Martin's-le-Grand into Aldersgate-Street (keeping the Left Side of the Street) to Long-Lane, and return on the Right; there to remain in a double Row, with the Horfes towards Newgate-Street, until Divine Service is ended, and then to return the fame Way to take up.

#### Eastern Avenue for the Corporation.

That the Lord Mayor, Sheriffs and Four Gentlemen of the Common Council, deputed to reprefent the Corporation, proceed from the Manfion-Houfe rather before Nine o'Clock, through Cheapfide, round the South Side of St. Paul's Church Yard, and up Fleet-Street to Temple-Bar; put down at Meffrs. Child and Company's ; then direct their Carriages to turn fhort about (within Temple-Bar, if poslible,) and follow each other down Fleet-Street round St. Paul's Church Yard, and along Cheapfide, turn to the Left down King-Street, and wait in Guildhall-Yard till called for.

That the Aldermen and City Officers immediately follow the Lord Mayor, Sheriffs and Deputation to the South Side of St. Paul's Church Yard, fet down at the South Door of the Church, and order their \* Carriages to turn short about, and return the fame Way they came to the Top of King-Street, then turning down King-Street into Guildhall-Yard, continue there till, called for.

To the Members of both Houles of Parliament to be, in the Church before Ten o'Clock, that their Majeffies and the Royal Family may not be stoppedor impeded in going to the Church:

#### 2:2005 General Directions.

That in order to keep the Avenues to and from the Church as clear and open as possible, Posts with Bars be fixed at the Entrance of all the Streets and Passages on the North and South Sides of Fleet-Street, Ludgate-Hill, Ludgate Street, St. Paul's Church-Yard, Watling Street, Budge-Row, the Poultry, Cheapfide, Newgate-Street, Show-Hill, Holborn up to the Bars, and Paternoster Row, and at the Entrance of all the Streets and Passages on the East and Weft Sides of Walbrook, King-Street, St. Martin'sle-Grand, and Alderfgate-Street, as far Northward as the Corner of Barbican.

That Posts and Rails he fixed from the South-East Corner of Paternoster-Row, rounding to the North-Side of Newgate Street; from the North-East Cor-ner of Dowgate-Hill crois Cannon-Street to the South-East Corner of Walbrook; and from the North-East Corner of the Manifon House cross the Street to the South-West Corner of Prince's-Street; and from the South-Weft Corner of Barbican, crofs Alderfgate-Street to the South-East Corner of Long-Liane; and from the North-East Corner of Warwick-Lane crofs Newgate-St, eet: 'And' that at the Ends of all other Streets and Passages communicating with the Lines of the different Processions Posts and Rails be fixed in like Manner.

Church ; and that no Coach or other Carriage, (except those belonging to the Perfons above-mentioned) be fuffered to remain in any Street or Paffage within the Extent of fuch Pofts and Bars on any Pretence whatever.

That where Two or more Lines of Carriages coming from different Streets, in order to proceed towards the Church, are to fall into One Line, Constables und other proper. Persons be stationed, who shall direct the feveral Lines to advance alternately, One Carriage from each, into the fingle Line; and shall immediately take into Custody any Coachman or other Perfon who shall relist or difabey fuch Orders as may be given for the Observance of this Regulation.

That all Carriages in the North-Weft Avenue shall advance in a fingle Line from Holborn-Bars; and that all Carriages in the Eastern Avenue shall advance in a fingle Line from the Manfion-Houfe.

That Constables and other proper Perfons be placed to fecure all the Bars, Poils and Rails in every Paffage where they shall be fixed.

That Constables and other proper Persons be placed to keep clear and nninterrupted the Footway from the North-Weft Avenue through Canon-Alley; and the Footway from the Eastern Avenue along the Church-Yard to the Church.

That no Hackney Coach be permitted, on any Pretence whatfoever, to be drawn within those Parts of the City to be inclosed with Posts and Rails; and that the Commissioners for Hackney Coaches be requefted to take away the Licence from every Coachman who shall attempt the Breach of this Regula-, tion.

Ordered; That a Copy of the faid Resolution be-transmitted to the Postmaster-General, on Account of the Mail Coaches.

Ordered, That the faid Refolution be figned by the Town Clerk, and published in all the News-Papers; and that a sufficient Number of Copies thereof be also printed, and affixed in all publick Places within this City and Liberties.

Ordered, That Mr. Dance, the Clerk of this City's Works, do caufe Posts, Bars, and Rails to be fixed and continued in the feveral Places therein mentioned, and at fuch other Places as shall appear. to be necessary for the Purposes of the faid Refolution.

Ordered, That the Two Marshals of this City do provide fuch a Number of Conftables as the Lord Mayor shall direct, and station them in such Manner as shall effectually carry the faid Refolution into Execution.

#### PROCLAMATION Α

For giving Currency to a New Coinage of Seven Shilling Gold Pieces.

GEORGE R.

7HEREAS We have thought fit to order, That all the faid Poffs, Rails and Bars be nixed by Two of the Clock in the Morning, and con- be coined, which fhould be called "Seven Shilling Pieces," that certain Pieces of Gold Money should

Pieces," each of which should be of the Value of Seven Shillings, and Three of which should be of the Value of One Guinea ; and that each Piece should be be of the Weight of 1 Pennyweight 19 Grains 1460 Troy Weight, of Standard Gold, being One Third of the Weight of a Guinea; and that Three of fuch Pieces fhould be of the Weight of 5 Pennyweights 9 Grains  $\frac{4}{70000}$  Troy Weight, of Standard Gold, being the Weight of a Guinea, according to the Weights approved and confirmed by Us in Our Council, in purfuance of an Act made in the Fourteenth Year of Our Reign, intituled, "An Act for regulating and afcertaining the Weights to be made Ufe of in weighing the Gold and Silver Coin of this Kingdom." And We have further thought fit to order, that every fuch Piece of Gold Money, fo ordered to be coined as aforefaid, fhould have, on one Side thereof, Our Effigies or Por-traiture, with Our Name, and the Words Dei Gratiâ, and on the Reverse, the Regal Crown of England, with the following Legend, Mag. Bri. Fr. Et Hib. Rex. And whereas Pieces of Gold Money of the above Description have been coined at Our Tower of London, and will be coined there, in pursuance of Orders which we have given for that Purpofe, We have therefore, with the Advice of Our Privy Council, thought fit to iffue this Our Royal Proclamation; and We do hereby ordain, declare and command, that the faid Pieces of Gold Money fo coined and to be coined as aforefaid, shall be current and lawful Money of Our Kingdom of Great Britain, and fhall be called Seven Shilling Pieces, and fhall pals and be received as current and lawful Money of Our faid Kingdom; and every of fuch Pieces shall pars and be received as of the Value of Seven Shillings of Our lawful Money of Our faid Kingdom, and Three of fuch Pieces shall pars and be received as of the Value of One Guinea of Our lawful Money of Our faid Kingdom, in all Payments whatfoever.

Given at Our Court at St. James's the Twentyninth Day of November, One thousand feven hundred and nine-feven, in the Thirty-eighth Year of Our Reign.

WHEREAS the Time limited by His Majesty's 'Order in Council of the 7th Day of June last, for prohibiting the Exportation out of this Kingdom, or carrying Coaltwife, Gunpowder or Saltpetre, or any Sort of Arms or Ammunition, wil expire upon the 7th Day of this inftant December: And whereas it is judged expedient for His Majesty's Service, and the Safety of this Kingdom, that the faid Prohibition should be continued for fome Time longer: His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit and command, that no Perfon or Perfons whatloever, (except the Master General of the Ordnance for His Majesty's Service) do, at any Time during the Space of Six Months, to com-

mence from the 7th Day of this inftant December, prefume to transport into any Parts out of this Kingdom, or carry Coaftwife, any Gunpowder or Saltpetre, or any Sort of Arms or Ammunition, or thip or lade any Gunpowder or Saltpetre, or any Sort of Arms or Ammunition, on Board any Ship or Vessel, in order to transporting the same into any Parts beyond the Seas, or carrying the fame Coaff-wife, without Leave or Permifinon in that Behalf first obtained from His Majesty, or His Privy Counncil, upon Pain of incurring and fuffering the re-fpective Forfeitures and Penalties, inflicted by an Act passed in the Twenty ninth Year of His late Majesty's Reign, initialed, "An Act to impower His Ma-" jesty to prohibit the Exportation of Saltpere, and "to enforce the Law for impowering His Ma-"jefty to prohibit the Exportation of Gunpowder, " or any Sort of Arms or Ammunition; and alfo " to impower His Majefty to reftrain the carrying "Coaftwife of Saltpetre, Gunpowder, or any Sort of Arms for Ammunition."—And the Right Honourable the Lords Commissioners of His Ma-jesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master General of the Ordnance, and His Majesty's Secretary at War, are to give the necessary Directions . herein, as to them may respectively appertain. jefty's Service, and the Safety of this Kingdom, that the faid Prohibition fhould be continued for fome Time longer: His Majefty doth therefore, with the Advice of His Priyy Council, hereby order, require, prohibit and command, that no Perfon or Perfons whatloever, (except the Mafter General of the Ordnance for His Majefty's Service) do, at any Time during the Space of Six Months, to com-

" relative thereto." Have the Honor to acquaint you, that, after delivering your Difpatches to the Governor of Demarary, and Captain Manwaring of the Babet, on the 1st Instant, we immediately, in pursuance of your Orders, made Sail for Barbadoes, and at Day-Light on the 4th, that Island then bearing West Five or Six Leagues, we observed a Schooner on our Quarter making Sail after an American Brig to Leeward ; we continued our Course, but she discovering us to be an Armed Veffel, hauled her Wind to the Northward, as we did in Chace of her; and at Nine A. M. brought her to a close Action of Fifty Minutes, when the struck, proving to be L'Epicharis French Privateer, mounting 8 Carriage Guns, and having on Board 74 Men, belonging to Guadaloupe.

It is with Regret I add, that this was not accomplifhed without the Lofs of an excellent Seaman, and Four others wounded, One I fear mortally. The Lofs of the Enemy, I have Reafons to think, was great, as on our taking Possefilm of her Four Men were found laying dead on her Deck, and Twelve feverely wounded.

The Muster Roll of the Privateer being lost, and the Captain's Account not agreeing with the Number found, I have mentioned 74, as the Number actually counted by us when the ftruck.
