Brussels, July 7. Yesterday arrived an Express from Paris, bringing Letters from the Marquis de los Balbaces to his Excellency, in which he gives an account of the Marriage between the King of Spain and Madamoiselle d'Orleans being declared, and that he was going to sign the Articles of Marriage, which news has occasioned great rejoicing here. Our Letters from Nimeguen inform us that the Imperial and French Ambassadors were finally come to an Agreement about executing the Peace, the Emperor having consented to draw his Troops out of the Empire and to quit the places, he has at present Garrisons in, upon which the French will do the like. From the Hague they tell us, that the pressing Instances of the French Ambassador in behalf of the Count of Bentheim, are like to prevail with the States, to restore that Count's Children, which they had

had, at the desire of their Mother, and at their own, taken into their Protection. From *Strasbourg* we have an account, That those Magistrates were very much alarmed by the demand the Bishop of that City had made to have the Cathedral there, and the Revenue belonging thereunto, restored to him, letting them know, that in case of refusal, he shall be obliged to use Force.

*Hague, July 7.* The States of *Holland* have now before them the Memorial of the French Ambassador, concerning the Count of *Benthem's* Children, which this State received into their Protection at the desire of the Countess. It is a thing that has been the Subject of much dispute for several years last past, and therefore people are the more curious to see what the States will resolve in it upon the Memorial of the French Ambassador. We cannot yet know what resolution the States are like to come to concerning *Marstricht*; the Spaniards seem to persuade themselves that they will comply with the obligation of their Treaty, and deliver the place to the King of *Spain*, but others are of a contrary opinion. The Danes, as our Northern Letters tell us, are much displeas'd with the late proceedings of the Elector of *Brandenburg*, who say he ought not to have concluded his Peace, but jointly with the King of *Denmark*, who is now left alone in the War, but the Elector does not want Arguments to justify what he has done.

*Paris, July 8.* The new Queen of *Spain* has received the Compliments of the Foreign Ministers here, in the name of the several Princes their Masters and of all the persons of quality of the Court, and preparations are already making as well for the marriage which will be performed here by Proxy, as for her journey to *Spain*. The Chevalier de *Lorraine* is appointed to wait upon her thither, and several Ladies are named who are likewise to attend her, but are to leave her after her arrival at *Madrid*, the King of *Spain* appointing all the Servants and Officers of her Family. The marriage of the Dauphin with the Princess of *Bavaria*, and of the young Elector with *Mademoiselle de Blois*, Sister to the new Queen of *Spain*, is talked of at Court.

*Pendennis, June 29.* The last week, came into this Harbour the *Portsmouth Pink* of *London*, bound for *Jamaica* from *Amsterdam*; and the *Charles of New-York*, bound home likewise from *Amsterdam*, with some other small Vessels. On Tuesday last, the Wind being at N. E. pass'd to the Southward a Fleet of ships, and a small Vessel that came in company with them from the *Isle of Wight*, and put in here, inform'd us that they were about 150 Sail, most Dutch, some English, under the Convoy of 3 Dutch Men of War bound for the *Streights*. Yesterday morning pass'd by another Fleet, bound, as we suppose, for *Newfoundland*.

*Falmouth, June 30.* The 28th instant came in here the *Ralph and Ann Ketch*, employed by the *East India Company*; and having stop'd some leakes which oblig'd her to come in here, put to Sea again this day. This morning came in here a small Vessel laden with Wheat for this place; the Master says, that on Saturday and yesterday he heard much shooting to the Southward. The last week pass'd by this Harbour a Fleet of Dutch Merchant ships bound for *Springall*.

*Whitton, June 30.* Some of our Ships are

arrived from the *Baltick*; all the News they bring is, that the Commissioners of *Sueden* and *Denmark* had met in *Schonen* to treat a Peace between the two Crowns, which the general hope and expectation was would be speedily concluded.

*Lime, June 30.* Yesterday one *Nicholas Bradiske* of this Town came home from his Captivity in *Algiers*. He was Master of a Vessel of *Topsham* taken in the beginning of the War. He left *Algiers* in April last, and then most of their ships, viz. 22 Sail, mounted from 40 to 20 Guns apiece, were laid up, but were designed to be fitted out in August, the Soldiers being in the mean time made use of, to go up with the Camp into the Country, to fetch in their Tribute. This day several pieces of French Linnens, called Lockrams, were burnt by the Officers of the Custom-house, pursuant to an Act of Parliament, prohibiting the Importation of several French Commodities.

*Plimouth, July 1.* The 28th past, arrived here the *St. Peter* and the *St. Mary*, both of *Ostend*, and the *St. John* of *Calais*; the *Dove* of this place from *Neavis*, the *Primrose* of *London* bound home from *Lisbon*, the *Charles of Leith*, likewise from *Lisbon*; the 29th came in here the *Blackmore* of the *Isle of Wight* bound for *St. Martins*, the *Katherine* of *London*, for the *Streights*; and this day the *Unity* of *Bristol*, bound for *Cadiz*; and the *Golden Lamb* of *London*, and the *John and Elizabeth* of *Dever*, both from *Bordeaux*. On Saturday last pass'd by this place to the Westward Sir *Roger Strickland*, with another Frigate to cruise in the Soundings.
