Brussels, July 7. Yesterday arrived an Express from Paris, bringing Letters from the Marquis de los Balbaces to his Excellency, in which he gives an. account of the Marriage between the King of Spainand Madamoiselle d' Orleans being declared, and that he was going to fign the Articles of Marriage, which news has occasioned great rejoicing here. Our Letters from Nimeguen inform us that the Imperial and French Ambassadors were finally come to an Agreement about executing the Peace, the Emperor having co sented to draw his Troops out of the Empire and to quit the places, he has at present Garrisons in, upon which the French will do the like. From the Hague they tell us, that the prefling Instances of the French Ambassador in behalf of the Count of Benthem, are like to prevail with the States, to reffore that Count's Children, which they

had, At the defire of their Mother, and at their own, taken into their Protection. From Struckourgh we have an account, That those Magistrates were very much allarmed by the demand the Billion of that City had made to have the Cathedral there, and the Revenues belonging thereunto, restored to him, letting them know, that in case of refusal, he shall be obliged to use Force.

Hague July a The States of Holland have now before them the Memorial of the French Ambassa-der, concerning the come of Benthem's Children, which this State received into their Protection at the defire of the Countess. It is a thing that has been the Subject of much dispute for a veral years last past, and therefore people are the more curious to see what the States will resolve in it upon the Memorial of the French Ambassador. We cannot yot know what resolution the States are like to come to converning Maestrickt; the Spaniards seem torperfunda themselves that they will comply with the obligation of their Treaty, and deliver the place to the King of Spain, but others are of a contrary The Dancs, as our Northern Letters tell us, are much displeased with the late proceedings of the Elector of Brandenburg, who say he ought not to have concluded his Peace, but jointly with the King of Denmark, who is now left alon. in the War, but the Elector does not want Arguments to justifie what he has done.

Paris, Fuly 8. The new Queen of Spain has received the Compliments of the Foreign Ministers here, in the name of the feveral Princes their Mailers and of all the persons of quality of the Court & and preparations are already making as well for the marriage which will be performed here by Proxy, as for her journey to Spain. The Chevalier de Lorrain is appointed to wait upon her thither, and feveral Ladies are named who are likewite to attend her, but are to leave her lafter her arrival at Madrid, the King of Spain appointing all the Servants and Officers of her Family. The marriage of the Dauphin with the Princess of Bavaria and of the young Elector with . Madamoiselle de Blow, Sister to the new Queen of Spain, is talked of at Copr t.

Lime, June 30. Yesterday one Nicholas Braduke of this Town came home from his Captivity in Algiers. He was Malter of a Vessel of Topsham taken in the beginning of the War. He lest Algiers in April last, and then most of their thips, viz. 22 Sail, mounted from 40 to 20 Guns apiece, were laid up, but were designed to be fitted out in August, the Soldiers being in the mean time made use of, to go up with the Camp into the Country, to fetch in their Tribute. This day several Tieces of French Linnens, called Lockrams, were burnt by the Officers of the Custom-house, purfuant to an Act of Parliament, prohibiting the Importation of feveral French Commodities.
