Our Letters from Holland give us an account, That Monficur d' Avaux, Ambassador from this Crown, laboured har I to dispose the States to accept the Allyance by him proposed, that on one fide he had offered tiem great advantages, and on the other had told them, That in case they re-fused it they must expect to be Treated on all occasions as a People the King would have little Regard for Lu that neither those Promises nor these Menaces had had any effect upon the States, who feem d resolved to pursua their true Interests, and to close with His Majelly of Great Britiain, of whose kindness and resolution to stand by them they were well affured

Dover, Jan. 8. We have had here extream flormy Weather, accompanied with much Rain, the Wind generally at West, and the last night or this morning happened a great fall of the Cliff adjoyning to the North wall of the Cassle, and at the North fide of the faid Wall, called the Cassle-Reare. It is in breadth about 30 Rod, and in length little less, that at High-water mark it may be 25 Rods in the Sea, and the height is about 20 Foot, in all places much alike, it's judged this fall of the Cliff (the greatest in the Memory of any man living) will be a means to fecure and lodge the Beach or Shingle thrown up into the Bay, which is the only preservation of the Harbour.

Whitchall, Jan 9. This morning Mr. Gadbury was again examined before Hu Majesty in Council, upon an information by him given in upon Oath the day before to a Committee of the Lords. Wherein he gave their Lordships an account, That about September last Sir Robert Payton express to him his defires to come over to the Interests of His Majesty, and to be reconciled to His Ruyal Highness; That he Mr. Gadbury, acquainted Mrs. Celier (with whom be had had an acquaintance of several years) therewith; and that there was afterwards an intimate correspondence between Sir Robert Paycon and her this occasion Sir Robert had told him, That in doing this be should certainly part with a very great Inter-est, an Interest which had compassed his double Eletion of Member of Parliament, which could put him at the Head of 20000 men in two days time, and which could raise 60000 in a week or eight days. That this Interest, in case the King (whom God pre-ferve) had eyed at Windsor the last Summer, was ready to have seized the Tower, Dover Calle, Portsmouth, &c. That they resolved to secure the Lord Mayor of London, and such of the Lords of the Priva Council as should offer to Proclaim his Royal Highnels, or fet up any single Person against their Resolutions, and to put them to death, being resolved to advance a Commonwealth-Government; and that this Interest could rout out all the Royalists and Episcopists out of the Nation.

Then Mrs. Cellier beirg called in and Examined, She declared upon Oath, That Sir Robert Payton had told her, that if he should turn to the Kings interests he should stand alone; That if the King bad dyed an Windsor, they would have knocked the Lord Major. on the head, seized on such others as they thought fit, and would not have suffered the Duke of York to be Proclaimed King, and that they had Posted themselves so as to do it; That they allowed Rentions to several old Officers of the Rump, as to Alsop and others; and that Moneys had been Co letted. All which Sir Robett Payton absolutely denyed. But the matter being charged against him upon Oath, he was, by Warrant of the board, committed Prisoner to the Tower, For High Treason in conspir ng to Levy War against the King.

Hh Majesty was pleased this day in Council to declare, That Ise thought fit, that the Garisons now in the Castie of Chepitow, Ghester Castle, Dartmouth, Holy Illand, St. Maws, and Scarborough, fnould be forthwith Disbanded. And Hu Majesty was likewise pleased to order Mr. Atturney General to Prosecute the
