

Marseilles, March 12. The Person who went from hence some time since for *Tripoly*, to Treat with that Government, concerning a Peace, is come back; the Propositions he made, having been rejected, which has occasioned the departure of the Chevalier *de Falbelie*, who is gone with three men of War under his Command, to look after those Pyrats, who have at present 10 Ships of good force at Sea. The 8 French Gallies that had been at *Civita Vecchia*, *Genoua*, &c. at their arrival some days since at *Thoulon*, found Orders to return immediately back to *Genoua*, whither they have accordingly retaken their course. Some men of War are now fitting out at *Thoulon*, which its said, are designed with 12 Gallies against *Tripoly*, and they will be ready to sail about the beginning of *May*. This day arrived here a Bark of this place from *Argiers*, by which we have an account, that notwithstanding the Peace lately made between the States-General of the *United Provinces* and those Corsairs, the latter continue their Pyracies upon the Dutch, on pretence that the States have not sent them the Guns promised by the said Treaty, though they had by an express, received an assurance, that the said Guns were on their way. The said Algerines have taken some English Vessels, laden with *Newfoundland-Fish*, &c.

Paris, March 30. People are now expecting to see what Consequences the Treaty concerning *Cassal* will have, and whether the Princes of *Italy* will quietly suffer that important Place to fall into our Kings hands. Our Troops, as we told you in our last; march that way, and a Squadron of Men of War are fitting out at *Thoulon*: And while these preparations are making on this side, we do not hear that the Princes of *Italy* stir. The Ships that are fitting out at *Rochefort*, are, it is believed, designed for the *West-Indies*, under the Command of the Count *d'Esrees*. Monsieur *Henry* the Danish Ambassador arrived here some dayes since, and has had a private Audience of the King. It is said, that the Dutchess Dowager of *Hanover*, who is here, is with Child, and that she has sent to acquaint the Bishop of *Osnaburg* therewith, and to desire him not to take possession of the Territories of her late Husband, till she be brought to Bed, that so, if it be a Son, his Right of Succession may not be prejudiced.

Risale, March 9. The *Fames* Galley, the *Swan*, and the *Grey* and *Frigats* are now in this Port, with several Merchant Ships bound for the *West-Indies* and *Virginia*. Four Companies of the Lord *Dumbartons* Regiment are come to Town, which are to be Shipped in the *Fames*, and the *Swan* for *Tanger*, and we expect here four Companies more designed for the same Service.

Dublin, March 17. The last week the Scotch Soldiers that killed *Mr. Brown* the High Constable, of which so much noise has been made in the prints at *London*, being brought to their Tryal, the Sentinel was acquitted, and the two Serjeants found guilty of Manlaughter.

Our Lord-Lieutenant who has been very much indisposed of the Gout, is now so well recovered as to goe abroad.

Deal, March 21. This Afternoon the Wind coming N. E. *Sr. Ferris-Berry* in the *Leopard*, and the Merchant Ships under his Convoys, bound for the *Streights*, sailed out of the *Down*.

Portsmouth, March 21. The 18th Instant the *Dartmouth* Frigate sailed out of this Harbour, and came to an Anchor at *Spinhead*, and this morning sailed with the *Phenix* and the *Norwich* to the Westward.

Newmarket, March 23. On Sunday last the Vice-Chancellor, accompanied with the Heads of the Colledges, and others of the University of *Cambridge*, in all to the number of about 200, Persons, came hither in their Formalities, to pay their Duty to His Majesty, which having done, they likewise waited upon the Duke, and Complimented him upon his safe Return from *Scotland*; after which they were, by the Kings Command, entertained at Dinner. It is said, the Court will continue here till the Third of the next Month.

Whitehall, March 24. On Monday in the Afternoon His Royal Highness came from *Newmarket*, yesterday morning the Lord Mayor and the Sheriffs waited upon him at *St. James's*, and this morning the Duke returned to *Newmarket*, to attend His Majesty during his stay there.

Yesterday in the Afternoon the Dutchess of *Modena* arrived at *St. James's*.

Whitehall, March 24. Information having been given to some of His Majesties Justices of the Peace, That several Apprentices had had divers Meetings, and that they had formed a Design among themselves to come together in a considerable number on the Kings Birth-Day, as they pretended, to Burn the *Rump*; They issued their Warrants for the Apprehending some of the Principal of them, and Committed them to the Gatehouse; and having acquainted the Lords of the Privy-Council therewith, their Lordships met on Monday in the Afternoon, before whom the said Apprentices being Examined, they Confessed they had been put upon a Design of Burning the *Rump* on His Majesties Birth-Day.

And this Afternoon one *Thomas Alford*, who was to have been their Captain, was likewise examined before their Lordships, and by Order of the Board Committed to *Newgate* for High-Treason, in Conspiring to Leavy War against the King.
