P R E S E N T,

The KING's Most Excellent Majesty in Council.

WHEREAS His Majesty was graciously pleased, by His Royal Proclamation bearing Date the Twenty-sixth Day of December, 1792, to promise and declare, that the Bounties of Five Pounds for every Able Seaman, and Two Pounds Ten Shillings for every Ordinary Seaman, fit for His Majesty's Service, should be paid in the Manner thereby directed to every such Able and Ordinary Seaman, not above the Age of Fifty nor under the Age of Twenty Years, who should, on or before the Twenty-eighth Day of February then following, enter themselves to serve in His Majesty's Royal Navy, either with the Captains or Lieutenants of His Majesty's Ships or Vessels, or Officers employed on Shore for raising Men for the Service of the Royal Navy: And whereas His Majesty was also graciously pleased, by his said Proclamation, to declare, that all Able-bodied Landmen, not above the Age of Thirty-five nor under the Age of Twenty Years, who should so enter themselves as aforefaid, should receive the Sum of Thirty Shillings each Man, as His Majesty's Royal Bounty: And whereas His Majesty was also graciously pleased, by His Royal Proclamation bearing Date the Sixteenth Day of the said Month of February, 1793, to promise and declare, that a Reward of Twenty Shillings for every Able and Ordinary Seaman, fit to serve on board His Majesty's Ships, should be paid to any Person who should discover any Seaman or Seamen who might conceal him or themselves, so that such Seaman or Seamen should be taken for His Majesty's Service, on or before the Thirtieth Day of April then next, by any of His Majesty's Sea Officers appointed to raise Men on Shore, or

by the Captains or Commanders of any of His Majesty's Ships or Vessels in the Ports or on the Coasts of this Kingdom: And whereas the Time limited by the said Proclamations for Payment of the said Bounties and Reward, hath been prolonged and extended to the Thirtieth Day of this instant April; and it being judged expedient for His Majesty's Service that the said Bounties and Reward should be continued to be paid for some Time longer; His Majesty, with the Advice of His Privy Council, doth therefore order, and it is hereby accordingly ordered, that the Time limited for Payment of the said Bounties and Reward be prolonged and extended, from the said Thirtieth Day of this instant April to the Thirtieth Day of June next inclusive:—Whereof all Persons concerned are to take Notice, and govern themselves accordingly.

WHEREAS the Time limited by His Majesty's Order in Council of the 4th Day of November last, prohibiting the Exportation out of this Kingdom of any Sort of Rock Salt, will expire upon the 29th Day of this instant April: And whereas it is judged expedient that the said Prohibition should be continued for some Time longer; His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit and command, that no Person or Persons whatsoever do at any Time, during the Space of Six Months, to commence from the said 29th Day of this instant April, export or attempt to export, transport, carry or convey, or load or lay on board of any Ship, Vessel or Boat, in order to be exported, transported, carried

or

or conveyed out of any Port or Place in Great Britain, any Sort of Rock Salt whatsoever, without Leave or Permission being first had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act passed in the Thirty-sixth Year of His present Majesty's Reign, intituled, "An Act for indemnifying all Persons who have been concerned in advising, or carrying into Execution an Order of His Majesty in Council respecting the Exportation of Rock Salt; for preventing Suits in consequence of the same; for authorizing His Majesty to prohibit the Exportation or carrying Coastwise of Rock Salt; and for making further Provisions relative thereto;" His Majesty, nevertheless, by the Advice aforesaid, hath thought fit to order, that nothing herein contained shall prevent Rock Salt being carried Coastwise, under the usual Rules, Regulations and Restrictions, nor the Exportation of the same to Ireland, or to any other of His Majesty's Dominions, under the usual Conditions and Regulations, and upon Security being given, by the Exporter and Two other Persons, (of whom the Master of the Vessel shall be one) by Bond, in such Penalty as shall be directed by the Commissioners of His Majesty's Customs, that the said Rock Salt shall be exported to some Port or Place in His Majesty's Dominions, and none other; and that a Certificate shall be produced within Six Months from the Date of the Bond, if such Rock Salt shall be entered out for any Part of His Majesty's Dominions in Europe, and within Twelve Months if for any Part of His Majesty's Dominions in America or the West Indies, and within Eighteen Months if for any of the British Settlements or Factories in Asia or Africa, under the Hand of the Principal Officer of the Customs at the Port or Place where such Rock Salt shall be so landed; and if there shall be no Officer of the Customs, then under the Hand of the Chief Magistrate of the Place, testifying that the said Rock Salt has been duly landed at the Port or Place for which the same was entered out. And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Lords Commissioners of the Admiralty, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein as to them may respectively appertain.

Copy of a Letter from the Right Hon. Admiral Lord Bridport, K. B. to Ewan Nepean, Esq; dated on Board His Majesty's Ship Royal George, at Sea, the 22d Instant.

S I R,

I Have the Satisfaction to acquaint you, for their Lordships Information, that L'Hercule, of 74 Guns, was taken by His Majesty's Ship Mars last Night.

The inclosed Copy of a Letter from Lieutenant Butterfield will best shew to their Lordships the Spirit and Judgment manifested upon this Occasion. No Praise of mine can add one Ray of Brilliancy to the distinguished Valor of Captain Alexander Hood, who carried his Ship nobly into Battle, and who died of the Wounds he received in supporting the just Cause of his Country. It is impossible for me not to sincerely lament his Loss, as he was an Honor to the Service, and universally beloved; he has fallen gloriously, as well as all those who are so handsomely spoken of by Lieutenant Butterfield. I have appointed him to the Command of L'Hercule, to carry her into Port, and I have given a temporary Appointment to Captain James George Shirley to command the Mars, and Lieutenant George White, First of the Royal George, to command the Megara. Lieutenant Henry Combe, the Second, will deliver to you this Dispatch.

Mars, at Sea, April 22, 1798.

My Lord,

I Beg Leave to acquaint your Lordship, that the Ship chased by His Majesty's Ship Mars Yesterday, per Signal, endeavoured to escape through the Passage du Raz, but the Tide proving contrary, and the Wind Easterly, obliged her to anchor at the Mouth of that Passage, which afforded Captain Hood the Opportunity of attacking her, by laying her so close alongside as to unhinge some of the Lower Deck Ports, continuing a very bloody Action for an Hour and a Half, when she surrendered.

I lament being under the Necessity of informing your Lordship, that His Majesty has, on this Occasion, lost that truly brave Man, Captain Hood, who was wounded in the Thigh late in the Conflict, and expired just as the Enemy's Ship had struck her Colours. This Ship proves to be L'Hercule, of 74 Guns and 700 Men, her first Time at Sea, from L'Orient, to join the Brest Fleet.

I cannot sufficiently commend the Bravery and good Conduct of the surviving Officers and Men, who merit my warmest Thanks: I must particularly recommend to your Lordship's Notice Mr. Southey, the Signal Midshipman.

Lieutenants Argles and Ford are the only Officers wounded. Captain Hood and Captain White, of the Marines, are killed. Lieutenant Argles, though badly wounded, never quitted the Deck.

From a Number of the People being with Lieutenant Bowker, in Charge of the Prize, I cannot at present

present inform your Lordship the exact Number of Killed and Wounded, but from the best Information Circumstances afford, I think about 30 killed and as many wounded, most of them dangerously.

SEVERAL Persons, whose Names are thereunto subscribed, on Behalf of themselves and others, Burgeſſes of the Borough of Malmſbury in the County of Wilts, having this Day preſented their Petition to the Houſe of Commons, ſetting forth, that on the Tenth Day of May, One thouſand ſeven hundred and ninety-ſeven, the Select Committee, appointed to try the Merits of the Petition preſented by James John Vaſſar, Eſq; complaining of an undue Election and Return for the ſaid Borough, reported to the Houſe, That it appeared to the ſaid Select Committee, that the Merits of the Petition did wholly depend upon the Right of Election; and that thereupon the ſaid Committee required the Counſel for the ſeveral Parties to deliver to the Clerk to the ſaid Committee Statements in Writing of the Right of Election for which they reſpectively contended: That in conſequence thereof, the Counſel for the Petitioner delivered in a Statement as follows: "That the Right of Election for "Members to ſerve in Parliament for the Borough "of Malmſbury in the County of Wilts is in the "Alderman, Capital Burgeſſes, Aſſiſtants, Land- "holders, and Commoners of the ſaid Borough." That the Counſel for the Sitting Member, Philip Metcalf, Eſq; delivered in a Statement as follows: "That the Right of Election of Burgeſſes to ſerve "in Parliament for the Borough of Malmſbury "in the County of Wilts is in the Alderman and "Twelve Capital Burgeſſes only." That upon the Statement delivered in by the Counſel for the Petitioner, the ſaid Select Committee had determined, That the Right of Election, as ſet forth in the ſaid Statement, is not the Right of Election for the ſaid Borough of Malmſbury: That upon the Statement delivered in by the Counſel for the Sitting Member the ſaid Select Committee had determined, That the Right of Election, as ſet forth in the ſaid Statement, is the Right of Election for the ſaid Borough of Malmſbury. That the Petitioners believe, and are adviſed, that the Right of Election, ſo determined by the ſaid Select Committee, is not the Right of Election for the ſaid Borough; and therefore, to prevent the Judgment of the ſaid Select Committee from becoming final and concluſive, the Petitioners pray, that they may be admitted as Parties, according to the Form of the Statute in that Caſe made and provided, to oppoſe the Right of Election, in Favour of which the ſaid Select Committee have ſo reported, and that they may have ſuch other Relief in the Premises as to the Houſe ſhall ſeem meet, and the Nature of their Caſe may require. I do hereby give Notice, that the Houſe has appointed Monday the Eleventh Day of June next, at Three of the Clock in the Afternoon, to take the ſaid Pe-
