And We do ftrictly charge and command all Juftices of the Peace, Mayors, Sheriffs, Bailiffs, Constables, and all other His Majesty's loving Subjects, to use their utmost Diligence in apprehending the faid Lord Edward Fitz-Gerald.

## GOD fave the KING.

A T the Court at St. James's, the 2d of May, 1798,

R E S E N The KING's Most Excellent Majesty in Council. WHEREAS the Time limited by His Majefty's Order in Council of the 4th Day of November last, prohibiting the transporting into any

By the LORD LIEUTENANT and COUNCIL | Parts out of this Kingdom any Pot Afh or Pearl-Ash; (except as in the faid Order is mentioned) wilt expire upon the 7th Day of this inftant May : And whereas it is judged expedient that the faid Prohibition fhould be continued for fome Time longer; His Majesty doth therefore, with the Advice. of His Privy Council, hereby order, require, prohibit and command, that no Perfon or Perfons whofoever. do, at any Time, during the Space of Six Months, to commence from the faid 7th Day of this inflant May, export, or attempt to export, transport, carry or convey, or lade or lay on Board of any Ship, Veffel or Boat, in order to be exported, tranfported, carried or conveyed out of this Kingdom, any Pot-Ash or Pearl Ash, without Leave or Permiffion being first had and obtained from His Ma-jetty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act passed in the Thirty-fourth Year of His Majetty's Reign, intituled; An Act for indemnifying all Perfons who have " been concerned in advising or carrying into Execution an Order of the Lords Commissioners of His Majefty's Treafury refpecting the Exportation of Pot Afhes or Pearl-Afhes ; for preventing Suits in confequence of the fame; for authorizing His " Majefty to prohibit the Exportation or carrying " Coaftwife of Pot-Afhes or Pearl-Afhes, and for " making further Provisions relative thereto." But it is neverthelefs His Majefty's Pleafure, that nothing herein contained shall extend, or be construed to extend, to prevent the Exportation of the faid Articles to Ireland, or to His Majesty's Islands of Guernfey, Jerfey, Alderney, Sark or Man, or to His Majefty's Colonies or Plantations in America or the Welt Indies, or to Newfoundland, or to His Majefty's Forts and Settlements on the Coaft of Africa; or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies; provided that, upon the Exportation of the faid Articles to Ireland, or or His Majesty's Islands of Guernsey, Jersey, Alderney, Sark or Man, or to His Majesty's Colonies and Plantations in America or the West Indies, or to the Island of Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or the British Settlements or Factories in the East Indies, the Exporters of the faid Articles do first make Oath of the true Destination of the fame to the Places for which they shall be entered Outwards, before the Entry of the fame
