THEREAS the Time limited by His Majefty's Order in Council of the 6th Day of December last, for prohibiting the Exportation out of this Kingdom, or earrying Coastwife, Gunpowder or Saleperre, or any Sort of Arms or Ammunition, will expire upon the 7th Day of June next: And whereas it is judged expedient for His Ma-jefty's Service, and the Safety of this Kingdom, that the faid Prohibition flouid be continued for fome Time longer: His Majefty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit and command, that no Perfon or Persons whatscever, (except the Master General of the Ordnance for His Majelty's Service) do, at any Time during the Space of Six Months, to commence from the 7th Day of June next, prelume to transport into any Parts out of this Kingdom, or carry Coathwife, any Gunpowder or Saltpeire, or any Sort of Arms or Ammunition, or thip or lade any Gunpowder or Saltpetre, or any Sort of Arms or Ammunition, on Board any Ship or Veffel, in order to transporting the fame into any Parts beyond the Seas, or carrying the fame Coaff-wife, without Leave or Permiffion in that Behalf first obtained from His Majefty, or His Privy Countil, upon Pain of incurring and fuffering the re-fpective Forfeitures and Penalties, inflicted by an Act passed in the Twenty ninth Year of His late Majetty's Reign, intituled, "An Act to impower His Ma-" jefty to prohibit the Exportation of Saltpetre, and to enforce the Law for impowering His Ma-jefty to prohibit the Exportation of Gunpowder, " or any Sort of Arms or Ammunition ; and alfo " to impower His Majefty to reftrain the cárrying "Coaltwile of Salepetre, Gunpowder, or any Sort "of Arnis or Amaunition."—And the Right Honourable the Lords Commissioners of His Ma-jesty's Treasury, the Commissioners for execution the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master General of the Ordnance, and His Majefty's Secretary at War, are to give the necessary Directions herein, as to them may respectively appertain. SIR,

I Have the Honor to inclose a Letter from Sir Francis Lafor y, Captain of His Majesty's Ship Hydra, detailing the Particulars of a very gallant Action in the Ship he commands, with the French Frigate La Confiante, and Vefuve, a Corvette, both of which were forced on Shore, together with a Cutter that accompanied them. I mult add, that the whole of this Affair reflects the higheft Honor upon Sir Francis Laforey, the Officers, and Ship's Company of the Hydra.

SIR, Hydra, off Hawre, June 1, 1798.

I Beg Leave to acquaint you, that on the Morning of the 30th Ult. His Majefly's Ship under my Command being off Havre, with the Vefuvius Bomb and Trial Cutter, carrying into Execution the Orders I had the Honor to receive from you on the 28th, at Break of Day Three Sail were difcovered to Windward, which, upon the Hydra drawing up within Gun-Shot, hoined French Colours, and proved to be a Frigate, a Corvette, and a Cutter.

The Corvette being the Leewardmost, commenced the Action as the two Ships passed on different Tacks. Upon the Hydra being put about, she pitched up in a Position nearly equal Distance between the two, when the Frigate opened the Fire. In about a Quarter of an Hour the Cutter bore away, and run athore under a Preis of Sail near a fmall Battery off the Entrance of Dieu River; floating with the rifing Tide, the attempted to proceed further down to-

Commiffions in the Effex Militia, figned by the Lord | fuvius and Trial, was compelled again to run or Shore.

The Frigate endeavoured to regain the Port of Havre, but, after engaging His Majeity's Ship Three Quarters of an Hour, fhe likewife ran on Shore, at the Time of high Water, a little to the Eaftward of Dieu, where the futtained the Fire of His Majefty's Ship, with little Return on her Part, till the falling of the Tide rendered it necessary for our own Safety that we fhould haul off Shore. A Number of Troops having formed on the Beach and adjoining Heights, I could not attempt to board her that Evening with any Profpect of Success; but on the Morning of the 31th, perceiving that a great Part of her Crew had left her, I fent the Boats of His Majaty's Ship, under Cover of the Trial Cutter, whilft the Tide, was fufficiently high to enable the Hydra to approach within Gun-Shot for Protection, to haul down her Colours and burn her; waich I have the Pleafure to flate was compleatly atchieved without any Lofs on our Part, fuch as remained on board having abandoned her upon the Approach of the Trial and the Boars, and which was the more fatisfactory, as it was effected in the Face of a Party of Cavalry drawn up on the Beach, and amidft a fmall, though ineffectual, Fire of Musketry from the Military on the commanding Heights. The Corvette having grounded very high upon the Beach, and beingwithin the Range of a Battery of Two Twenty four Pounders, nothing could be attempted towards defroying her; during the Night fle was hauled into the River of Dicu; the Cutter ran on Shore on the Action commencing: Thefe Snips had failed from Havre on the Night of the 29th; the Frigate was named La Confiante, mounted 36 Guns, Twelve-Pounders, was full of Stream and had Orders on her build a was full of Stores, and had Ordnance in her Hold ; the was commanded by Monf. Leorier, and by a Note D'Equippage found on board, appears to have been manned with 300 Men; the Number of flain left on board, and the State of the Decks, leads me to suppose her Loss in killed and wounded was fe-vere. The Corvette was named Le Vesuve, mounted vere. 20 Nine-Pounders, and was commanded by a Monfieur L'Eutier. I am truly happy at having it in my Power to inform you, that the Hydra efcaped without Loss; her Rigging was much cut, and her Mainmalt wonnded, but not badly. It is with pe-culiar Satisfaction I report the fleady Conduct of the Officers and Crew of His Majefty's Ship I have the Honor to command; from Lieutenant Jones and Mr. Pickering, the Master, I experienced Co operation; the Judgment and active Gallantry exhibited by Lieutenants Acklom and Simonds, and Lieutenant Blanch, of the Marines, who commanded the boarding Party, reflects the higheft Credit upon them; and I beg Leave to expreis my perfect Approbation of the Exertions difplayed by Captain Fitzgerald, of the Vesuvius, and Lieutenant Garrett, of the Trial, to fupport the Hydra.

#### TRANSLATION of a Letter from Baron Thugut to Lieutenant-Colonel Aylett.

SIR, Vienna, March 5, 1798. THE Emperor remembers, with Satisfaction, the diffinguifhed Proofs of Valour that you, Sir, and Seven other Officers of the 15th Light Dragoons manifested on the 24th of April, 1794, near Cam-bray. His Majesty regrets that the Statutes of the Order of Maria Therefe, confirmed by constant Custom, do not allow the Cross of this Order, strictly National, to be conferred on Officers fo worthy of being decorated with it; but wishing at the fame Time to give you and your honorable Companions in Arms, a publick Mark of his particular Esteem, His Majesty has ordered a Medal to be struck to perpetuate the Remembrance of this brilliant Action, and has commanded me to offer them, in His Name, the only Impressions which have been Aruck, except that which is placed in the Imperial Cabinet of Vienna. In fulfilling the Intention of His Imperial Majefly, I beg you to accept for your-felf, Sir, and to diffribute to the other Officers who, in the important Affair of the 24th of April, 1794, fought under your Command, these Medals, which for that Purpose I have delivered to Captain Ryan. ATTESTATION of Major-General Count Merfeld.

#### Vienna, Dec. 20, 1797.

THE 15th Light Dragoons charged the Enemy, on the 24th of April, 1794, who were in great Force at Villers en Couché, routed, and fabred a great many; and by this Conduct refcued His Imperial Majefty from the Danger that menaced his Perfon, who being on the Road from Valenciennes to Catillon, was cut off by the Patroles of the Enemy, as His Majefty on that Day was returning from Bruffels to the Army, and the Enemy's Patroles had already paffed the River Selle.

The courageous Conduct of this Regiment, animated by it's brave Officers, is fo much the more meritorious, as the main Column of the Allied Army did not arrive to it's Support; but this gallant Regiment, abandoned to itfelf, relied on it's own Valour, attacked the Enemy, fo "much ftronger, and whofe Bravery alone prevented the melancholy Confequences above ftated; and, not content with that, they took from the Enemy, who were fo much more numerous, Three Pieces of Cannon.

Y Efferday a Difpatch was received from Major-General Loftus, conveying Information from Lieutenant Elliott, of the Antrim Militia, that the Troops in Gorey, confifting of Thirty of the Antrim Militia, a fubaltern Detachment of the North Cork, the Gorey Yeomen Cavalry, Ballykeer, and Part of the Camolin Cavalry, attacked the Rebels at Ballycanoe about Three o'Clock on the 1ft Inftant, defeated them, and killed above One Hundred of them.

The Patience, the Spirit and continued Exertions of the Yeomanry are unequalled, and I cannot fufficiently applaud the indefatigable Zeal of Major-General Myers, who has undertaken the Arrangement of them with a Promptitude and Ability, which has been of the most effential Advantage.

It appears that Colonel Walpole had met wirh the main Body of the Rebels in a firong Poft near Slievebuy Mountain, and having attacked them, he was unfortunately killed by a Shot in the Head in the Beginning of the Action, when his Corps, being in a Situation where it could not act with Advantage, was forced to retire to Arklow. The Lofs was Fifty-four Men killed and miffing, and Two Six-Pounders. Captain Stark, Captain Armftrong, Captain Duncan were wounded, but not dangeroufly, and Sir Watkins William Wynne received a Contufion in the Hand.
