The KING's Most Excellent Majesty in Council. VHEREAS the Time limited by His Majelty's Order in Council of the 6th Day of December taft, for prohibiting the Exportation out of this Kingdom, or oarrying Coattwife, Gunpowder or Saltpetre, or any Sort of Arms or Ammunition, will expire upon the 7th Day of June next: And whereas it is judged expedient for His Ma-jefty's Service, and the Safety of this Kingdom, that the faid Prohibition should be continued for fome Time longer: His Majefty doth therefore, with the Advice of His Privy Council, hereby with the Advice of His Privy Council, hereby order, require, prohibit and command, that no Per-fon or Perfons whatfoever, (except the Mafter General of the Ordnance for His Majelty's Service) do, at any Time during the Space of Six Months, to commence from the 7th Day of June next, prefume to transport into any Parts out of this Kingdom, or carry Coaftwife, any Gunpowder or Saltpetre, or any Sort of Arms or Ammunition, or fhip or lade any Gunpowder or Saltpetre, or any Sort of Arms or Ammunition, on Board any Ship or Sort of Arms or Ammunition, on Board any Ship or Vessel, in order to transporting the same into any Parts beyond the Seas, or carrying the fame Coaff-wife, without Leave or Permission in that Behalf first obtained from His Majesty, or His Privy Counritt ootained from Fris Majerty, of Fris Frivy Coun-cil, upon Pain of incurring and fuffering the re-spective Forfeitures and Penalties, inflicted by an Act paffed in the Twenty ninth Year of His late Majefty's Reign, intituled, "An Act to impower His Ma-" jefty to prohibit the Exportation of Saltpetre, and " to enforce the Law for impowering His Ma-" jefty to prohibit the Exportation of Gunpowder, * or any Sort of Arms or Ammunition ; and alfo " to impower His Majefty to reftrain the carrying "Coaftwife of Saltpetre, Gunpowder, or any Sort " of Arms or Ammunition." — And the Right Honourable the Lords Commissioners of His Majefty's Treasury, the Commillioners for executing the Office of Lord High Admiral of Great Britain; the Lord Warden of the Cinque Ports, the Master General of the Ordeance, and His Majesty's Secretary at War, are to give the necessary Directions herein, as to them may respectively appertain.

PRESENT.

The KING's Moft Excellent Majefty in Councilr HEREAS the Time limited by His Majefty's Order in Council of the 6th Day of December laft, prohibiting the Transportation into any Parts out of this Kingdom any of the Wood called Lignum-Vitæ, will expire upon the toth Day of June next: And whereas it is judged expedient for His Majefty's Service that the faid Prohibition fhould be continued for fome Time longer; His Majefty doth therefore, with the Advise of His Peine Comp doth therefore, with the Advice of His Privy Coun-cil, hereby order, require, prohibit and command, that no Perfon or Perfons whofoever do, at any Time, for the Space of Six Months, to commence from the faid roth Day of June next, export, or attempt to export, transport, carry or convey, or lade or lay on Board of any Ship, Vessel or Boat; in order to be exported, transported, carried or conveyed out of this Kingdom, any of the Wood called Lignum-Vitæ, without Leave or Permifion being firit had and obtained from His Majelly or His Privy Council, upon Pain of incurring the Forfeitures in-flicted by an Act passed in the Thirty-fourth Year of His Majelty's Reign, intituled, " An A& for in-" demnifying all Perfons who have been concerned " in adviling or carrying into Execution an Order " of the Lords Commissioners of His Majesty's " Treasury respecting the Exportation of Pot-Ashes " or Pearl-Afhes; for preventing Suits in confequence of the fame; for authorizing His Majetty " to prohibit the Exportation or carrying Coaffwile " of Pot-Athes or Pearl-Athes, and for making " further Provisions relative thereto." But it is neverthelefs His Majefty's Pleafure, that nothing herein contained shall extend, or be construed to extend, to prevent any Ship or Vessel from taking or having on Board any of the faid Wood called Lignum-Vitæ, which may be necessary for the Use of the faid Ship or Vessel during the Course of her intended Voyage, not to preven the Eventration of intended Voyage, nor to prevent the Exportation of the faid Wood called Lignum Vitæ to Ireland, or to His Majefty's Iflands of Guernfey, Jerley, Alderney, Sark or Man, or to His Majetty's Colonies or Plan-tations in America or the Welt Indies, or to Newfoundland, or to His Majefty's Forts and Settlements on the Coaft of Africa, or to the Island of St. He-, lena.

lena, or to the British Settlements or Factories in the East Indies; provided that, upon the Exportation of leaving Belfast; and many others, being Officers of the faid Wood called Lignum-Vitæ to Ireland, or to His Majesty's Islands of Guernsey, Jersey, Alderney, Sark or Man, or to His Majesty's Colonies and Plantations in America or the West Indies, or to the Island of Newfoundland, or to His Majefly's Forts and Settlements on the Coaft of Africa, or to the Island of St. Helena, or the British Seulements or Factories in the East Indies, the Exporters of the faid Wood called Lignum-Vitæ do first make Oath of the true Deflination of the fame to the Places for which it shall be entered Outwards, before the Entry of the fame shall be made, and do give full and fufficient Security, by Bond, to the Satisfaction of the Commissioners of His Majefty's Cultoms, to carry the faid Wood called Lignum-Vitæ to the Places for which it is fo entered Outwards, and none other; and fuch Bond shall not be cancelled or delivered up until Proof be made, to the Satifaction of the faid Commiffioners, by the Produc-tion, within a Time to be fixed by the faid Commillioners, and specified in the Bond, of a Certificate or Certificates, in such Form and Manner as shall be directed by the faid Commissioners, shewing that the faid Wood called Lignum-Vitæ has been duly landed at the Places for which it was entered Outwards .- And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Com-missioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein, as to them may respectively appertain.

Dublin Castle, June 9, 1798. My Lord,

IT is with the utmost Concern I acquaint your Grace an Infurrection has broken out in the County of Antrim; and in order to give your Grace the fulleft Information in my Power, I inclofe to you an Extract of a Letter received this Morning by Lord Caftlereagh from Major-General Nugent. I am in great Hope, from the Numbers and Spirit of the Loyal in that Part of the Country, the Infurgents may be quickly checked.

My Lord, Belfast, June 8, 1798.

I HAVE the Honor to report to your Lordship, that in confequence of Information, which I received early Yesterday Morning, of an intended Infurrection in the County of Antrim, having for its first Object the Seizure of the Magistrates, who were to affemble that Day in the Town of Antrim, I ap-prehended feveral Perfons in Belfast. I did not receive the Intelligence early enough to prevent the Infurgents from taking Poffeffion of Antrim, and I

| ings there, but I prevented many Magistrates from Yeomanry, on permanent Duty, did not attend the Meeting. 1 ordered the 6 th Regiment, and Light Battalion, and 100 of the 22d Light Dragoons, un-der Colonel Clavering, and Lieutenant-Colonel Lumley, with Two $5\frac{1}{2}$ Inch Howitzers, and Two Curricle Six Pounders, to proceed with the utmost Difpatch through Lifburn to Antrim. I alfo ordered from the Garrifon 250 of the Monaghan Militia, with Lieutenant-Colonel Ker, and 50 of the 22d Dragoons, together with the Belfaft Yeomanry Cavalry, with Major Smith, to proceed under the Cominand of Colonel Durham, with Two curricle Six Pounders, through Carmoney, and Templepatrick to Antrim, to co-operate with the other Detachment. The Dragoons under Lieutenant-Colonel Luinley having made the Attack upon the Town, without waiting for the Light Battalion, were fired upon from the Windows of the Houfes, and were confequently obliged to retreat, with the Lofs of, I am forry to add, Three Officers of that excellent Regiment, killed and wounded, and the Two Curricle Six Pounders. Colonel Clavering, on his Arrival near Antrim, finding the Rebels pouring into that Town in great Force, very judicioufly took Poft on a Hill on the Lifburn Side, and reported his Situation to M. General Goldie. In the mean Time Colonel Durham, with his whole Detachment proceeded to within Half a Mile of Antrim, and after a cannonade of Half an Hour, drove the Infurgents completely out of the Town, and retook the Two Curricle Guns, together with 1 Brafs Six Pounder, very badly mounted, of which it fe ms the Rebels had Two, fuppofed to have been fmug-gled out of Belfaft. The Colonel then proceeded without the Lofs of a Man, though the Town (which for obvious Perform) (which, for obvious Reasons, suffered much) to Shane's Caftle and Randelftown, in which Direction the principal Part of the Rebels fled. He remains there still for Orders from me. Lord O'Neil, I am forry to fay, is dangeroufly wounded. Lieutenant-Colonel Leslie, of the Tay Fencibles, reports to me, from Carrickfergus, that Lieutenant Small, with a Detachment of Twenty Men of that Corps, in the Barrack at Larne, defended themfelves most gallantly against the Attack of a numerous Body, and maintained their Poft with the Lofs of Two killed and Three wounded, including the Lieutenant. I have ordered them into Head Quarters at Carrickfergus. The Glenarm Yeomanry (Sixty strong) being also threatened by an Attack, in the Course of the Day took Possession of Glenarm Castle, where they will maintin themselves, if poffible. Brigadier-General Knox, having heard of a Party of the Toome Yeomanry being made Prifoners by the Infurgents, fent to me very early this Morning to offer to march, by Toome Bridge, into the County of Antrim; which I have defired him to do, in order to liberate Colonel Durham's Detachment, and enable them to crofs the Country on their Return to Belfast.

Although the Infurrection has been pretty general in the County, I do not find they had much Success; but I have not received as yet any Reports from Ballycaftle, Ballymena, Ballymoney, Portglenore, and other Places in the Northern Parts, in which Vormany and Astronomy Information led to Yeomanry are stationed. As my Information led to am not therefore acquainted with their first Proceed. | a general Rifing in the County of Down, I have

been

been obliged to call in all the fmall Detachments of feveral Officers to whom I am highly indebted for the York Fencibles to Newtown Ardes. Colonel Stapleton has every Thing in Readiness to move at a Moment's Warning. The Yeomanry are all on permanent Duty throughout the Counties of Down and Antrim; and I have distributed Arms to 140 loyal Men in Belfast, who will be attached to the Monaghan and Fifeshire Regiments, and thereby become very uleful. Offers of Service are very numerous.

I cannot clofe this Letter without expreffing to your Lordship my entire Approbation of the Conduct of the Troops of all Descriptions in this Part of the Northern District. Their Zeal and Attention to their Duties cannot be surpassed, and I trust that, when Occafion offers, they will act in that Concert which is fo much to be wifhed for in Military Service. Lieutenant-Colonel Lumley, I am afraid, is badly wounded in the Leg; Cornet Dunu is killed; and Lieutenant Murphy flightly wounded; all of the 22d Dragoons. I underitand, but not officially, that fome Ycomanry from Lord Hertford's Estate (I believe the Derriaghy) were with the Dragouns when they made the unfuccefsful Attack on Antrim, and they retired to Antrim Caffle, where they were relieved by Colonel Durham. Colonel Durham deferves my warmest Praise for his judicious and spirited Conduct. He speaks in high Terms of the Detachment under him, and particularly the Mo-naghan Militia. The Rev. Steele Dickson was taken up the Night before laft, and fent Prifoner here, where he will be confined in a' Place of Safery, as well as many others, whom it is now necessary to apprehend. Your Lordship may depend upon my individual Exertions in this unpleasant Contest; and as I am ably supported, I make no Doubt that we shall prevent the Rebels from gaining any Advantages, and ultimately oblige them to return to their I shall write again To-morrow should Allegiance. any Material Event occur.

Extract of a Letter from Major-General Johnson to Lieutenant-General Lake, dated at Ross, June 1798.

SEND you a Return of the Killed, Wounded and I Miffing of the Troops engaged on the 5th In-flant. Their Numbers you will, I truft, find not great, when you take into Confideration the Numbers they were opposed to.

I likewise fend a Return of the Ordnance, Ammunition and Standards, taken from the Rebels. The Number Killed cannot be afcertained. In my former Letter I was prevented by a Pref-fure of Business doing Justice to the Merits of

their extraordinary Exertions.

General Eultace, Colonel Crawfurd, A. Q. M. G. Lieutenant Colonels Stewart, 89th Regiment, commanding Light Infantry; Maxwell, Donegal Mili-tia; Majors, Vandeleur, Clare Militia; Vefey, County of Dublin Militia; Mellifont, my Aid de Camp, and Major of Brigade Sandford, are entitled to my fulleft Praife. I thould not omit Lieu:enant Eustace, the General's Aide de Camp, who is a very, promifing young Man. To Lieutenant-Colonel James Foulis, commanding the Mid Lotaian Cavalry, and Captain Irvine, commanding the Detachment of the 5th and 9th Dragoons, I am no lefs indebted. I cannot fay too much in Favor of Captain Bloomfield, B. H. Artillery, and Captain Inorthill, commanding the Royal Irith Flying Artillery, whofe very great Exertions contributed very effentially to our Succefs. We had a great Lofs in Colonel Lord Mountjoy. Captain Tottenham, Yeoman Cavatry, and Captain Boyd, with the Debus of his Corps, have rendered me every poffible Affiitance. In making Mention of those Particulars, I would not with you to suppose I do not feel myself much indebted to every Individual, a very few excepted.
