Honourable the Earl of Bath.

Whitehall, April 14. This day Mr. Hubert Burck and Mr. Fohn Macnemarra appeared at the Board, and informed His Majesty upon Oath, That they were come from Ireland to complain, That being Witnesses against the Earl of Tyrone, their Testimony was refuted to be heard by the Grand Jury upon the faid Earls lace Indictment of High Treason, at the Affizes at Waterford. And a Letter being likewise read, which was written by the Judges of the faid Circuit to the Lord Lieutenant, in Anfwer to a like complaint made to his Grace by one Edward Ivy, another of the Witnesses, and gave his Grace an account that the said Hubert Burck, Ed-Sanson (who was also a Witward Ivy, and ness) having complained to them, That the Grand Jury would not hear them, they fent for the Foreman, with fome of his Fellows, who did in open Court declare in the presence of the faid Sanson, Burck, and Ivy, That they had heard what Sanfin and Burck Could fay, and that they had fent for Ivy and Macnemarra, but that they could not be found. Whereupon it was ordered by His Majesty in Council, That the said Burck and Macnemarra should forthwith return to Ireland, and acquaint. the Lord Lieutenant with their Complaint, and that the Information given in and subscribed by them, should be transmitted to his Grace, with directions to examin the matter, and to Proceed therein according to Law.

Whitehall, April 14. His Majesty having commanded the Judges, who are returned from their several Circuits, to give an account of what they had done im pursuance of the Directions they had received from His Majesty in Council, for the more effectual Executing the Laws against Popish Recusants; they accordingly this day attended his Majesty at the Committee of Papery, and made the following Report.

That in some counties they found molt of chose named in the Commissions already Convicted, and their Convictions returned into the Exchequer. But that they had however caused them to be again Proclaimed as fuch. That in other Counties many Popith and reputed Popith Recufants had taken the Oaths, and came to Church; That others, to a-void the effect of the Law, shifted Counties; That in some Counties the Commissions were but newly come down; That however all possible care was taken for the speedy and effectual proceeding upon them: And lastly, that in all their Circuits they had caused those that were not already Convicted to be Presented, and had applied themselves with all possible zeal and vigor for the punctual Performance of the directions they had received in this matter,

His Majefy was pleafed to approve of what they had done, and to require them to proceed as they had begun, letting them know that they should be supplied with all such Orders and Directions as should be farther necessary. And that for such perfons as had absented or withdrawn themselves from their respective ounties, that effectual care be taken for their Profecution at the next Affizes. And that His Majesty would direct the Lords Commisfioners of the Treasury to appoint several sit and able persons to sollicite and actend this bervice, as well at the Assizes as wherever else there should be occasion, His Maj sties intention being, That the faid Laws against Popish Recusants be duely and effectually Executed.
