## PROCLAMATION,

For apprehending Beauchamp Bagnall Harvey, Elquire. GEORGE R.

7HEREAS Beauchamp Bagnall Harvey stands charged with open Acts of Treafon and Rebellion, in commanding the Rebel Force in the County of Wexford in Ireland; We have therefore thought fit, by and with the Advice of our Privy Council, to iffue this our Royal Proclamation, hereby requiring and commanding all our loving Subjects to difcover and apprehend the faid Beauchamp Bagnall Harvey (who is a thin Man, about Thirty-Five or Thirty-Six Years of Age, and is about Five Feet Six Inches high, and floops a little, and is of a darkish Complexion, and has dark Eyes, and is marked with the Small Pox) and to carry him before fome of Our Juffices of the Peace, or Chief Magistrates of the County, Town, or Place where he shall be apprehended, who are respectively required to secure him, and thereof to give speedy Notice to our Privy Council, or one of our principal Secretaries of State, to the end he may be forthcoming, and may be dealt withal, and proceeded against according to Law. And whoever shall discover and apprehend the faid Beauchamp Bagnall Harvey, and bring him before fuch Justice of the Peace, or Chief Magistrate, or fo discover him that he may be apprehended, shall receive a Reward of One Thousand Pounds; which faid Sum of One Thousand Pounds, the Lords Commissioners of Our Treasury, are hereby required and directed to pay accordingly. Given at Our Court at St. James's, the Twenty Ninth Day of June, One Thouland Seven Hundred and Ninety Eight, in the Thirty-Eighth Year of Our Reign.

7HEREAS His Majefty was gracioufly pleased, by His Royal Proclamation bearing Date the Twenty-fixth Day of December, 1792, to promile and declare, that the Bounties of Five Founds for every Able Seaman, and Two Pounds Ten Shillings for every Ordinary Seaman, fit for His Majefty's Service, fhould be paid in the Manner thereby directed to every fuch Able and Ordinary Seaman, not above the Age of Fifty nor under the Age of Twenty Years, who fhould, on or before the Twenty-eighth Day of February then following, enter themfelves to ferve in His Majefty's Royal Navy, either with the Captains or Lieutenants of His Majefty's Ships or Veffels, or Officers employed on Shore for raifing Men for the Service of the Royal Navy: And whereas His Majefty was also graciously pleased, by his faid Proclamation, to declare, that all Able-bodied Landmen, not above the Age of Thirty-five nor under the Age of Twenty Years, who should fo enter themselves as aforefaid, should receive the Sum of Thirty Shillings each Man, as His Ma-jefty's Royal Bounty: And whereas His Majefty jeity's Royal Bounty: And whereas His Majelty was also graciously pleased, by His Royal Procla-mation bearing Date the Sixteenth Day of the faid Month of February, 1793, to promise and de-clare, that a Reward of Twenty Shillings for every Able and Ordinary Seaman, fit to ferve on board His Majesty's Ships, should be paid to any Perfon who should discover any Seaman or Seamen who might conceal him or themfelves, fo that such Seaman or Seamen should be taken for His Majefty's Service, on or before the Thirtieth Day of April then next, by any of His Majefly's Sea Officers appointed to raife Men on Shore, or by the Captains or Commanders of any of His Majesty's Ships or Vessels in the Ports or on the Coasts of this Kingdom: And whereas the Time limited by the faid Proclamations for Payment of the faid Bounties and Reward, hath been prolonged and extended to the Thirtieth Day of this instant June; and it being judged expedient for His Majesty's Service that the faid Bounties and Reward
