W HEREAS George James Earl of Errol was duly elected and returned to be One of the Sixteen Peers of Scotland, to fit in the Houfe of Peers in the prefent Parliament of Great Britain, and is fince deceafed : In order to the electing and is ince deceased: In order to the electing another Peer of Scotland to fit in his Room, We do, by the Advice of Our Privy Council, iffue forth this Proclamation, firstly charging and com-manding all the Peers of Scotland to affemble and meet at Holy-Rood Houfe in Edinburgh, on Wed-nefday the Fifteenth Day of August next, between the Hours of Twelve and Two in the Afternoon, to nominate and chufe another Peer of Scotland. to nominate and chufe another Peer of Scotland, to fit and vote in the Houfe of Peers of this prefent Parliament of Great Britain, in the Room of the faid George James Earl of Errol, deceafed, by open Election and Plurality of Voices of the Peers that fhall then be prefent, and of the Proxies of fuch as fhall be abfent (fuch Proxies being Peers, and producing a Mandate in Writing duly figned before Witneffes, and both Confituent and Proxy being qualified according to Law) i And the Lord Clerk Register, or fuch Two of the Principal Clerks of the Seffion as shall be appointed by him to officiate in his Name, are hereby respectively required to attend such Meeting, and to administer the Oathe required by Law to be taken there by the Oaths required by Law to be taken there by the faid Peers, and to take their Votes; and immediately after fuch Election made, and duly exa-mined, to certify the Name of the Peer fo elected, and fign and atteft the fame, in the Prefence of the faid Peers the Electors ; and return fuch Certificate faid Peers the Electors; and return fuch Certificate into Our High Court of Chancery of Great Bri-tain. And We firitly charge and command that this Proclamation be duly publified at the Market Crofs at Edinburgh, and in all the County Towns in Scotland, Twenty-five Days at leaft before the Time hereby appointed for the Meeting of the faid Peers to proceed on fuch Election. PROCLAMATION; Á

Refpetting ALIENS leaving this Kingdom and arriving therein.

GEORGE R.

HEREAS by an Act passed in the last Sel-fion of Parliament, intituled, "An Act to " continue until the First Day of August, One " thousand eight hundred, and until the End of the " thouland eight hundred, and until the End of the "then next Selfion of Parliament, and amend an "Act made in the Thirty-third Year of the Reign "of His prefent Majelty, intituled, An Act for "eftablifhing Regulations refpecting Aliens ar-"riving in this Kingdom, or refident therein, in "certain Cafes," divers Provifions are made con-cerning Aliens, and it is among other Things enacted, That after the paffing the faid Act, it fhall not be lawful for any Alien to leave this Kingdom not be lawful for any Alien to leave this Kingdom without a Paffport for that Purpole first obtained from One of Our Principal Secretaries of State, or from fome Or Out Thicipal Decretaics of Olarc, of from fome Perfon authorized by Us to grant fuch Paffport, which Paffport is to be produced to the proper Officer of the Cuftoms, at the Port or Place where fuch Alien shall embark for the Purpose of leaving this Kingdom, and allowed by fuch Officer, and fuch Paffport with fuch Allowance is to be also and fuch Paffport with fuch Allowance is to be alfo produced to the Mafter or Perfon having the Charge or Care of the Veffel; in which fuch Alien shall propofe to embark ; and the Penalty of Five Hun-dred Pounds is impofed on fuch Mafter or Perfon having the Charge or Care of fuch Veffel, if any Alien shall embark on board the same, with his Knowledge, Privity, or Confent, not having ob-tained fuch Paffport and fuch Allowance thereof as aforefaid; and fuch Alien is liable to Imprifonment for One Year, and to Transportation for Seven Years; and no Alien arriving in this Kingdom is to depart from the Place at which he or the shallhave fo arrived, without obtaining fuch Licence to refide in this Kingdom, in purfuance of the faid Act, ex-cept for the Purpole of making fuch Declaration or obtaining fuch Paliport, as by the faid Act of the Thirty-third Year of Our Reign are required to be obtained by fuch Alien, or for the Purpole of delivering fuch Account, and obtaining fuch Li-cence as required by the faid Act of the laft Sef614

last mentioned Act shall be carried into Execution in the Particulars aforefaid, do hereby strictly enjoin and command all Our Officers of the Cultoms, and all MagMtrates and other Perfons, to fee to the due Execution of the Act, and take care that the fame be duly executed and performed under the Penalties expressed in the faid Act, and under Pain of Our Displeasure.

A PROCLAMATION, For the Registering of ALIENS.

GEORGE R.

WHEREAS by an Act, passed in the last W Seffion of Parliament, intituled, "An Act " to continue until the First Day of August, One " thousand eight hundred, and until the End of " the then next Seffion of Parliament, and amend " an Act, made in the Thirty third Year of the "Reign of His present Majesty, intituled, An "Act for establishing Regulations respecting Aliens " arriving in this Kingdom, or refident therein, in " certain Cafes," it is enacted, That it fhall be lawful for Us, by Our Royal Proclamation or Proclamations to be iffued for that Purpole, from Time to Time, to require and command every Alien who fhould then be in, or fhould thereafter come into this Kingdom, (except as therein excepted,) to register himfelf or herfelf in the Manner therein mentioned, and thereupon to obtain Our Royal Licence to relide within this Kingdom, as therein mentioned ; and divers other Provisions have been made concerning Aliens, and divers Things are required to be done within certain Spaces of Time therein limited.

And whereas by another Act, paffed in the fame Sefficit of Parliament, intituled, " An Act to " amend an Act of the prefent Sefficion of Parlia-" ment, intituled, An Act to continue until the " First Day of August, One thousand eight hun-dred, and until the End of the then next Sef-"fon of Parliament, and amend an Act, made in the Thirty-third Year of the Reign of His pre-fent Majefty, intituled, An Act for eftablishing Regulations respecting Aliens arriving in this "Kingdom, or refident therein, in certain Cafes," We are authorized, from Time to Time, by Our Royal Proclamation or Order in Council, to extend the Time and Times for doing all and every the Things by the faid first-mentioned Act required to be done, within any certain Space or Spaces of Time, in fuch Mauner as to Us thall feem fit, and to appoint any longer Time or Times for doing all and every or any of fuch Things respectively, and to command and require the fame to be respectively done within such Time or Times as in and by Our Proclamation or Order in Council fhould be limited and appointed for fuch Purpofe: Now We, being defirous of carrying into Execu-tion the Purpofes of the faid Acts, in Manner heremafter expressed, do, by this Our Proclamation, by

Tion of Parliament : We, being defirous that fuch | and with the Advice of Our Privy Council, require and command every Alien who fiall be in this Kingdom on the Day of the Date of this Our Proclamation (except as herein after excepted), to regifter himfelf or herfelf, within Three Wecks after the Day of the Date of this Our Proclamation, in the Manner herein-after mentioned, with fuch Perfons, and in fuch Districts, as herein-after are men-

- All Aliens refiding within the City of London fhall fo register themfelves with the Lord Mayor of the faid City:
 - All Aliens refiding in the City and Liberties of Westminster, or elsewhere within the Bills of Mortality, except the City of London, or refiding within Ten Miles of the City of Lon-don, shall so register themselves with the Magistrates of the Seven Publick Offices, in Queen Square Westminster, Great Marlborough Street, Hatton Garden, Lambeth Street Whitechapel, Worship Street Shoreditch, Union Hall Southwark, and High Street Shadwell:
 - All Aliens refiding out of the Diffricts aforefaid, and within any Cities or Corporate Towns, or within the Jurisdiction of the Magistrates of fuch Cities or Corporate Towns respectively, shall fo register themselves with the Mayor or other Chief Magistrate of each of such Cities
 - or Corporate Towns refpectively: And all Aliens refiding in other Parts of the Kingdom shall fo register themselves with fome Justice of the Peace for the County or Place where fuch Aliens refpectively shall refide.

And We do further require and command all Aliens who shall come into this Kingdom, after the Date of this Our Proclamation, to register himfelf or herfelf in Mauner herein-after mentioned, within One Week after every fuch Alien shall have landed in this Kingdom, with the Mayor or Chief Magiftrate of the Port or Place where fuch Alien shall land in this Kingdom, or in Default of any fuch Magistrate, with the Collector of the Customs of the Port in or nearest to which every fuch Alien fhall land.

And We do further require and command every fuch Alien as aforefaid, for the Purpofe of obtaining fuch Licence as aforefaid, to deliver, or caufe to be delivered, to the Perfon with whom fuch Alien is hereby required to register himfelf or herfelf as aforefaid, a full and true Account, in Writing, of his or her Name, Age, Rank, Occupation or Pro-feffion, and where fuch Alien was born, and where fuch Alien last refided beyond the Scas before his or her last Arrival in this Kingdom, and when fuch Alien last arrived in this Kingdom, and at what Place.

'And We do hereby authorize and appoint the faid Lord Mayor, and fuch Mayors and Chief Magillrates, and other Magistrates and Collectors of the Cuftoms as aforefaid refpectively, to receive fuch Accounts as aforefaid, and do require and command them refpectively to caufe the original Account to be transmitted to Our Principal Secretary of State for the Home Department, for the Purpole of ob-taining Our Royal Licence to refide within thisKingdom, from the faid Secretary, whom We do hereby authorize and appoint to grant fuch Licences, or

from fuch other Perfon or Perfons whom We shall, from Time to Time, likewife authorize and appoint to grant fuch Licences. And We do further authorize and require the

faid Lord Mayor, and every other fuch Magistrate or Officer as aforefaid, to whom any fuch Account shall be delivered as aforefaid, to grant, under his Hand and Seal, to the Alien delivering fuch Account, a Provisional Lieence to fuch Alien to refide within this Kingdom, under fuch Refrictions as fhall appear fit, during the Time fo allowed to fuch Alien for obtaining a Licence as aforefaid. And We do further declare, That this Our

Proclamation shall not extend to require any Alien to deliver fuch Account, and obtain fuch Licence as aforefaid, who is or shall be exempted from the Obligation to deliver fuch Account by Our Proclamation or Order. in Council, or by Special Warrant from One of Our Principal Secretaries of State. And We do further declare, That, according to

the Provisions in the faid first-mentioned Act of Parliament, no Foreign Ambassador, or other Pub-lick Minister, duly authorized, nor the Domestic Servant of any fuch Foreign Ambassador or Publick Minifter, registered as such according to the Directions of the Laws in Force for that Purpofe, or being actually attendant on fuch Ambassador or Minister, is to be deemed an Alien within the Meaning of the faid Act.

And We also declare; That the Provisions in the faid Act do not affect any Alien, in refpect of any Act done, or omitted to be done, who shall make it appear that he or fhe was not above the Age of Fourteen Years at the Time when fuch Act was fo

done or omitted to be done. And We do further declare, That it is by the faid Act provided, that all fuch Licences, and Allowance of Time to obtain Licences as aforefaid, shall be given without Fee or Reward, and shall be fubject to no Duty or Charge whatfoever. And We do further declare and make known,

That every Alien who shall be found at large in Great Britain, after the Time by this Our Proclamation limited, for his or her obtaining Our Royal Licence to refide in this Kingdom, will be liable to Imprilonment for any Time not exceeding One Year, or to Transportation beyond the Seas for any Time not exceeding Seven Years, unless fuch Alien fhall have obtained fuch Licence to refide in this Kingdom, or Allowance of Time unexpired to obtain the fame, or shall be exempted from the Obligation to deliver fuch Account as aforefaid by the faid Act, or by Our Proclamation or Order in Council, or by Special Warrant from One of Our Principal Secretaries of State.
