Cádiz, April 26. 1.

The Charles Gally is newly arrived here from Tangier, and brought an account that the Moors were returned before that place; that by the working of their Trenches, they seemed to design to attack Charles Fort and Henrietta Fort, which were very well provided with Men, and all things necessary for their defence. And that the *Adonure* Frigate was engag'd with an Algerine, so close, that they fired their small shot, and that another Frigate being clean, and a good sailer, was making up to them, and that it was not doubted, but they would take the Algerine.

Copenhagen, April 20. On Thursday the Lord Bodmyn, Envoye Extraordinary from the King of England, arrived here, and this afternoon had a private Audience of the King, who told him, he would appoint Commissioners to Treat with him concerning a Defensive Alliance, from whence may be concluded, that the Reports which have been spread abroad of this Kings having entered into a strict engagement with France, are without any ground.

Berlin, April 20. Our Elector has been for some days retic'd at his house at *Potsdam*, which is the reason Sir Robert Southwel has not yet had an Audience, which is appointed him on Wednesday next. In the mean time there is great apparance that Sir Robert will have good success in his Negotiation here, his Electoral Highness having declared, that he will not depart from the common interest of the Empire.

Cologne, April 26. From *Trier* we have an account that several French Battalions were come to *Sarbruck*, and were to continue their march from thence to *Palsburk*, and that they would be followed in few days by others. That the Intendant of *Nancy* had received Orders from France to go to *St. Diez*, and other places, to view the ways, and if there was occasion to have them repaired, for the more and easy convenient marching of the Artillery.

Paris May 4. The 13th instant the Court removes to *Fontainebleau*, and in the beginning of July the King will begin his great progress, in which its said, he will be attended by a good number of Troops. The second instant, the Dauphin, the Prince of *Consi*, the Prince de la Roche sur Ton, and after them the Count d' *Armagnac*, the Count de *Briou*, the Duke de *Villeroy*, the Duke de la *Tremouille*, the Prince d' *Harcourt*, the Duke de *Gramont*, the Count de *Harson*, the Marquis d' *Angeau*, and the Duke de *Vendosme*, run at the Ring, in the presence

of the King, Queen, and Dauphin. s, and the Duke de *Vendosme* won the prize, which was a Jewel worth a thousand Pistols, given by the King. From Rome we have an account, that our Gallies which sailed last from *Marseilles*; were arrived at *Civita Vecchia*.

Plymouth, April 23. This Evening sailed the *Phoenix*, with the Ships under her Convoy for *Bilboa*. The *Dartmouth* is gone again to cruise to the Westward.

London April 27. A Searcher of the Custom-House coming this day into *Cutter-lane*, near *Cheapside*, with two Files of Musquetiers, and the Command of a Serjeant, to search for prohibited Goods, made a great uproar, which occasion'd the tumultuous meeting of 2 or 300 people; but my Lord Mayor having notice of it, came immediately thither, dispersed the people, and ordered the Serjeant, and Searcher, with the Soldiers, to attend the Court of Aldermen, where it appearing, that their carriage had been very unbecoming, they were committed to *Newgate*.

Whitehall, April 26. This day Sir *Leoline Jenkins* was sworn one of His Majesties Principal Secretaries of State, and received the Seals, which *Henry Coventry* Esq; then delivered up to His Majesty.

The Clerk of the Council and Mr. *Barnes* having given the Board an account of the Examinations they had taken at the places where *Richard Kavenach* had upon his first examination said, he was that day and night when Mr. *Arnold* was assaulted, which did not agree with what he then said; and other Informations having been given, which do very much increase the suspicion upon the said *Kavenach*, their Lordships directed, he should be committed to *Newgate*.

This afternoon His Majesty came to Town from *Windsor*, and to morrow goes for *Newmarket*, from whence His Majesty purposes to return on Friday.

Whitehall, April 26. The Lord *Shandon* having humbly acquainted the King, that the Turkey Company had made choice of him, and intended to recommend him to His Majesty, to be sent as Ambassador to *Constantinople*, and praying His Majesties approbation: His Majesty was pleased to reply, That he having countenanced, and been engaged in the Business of the Petition about the Parliament, (which His Majesty lookt upon as derogatory to His Prerogative, and tending to Sedition) His Majesty could not think him so fit for His Favour. Whereupon His Lordship having desired to be called in to the Committee of Foreign Intelligence this Evening, did there humbly acknowledge to His Majesty his fault, in having been concerned in the said Petition, that he was drawn in, and misled, by being given to understand that that proceeding was for His Majesties Service: but that being since better inform-
