E, taking into Our most serious Consideration the indispensable Duty which We owe to Almighty God for the recent and signal Interposition of His good Providence, in Addition to the manifold and inestimable Benefits which these Kingdoms had already received at His Hands, manifested by the Blessing bestowed on Our Arms in the late memorable Battle, fought in distant Seas, as well as by the Deliverance of Our Dominions from Invasion and from intestine Commotions, through the Energy and Valour of Our Naval and Military Forces, and the Loyalty and Courage of Our faithful Subjects, which, exerted in a righteous Cause, it has pleased the Divine Goodness to crown with Success, have thought fit, by the Advice of Our Privy Council, to issue this Our Royal Proclamation, hereby appointing and commanding that a General Thanksgiving to Almighty God, for these His Mercies, be observed throughout England, Wales, and the Town of Berwick upon Tweed, on Thursday the Twenty-ninth Day of November next: And for the better and more orderly solemnizing the same, We have given Directions to the Most Reverend the Archbishops, and Right Reverend the Bishops of England, to compose a Form of Prayer suitable to the Occasion, to be used in all Churches and Chapels, and other Places of Publick Worship, and to take Care for the timely dispersing of the same throughout their respective Dioceses; and We do strictly charge and command, that the said Publick Day of Thanksgiving be religiously observed by all Our loving Subjects, as they tender the Favour of Almighty God, and upon Pain of suffering such Punishment as we may justly instict upon all such who shall contemn or neglect the same.

For a Publick Thanksgiving.

WE, taking into Our most serious Cousideration the indispensable Duty which We owe to Almighty God for the recent and signal Interposition of His good Providence, in Addition to the manifold and inestimable Benefits which these Kingdoms had already received at His Hands, manifested by the Blessing bestowed on Our Arms in the late memorable Battle, fought in distant Seas, as well as by the Deliverance of Our Dominions from Invasion, and from intestine Commotions, through the Energy and Valour of Our Naval and Military Forces, and the Loyalty and Courage of Our faithful Subjects, which, exerted in a righteous Cause, it has pleased the Divine Goodness to crown with Success, have thought sit, by the Advice of Our Privy Council, to issue this Our Royal Proclamation, hereby appointing and commanding, that a Publick Thanksgiving to Almighty God for these His Mercies, be observed throughout that Part of Our Kingdom of Great Britain, called Scotland, upon Thursday the Twenty-ninth Day of November next: And We do strictly charge and command, that the said Publick Thanksgiving be reverently and decently observed by all Our loving Subjects in Scotland, on the said Twenty-ninth Day of November next, as they tender the Favor of Almighty God, and would avoid His Wrath and Indignation, and upon Pain of such Punishment as We may justly instict on all such as contemn or neglect the Performance of so religious a Duty; Our Will and Pleasure is therefore, and We charge, that, this Our Proclamation seen, ye forthwith pass to the Market Cross of Edinburgh, and all other Places needful, and there in Our Name and Authority make Publication thereof, that none pretend Ignorance. And Our Will and Pleasure is, that Our Solicitor do cause printed Copies hereof to be sent to the Sheriffs of the several Shires, Stewarts of Stewartries, and Bailiffs of Regalities, and their Clerk, whom We ordain to see the same published;

and We appoint them to lend Copies thereof to the feveral Parish Clourches within their Bounds; that upon the Lord's Day immediately preceding the Day above mentioned, the same may be published and read from the Pulpits immediately after Divine Service.

WHEREAS His Majesty was pleased, by his Order in Council of the 28th of last Month, to direct, that all Ships, Vessels, Persons, Goods, and Merchandizes, then arrived, or that should thereafter arrive, in any Port of this Kingdom, or the Isles of Guernsey, Jersey, Alderney, Sark, or Man, from Philadelphia, or any Port within the State of Pennsylvania, should make their Quarantine for Fourteen Days, to commence and be computed from the Day each Ship or Veffel should come to Anchor in the Place appointed for the Performance of Quarantine, and not before; and should strictly conform themselves, in all Respects, to the Rules and Regulations thereby required to be observed: And whereas His Majesty has received Information, that the malignant and infectious Disorder, of the Nature of the Plague, which exists in the City of Philadelphia, hath extended itself to the Port of Boston and New York; His Majesty, by and with the Advice of His Privy Council, doth thereupon order, That the Quarantine, at prefent subsisting upon all Ships and Vessels coming from Philadelphia, be extended to all Ships, Vessels, Persons, Goods, and Merchandizes coming from Botton and New York, or from any of the Ports within the Provinces of Massachusett's Bay and New York: And His Majesty, with the Advice aforefaid, doth hereby further order, require, and command, that all Ships and Veffels whatfoever coming from Boston or New York, or from any of the Ports within the Provinces of Massachusett's Bay and New York, and all Persons, Goods, and Merchandizes, on board the fame, that are already ar-

rived, or shall hereafter arrive, in any of the Ports of this Kingdom, or of the Isles of Jersey, Guernsey, Alderney, Sark, or Man, do make their Quarantine for Fourteen Days, and do strictly conform themselves, in all Respects, to the Rules and Regulations now in Force, and required to be observed by Ships and Vessels subject to Quarantine: And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Lieutenant-General, and the Rest of the Principal Officers of the Ordnance, His Majesty's Secretary at War, and the Governors or Commanders in Chief, for the Time being, of the said respective Isles of Jersey, Guernsey, Alderney, Sark, and Man, are to give the necessary Directions herein, as to them may respectively appertain.

The KING's Most Excellent Majesty in Council. WHEREAS His Majesty was graciously pleased, by His Royal Proclamation bearing Date the Twenty-sixth Day of December, One thousand seven hundred and ninety-two, to promile and declare, that the Bounties of Five Pounds for every Able Seaman, and Two Pounds Ten Shillings for every Ordinary Seaman, sit for His Majesty's Service, should be paid in the Manner thereby directed to every fuch Able and Ordinary Scaman, not above the Age of Fifty nor under the Age of Twenty Years, who should, on or before the Twenty-eighth Day of February then following, enter themselves to serve in His Majesty's Royal Navy, either with the Captains or Lieutenants of His Majesty's Ships or Vessels, or Officers enployed on Shore for raising Men for the Service of the Royal Navy: And whereas His Majesty was also graciously pleased, by his said Proclamation, to declare, that all Able-bodied Landmen, not above the Age of Thirty-five nor under the Age of Twenty Years, who should so enter themselves as aforesaid, should receive the Sum of Thirty Shillings each Man, as His Majesty's Royal Bounty: And whereas His Majesty was also graciously pleased, by His Royal Proclamation bearing Date the Sixteenth Day of the faid Month of February, One thousand seven hundred and ninety-three, to promise and declare, that a Reward of Twenty Shillings for every Able and Ordinary Seaman, fit to ferve on board His Majesty's Ships, should be paid to any Person who should discover any Seaman or Seamen who might conceal him or themselves, fo that fuch Seaman or Seamen should be taken for His Majesty's Service, on or before the Thirtieth Day of April then next, by any of His Majesty's Sea Officers appointed to raise Men on Shore, or by the Captains or Commanders of any of His Majesty's Ships or Vessels in the Ports or on the Coasts of this Kingdom: And whereas the Time limited by the faid Proclamations for Payment of the faid Bounties and Reward hath been prolonged and extended to the Thirty-first Day of this inflant October; and it being judged expedient for His Majesty's Service that the faid Bounties and



Reward should be continued to be paid for some Time longer; His Majesty, with the Advice of His Privy Council, doth therefore order, and it is hereby accordingly ordered, that the Time limited for the Payment of the said Bounties and Reward be prolonged and extended, from the said Thirty-first Day of this instant October to the Thirty-first Day of December next inclusive:—Whereof all Persons concerned are to take Notice, and govern themselves accordingly.

The KING's Most Excellent Majesty in Council, HEREAS the Time limited by His Majesty's Order in Council of the Twenty-fifth Day of April last, prohibiting the Exportation out of this Kingdom of any Sort of Rock Salt, will expire upon the Twenty-ninth Day of this instant October: And whereas it is judged expedient that the faid Prohibition should be continued for some Time longer; His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Person or Persons whatsoever do, at any Time during the Space of Six Months, to commence from the faid Twentyninth Day of this instant October, export, or attempt to export, transport, carry or convey, or load or lay on hoard of any Ship, Vessel, or Boat, in order to be exported, transported, carried, or conveyed out of any Port or Place in Great Britain, any Sort of Rock Salt whatsoever, without Leave or Permission being first had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act passed in the Thirty-fixth Year of His present Majesty's Reign, intituled, "An Act for indemnifying all Persons who have been concerned in adviling or carrying into Execution an Order of His Majetty in "Council respecting the Exportation of Rock "Salt, for preventing Suits in consequence of the " fame, for authorizing His Majesty to prohibit the "Exportation or carrying Coattwile of Rock Salt, and for making further Provisions relative thereto:" His Majesty, nevertheless, by the Advice aforesaid, hath thought fit to order, that nothing herein contained shall prevent Rock Salt being carried Coastwife, under the usual Rules, Regulations, and Restrictions, nor the Exportation of the same to Ireland, or to any other of His Majesty's Dominions, under the usual Conditions and Regulations, jefty's Customs, that the said Rock Sait shall be exported to some Port or Place in His Majesty's Dominions, and none other, and that a Certificate shall be produced, within Six Months from the Date of the Bond, if such Rock Salt shall be entered out for any Part of His Majesty's Dominions in Europe; and within Twelve Months, if for any Part of His Majesty's Dominions in America or the West Indies; and within Eighteen Months, if for any of the British Settlements or Factories in Afia or Africa, under the Hand of the Principal Officer of the Customs at

the Port or Place where such Rock Salt shall be so landed; and if there shall be no Officer of the Customs, then under the Hand of the Chief Magistrate of the Place, testifying that the said Rock Salt has been duly landed at the Port or Place for which the same was entered out.—And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Lords Commissioners of the Admiralty, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein as to them may respectively appertain.

Beg Leave to inclose you Copy of a Letter, sent by this Post, to the Right Honorable Admiral Lord Bridport.

Anson, in Plymouth Sound,
My Lord,
October 27, 1798,
ROM the disabled State of His Majeity's Ship
under my Command in the Action of the 13th
Instant, and the Wind remaining to the S. W.
I was unavoidably separated from the Squadron
under the Command of Sir John Borlase Warren,
Bart. K. B. and drove considerably to the N. W.
of Ireland.

I have great Satisfaction in informing your Lordship, that on the 18th at Daylight in the Morning, I discovered a large Ship to Leeward, fortunately for me, with the Loss of her Fore and Main-Top-Masts, (the Anson being by no Means in a Situation to chase,) her Mizen-Mast gone, Main-Yard and Main-Crosstrees; the Bowsprit and Fore-Yard shot through in several Places.

I immediately bore up, and got alongfide of her, after an Action of One Hour and Quarter, most gallantly disputed, which does the highest Honor to Citizen Joseph Andrien Segone, her Commander, she struck; proved to be La Loire, one of the largest and finest Frigates belonging to the Republic, presented by the City of Nantz, quite new and never before at Sea, pierced for Fifty Guns, mounting Forty-Six, (Eighteen-Pounders,) having on board Six Hundred and Sixty-four Men, (Troops included,) among whom are a Number of Artillery, Etat-Major for Three Regiments. La Loire hai Forty-eight Men killed and Seventy-sive wounded, was One of the Four Frigates which the Anson engaged the 13th, and was making her Escape from the Coast.

I beg Leave particularly to acknowledge the steady and good Behaviour of my Officers and Petry Officers; cannot avoid recommending to your Lordship's Notice my First Lieutenant Mr. John Hinton, whose Conduct not only upon this Occasion but many others, has met with my fullest Approbation; not derogating from the Behaviour of Lieutenants Meager, Manderson, and Mr. William Chrishop, the Master.

I have also to acknowledge the Services of Lieutenants Bell and Derring, of the Marines, who commanded the Carronades; as to my Ship's Company, they have been my faithful Companions during Four

Years in pretty active Service, and whose Conduct upon all Occasions merit my warm Approbation.

Having fallen, in the Night before the Action, with His Majesty's Brig Kangaroo, I ordered Captain Brace, from the Anson's disabled State, to continue in Company, and am much indebted to him for the Services he has rendered me in taking Possession of La Loire.

SIR.

Herewith inclose, for their Lordships' Informa-tion, a Letter I have received from Captain Chefshyre of His Majesty's Sloop Plover, stating his having captured a French Schooner Privateer of Ten Carriage Guns and Eight Swivels, that left Calais on Saturday last in the Forenoon, but had not taken any Thing.

SIR, Plover, at Sea, October 28, 1798. Beg Leave to acquaint you, for the Information of my Lords Commissioners of the Admiralty, that on Sunday Morning the 28th Inftant, I observed a fuspicious Schooner between Three and Four Leagues S. W. of Fairleigh, to which I gave Chaie; at Ten, after firing Five or Six Chaie Guns, she struck; on boarding found her to be Le Corfair L'Eringobrah, of Ten Carriage Guns and Eight Swivels, viz. Eight Three Pounders, and Two Four Pounders, Part of which she threw overboard; she had between Forty and Fifty Men; she failed from Calais on Saturday Forenoon, had taken

Copy of a Letter from Admiral Peyton, Commander in Chief of His Majesty's Ships in the Downes, to Evan Nepean, Efg; dated 29th October 1798.

IS Majesty's Sloop Racoon is just arrived in the Downes, and I herewith enclose a Letter I have received from her Commander, stating his having chafed Three French Lugger Privateers and captured One of them; Le Vigilant, of Twelve Four Pounders, and Two Long Sixes (Fifty-five Men) which foon after funk.

His Majesty's Ship Raccon, SIR, Downes, Od. 20, 1798. BEG Leave to acquaint you, that at Six A. M. on this Morning, Blackness bearing S. E. by E. Distance Three Leagues, I discovered Three large Luggers a-head; immediately made all Sail and gave Chase; after a running Fire of Two Hours, had the Pleasure to come up with and capture One of them, Le Vigilant Lugger, mounting Twelve Four-pounders and Two Long Sixes, carrying Fifty-five Men, (Six or Seven of which were left on Shore at Boulogne,) commanded by Citizen Muirbaffe. On fending my Boats on board, I found that in confe-quence of her being hyll? I in formal Blogge for many quence of her being hull'd in several Places she was finking very fast, which detained me a considerable Time, (in endeavouring to ftop the Leak,) other-wife I must inevitably have taken another before they could possibly have reached the Coast of France. I have the Pleasure to say that all the Prisoners got safe on board except those killed by my firing, and every Exertion was used to save the Vessel, but to no Esfect; at Nine A. M. she funk; she was entirely new, had been out Two Cruises only, and taken nothing. One of the Luggers in Company had captured a Brig, which I observed His Majesty's Sloop the Plover to take Possession of, off Folkestone, at Eleven A. M.
