#### Downing-Street, November 20, 1798.

A Decree having been publiched by the French Directory, declaring, that all Perfons Natives of, or originally belonging to Neutral Countries, or Coun-tries in Alliance with France, who may form a Part of the Crews of any of the King's Ships of War, or any other British Veffels, shall be confidered and treated as Pirates; His Majelty has directed it to be fignified to the Commillary for the French Prifoners in Great Britain, that if this Decree shall, in any Inftance, be carried into Effect against any fuch Perfons taken in any Veffels the Property of His-Majesty, or of His Majesty's Subjects, and navi-gated under the British Flag, it is His Majesty's Determination to exercise the most rigorous Retaliation against the Subjects of the French Republic, whom the Chance of War has now placed, or may hereafter place, at the King's Difpolal.

#### NOTICE to MARINERS.

Copenhagen, August 30, 1798.

IN order to render those Mariners who frequent the Port of Bergen more confident of their Situation when on that Coaft, particularly when failing to and from the faid Port by Skuddenees, a new Lantern-Light has been erected on the Point of that Naze, which will begin to burn on the 1st or that Naze, which will begin to burn on the lift of January, 1799, and continue on the fame Regu-lations as the Reft of the Lights, viz. during the Summer, from Eafter till Michaelmas, when it will be lit One Hour after the Setting of the Sun; and during the Winter, from Michaelmas till Eafter, it then being lit Half an Hour after the Setting of the Sun and continuing to burn till Day light the Sun, and continuing to burn till Day-light. It is further made known, that this Lantern will be hoifted on a Maft or Pole, close to which a Shed is built and painted White; therefore the fame must be feen very plainly in those Directions in which it prefents itself to View. The Lantern will be about Three Hundred Feet above the Surface of the Water. It is already known that there has long been a Coal-Light on the Isles of Hvidding, and a Lantern-Light close to Hoyvarden, the latter ferving when one has entered Carmfound, to affift in chufing a good Berth to anchor in. Whenever one may with to bear away for the Bay and enter Carmfound, one ought, with due Attention, be able to diftinguish the Light of Skuddenees and Hvidding lifes. This laft, which is fuspended between Two Poles, gives a Blaze-Light, but that on the Skuddenees, as has been observed, is a Lantern, and gives a clear and fleady Light; and belides, this Light cannot be feen when one comes from the Weftward, unless one is fo much to the Southward

that the Cliff of Giætongen does not interrupt the View of it, or that you have it due N. E. by E. : And in this Point of the Compais, the Navigation is clear from Hvidding Ifles; one may therefore, if one got Sight first of one Light, and were in Doubt a short Time which of them it was, sheer a little Eaft, for were it Skuddenees Light that ap-peared, one would flortly after fee the Blaze of Hvidding Ifles, unlefs it were a Fog, hazy Wea-ther, or Snow Storm. If, however, by fleering more to the Eastward, another Light does foon appear, it must naturally be that on Hvidding Isles, and one may then by Soundings fet one's Courfe accordingly and take a View of the other, fince, if from the Situ-ation of Skuddenees Light being hidden from the high Land, a Light appears more to the Eaftward, than due N. E. by E. be affured it must be Hvidthan due N. E. by E. be affured it muft be Hvid-ding Ifles. Knowing this, one may with Safety keep under Skuddenees, as one may now by the new Light know to a Certainty where the Bite is, and accordingly run in under the Land, and fo into Carmfound. When one comes near the Smorf-takken, one may expect to fee all the Three Lights ; and again, if the Light of Skuddenees is hidden by the high Land, then the Two others, particularly that clofe to Hoyvarden, will prove fufficient to direct one to a good Anchorage in this Harbour. But if one is unacquainted, and will not venture to run into Carmfound without Pilot, or other Ob-ftacles prefenting themfelves, then the Lights on the Ifle of Hvidding and Skuddenees will prove a re-Ifle of Hvidding and Skuddenees will prove a remarkable Affiftance to those who find themfelves obliged to cruize here during the Night; but in that Cafe it is abfolutely neceffary to be particularly attentive that the Current (which is frequently very ftrong here) does not drive the Veffel on either Side.

We view with the warmest Gratitude these fignal Interpolitions of Divine Providence for defeating the Defigns of our Enemies against the Liberties of this Country and the Profperity of the British Empire.

It is no lefs our Inclination than our Duty to cherish in the People under our Care an affectionate Attachment to your Majesty's Perfon and Government, and to the excellent Conftitution under which we have the Happiness to live.

We shall not fail to inculcate upon them a just Senfe of the Goodneis of God to us as a Nation, and

to excite them to a fleady Regard to the Dochrines and Duties of our holy Religion, as the molt effectual Means of promoting both their own Happi-nels and the Welfare of the State.

#### Whitehall, November 27.

As feveral Artificers and Manufacturers, Subjects of Great Britain, have, from Time to Time, gone into Foreign Countries to exercise their feveral Callings, contrary to the Laws of these Kingdoms, the follow-ing Abstracts of Ads of Parliament of Their late Majeflies King George the First and Second, and of Machines King George the First and Second, and of His prefent Majefty, for preventing such Practices, are published, for the Information of all Persons who may be ignorant of the Penalties they may incur-by Disobedience to them: And it will be observed, that such Penalties likewise extend to those who are any ways concerned or infrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, or in the Exportation of the Tools and Infruments used by them, as well as to the Artifi-cers or Manufacturers themselves.

Statute 5 George I. Chap. 27. IF any Perfon shall contract with, entice, or folicit, any Artificer in Wool, Iron, Steel, Brafs, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries out of the King's Dominions, and shall be convicted thereof, upon Indictment or Informa-tion in any of the Courts at Westminster, or at. the Affizes or Quarter-Seffions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Per-fon having been once convicted shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be paid.

If any of the King's Subjects, being fich Artificers, shall go into any Country out of His Majefty's Dominions, to exercise or teach the faid Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercising any of the faid Trades, shall not return into this Realm within Six Months after Warning given by the Ambaffador, Minifler or Conful of Great Britain, in the Country where fuch Artificers shall be, or by any Perlon authorifed by fuch Ambaffador, &c. or by one of the Secretaries of State, and from henceforth inhabit within this Realm; fuch Perfons shall be incapable of taking any Legacy, or of being

an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Defcent, Devife, or Purchafe, and shall forfeit all Lands, Goods, &c. within this Kingdom; to His Majesty's Use, and shall be deemed Alien; and out of His Majesty's Protection.

Upon Complaint made, upon Oath, before any Juffice of Peace; that any Perfon is endeavouring to feduce any fuch Artificer, or that any fuch Artificer hath contracted or is preparing to go out of His Majefty's Dominions, for the Purpoles aforefaid, Juch Juffice may fend his Warrant to bring the Perfon complained of before him, or before fome other Juffice; and if it fhall appear by the Oath of One Witnefs, or by Confeffion, that he was guilty of any of the faid Offences, fuch Juffice may bind him to appear at the next Affizes or Quarter Seffions: And if fuch Perfon fhall refule to give Security, the Juffice may commit him to Gaol till the next Affizes or Quarter Seffions, and until he fhall be delivered by due Courfe of Law. And if any fuch Artificer fhall be convicted, upon Indictment, of any fuch Promife, Contract, or Preparation to go beyond the Seas, for the Purpole aforefaid, he fhall give fuch Security to the King not to depart out of His Majefty's Dominions, as fuch Court fhall think reafonable, and fhall be imprifoned till Security given.

If any of the above Offences shall be committed in Scotland, the same shall be prosecuted in the Court of Justiciary or the Circuits there:

### Statute 23 George II. Chap. 13.

IF any Perfon shall contract with, or endeavour to feduce any Artificer in Wool, Mohair, Cotto leduce any Artificer in Wool, Mohair, Cot-ton, or Silk, or in Iron, Steel, Brafs, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufac-tures of Great Britain or Ireland, to go out of this Kingdom or Ireland into any Foreign Coun-try not within the Dominions of the Crown of Great Britain, and fhall be convicted, upon In-dioment or Information. in the King's Bench at dictment or Information, in the King's Bench at Weftminster, or by Indictment at the Affizes or General Gaol Delivery for the County, &c. wherein such Offence shall be committed in England, or by Indictment in the Court of Jufficiary or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Dublin, if fuch Offence be committed in Ireland; the Perfon fo convicted fhall, for every Artificer contracted with or feduced, forfeit FIVE HUNDRED POUNDS, and shall fuffer Impri-fonment in the Common Gaol of the County or Stewartry wherein fuch Offender shall be convicted for Twelve Calendar Months, and until Forfeiture be paid :. And in cafe of a fubsequent Offence of the fame Kind, the Perfons fo again offending fhall forfeit, for every Perfon contracted with or feduced, ONE THOUSAND POUNDS, and shall fuffer Imprisonment in the Common Gaol of the County or Stewartry wherein fuch Offender shall be convicted, for Two Years, and until fuch Forfeiture be paid.

If any Perlon in Great Britain or Ireland shall put on board any Ship or Boat, not bound directly to fome Port in Great Britain or Ireland, or to fome

other of the Dominions of the Crown of Great Britain, any fuch Tools or Utenfils as are commonly ufed in, or proper for the Preparing; Working up, or Finifhing of the Woollen or Silk Manufactures, or any Part of fuch Tools; he fhall, for every Offence, forfeit all fuch Tools; or Parts thereof, put on board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Weftminfter, or in the Court of Seffion in Scotland, or at any of the Four Courts in Dublin refpectively, wherein no Effoin, &c. fhall be allowed.
