#### Dublin-Cafile, January 22, 1799

HIS Day his Excellency the Lord Lieutenant went in State to the Houfe of Peers, and being feated on the Throne with the ufual So-lemnity, Thomas Lindfay, Efq; Gentleman Ufher of the Black Rod, was fent with a Meffage from his Excellency to the Houfe of Commons, fignify-ing his Pleafure that they fhould immediately attend his Excellency in the Houfe of Peers. The Com-

mons being come thither accordingly, his Excel-lency made the following Speech :

My Lords, and Gentlemen,

Have received His Majesty's Commands to meet

you in Parliament. I congratulate you on the happy Effects which have followed the unparalleled Atchievement of the Detachment of His Majefty's Fleet under the Command of Rear-Admiral Lord Nelfon, on the total Defeat of the French Squadron off the Coafts of this Kingdom by that under the Command of Sir John Borlafe Warren, and on the brilliant and im-portant Conquest of Minorca. These Events, while they afford to us in common with every other Defoription of His Majefty's Subjects Matter of juft Pride and Satisfaction, must at the fame Time give Confidence to other Powers, and fhew to all Eu-rope the beneficial Effects of a Syltem of Vigour and Exertion directed with manly Perfeverance against the destructive Projects of the common Enemy

I feel much Concern in being obliged to acquaint you, that a Spirit of Difaffection still prevails in feveral Parts of this Kingdom, and that the fecret Agents of the Enemy are active in raifing an Expectation of fresh Assistance from France.

In this Situation, and under the evident Necessity of continuing the War with Vigour, His Majefly firmly relies upon that Spirit and Magnanimity which have hitherto marked all your Exertions in Support of the Honor of His Crown, of the In-terefis of this Kingdom, and of the general Caufe of the Empire.

Gentlemen of the House of Commons, I have ordered the Public Accounts and Estimates to be laid before you, and as I am confident your Wildom will raife the Supplies which may be necessary in the Manner least burdensome to the

Subject, fo you may depend upon my Attention to their prudent and œconomical Application. It is with great Satisfaction I observe that, not-

withstanding our internal Calamities, this Kingdom, blended as its Interests are in the general Prosperity of the Empire, has participated in the Effects of the increasing Wealth and Commerce of Great Bri-tain, and that our Revenues and Trade have increafed.

#### My Lords, and Gentlemen,

It is my Duty to recommend to your Attention the various Objects of internal Regulation which have fo long enjoyed the Benefit of your Protection and Support. Your Agriculture, your Manufac-tures, and particularly the Linen Manufacture, the Protestant Charter Schools, and other charitable Inflitutions will require, and will, I am fure, conti-nue to receive, that Aid and Encouragement which they have uniformly experienced from the Libera-lity of Parliament. I am confident you will feel a particular Anxiety to give further Attention to the just and honorable Claims of those who have suf-fered from their Loyalty during the Rebellion.

His Majelty depends upon your perfevering Energy to reprefs, by every wife Effort, the Spirit of Difaffection which still requires the Exercise of extraordinary Powers to check its malignant Effects. In recurring where the Occafion has required it to Acts of indifpenfable Severity, I have not been in-attentive to the Suggestions of Mercy, and have endeavoured to mitigate the Effects of Penal Juftice, and the neceffary Exertions of the Powers of the State, with as much Forbearance and Lenity as could be confistent with the Public Safety.

In the general Caufe which engages the Empire, our Profpect is highly encouraging, but in Propor-tion as a fuccefsful Termination of the War bis-comes probable, our Efforts should be redoubled in order to fecure it.

In order to lecure it. The Zeal of His Majefty's Regular and Militia Forces, the Gallantry of the Yeomanry, the honor-able Co-operation of the British Fencibles and Militia, and the Activity, Skill, and Valour of His Majefty's Fleets, will, I doubt not, defcat every future Effort of the Enemy: But the more I have reflected on the Situation and Circumstances of this Kingdom, confidering on the one Hand the Strength

and Stability of Great Britain, and on the other those Divisions which have shaken Ireland to its Foundations, the more anxious I am for fome per-manent Adjuftment, which may extend the Advantages enjoyed by our Sifter Kingdom to every Part

of this Ifland, The unremitting Industry with which our Ene-mies perfevere in their avowed Defign of endea-vouring to effect a Separation of this Kingdom from Great Britain, must have engaged your particular Attention; and His Majefty commands me to exprefs His anxious Hope, that this Confideration, joined to the Sentiment of mutual Affection and common Intereft, may difpole the Parliaments in both Kingdoms to provide the most effectual Means of maintaining and improving a Connexion, effential to their common Security, and of confolidating, as far as poffible, into one Firm and lafting Fabric, the Strength, the Power, and the Refources of the Britifh Empire.
