PROCLAMATION. А

GEORGE R.

WHEREAS We have Reafon to apprehend that divers Perfons engaged in the Treafon-able Confpiracy againft Us in Our Kingdom of Ireland, which lately manifested itself in open Acts of Rebellion and War againft Us in Our faid Kingdom, have not abandoned their Treafonable Defigns against Us, and acting in concert with Our Foreign Enemies, are preparing to affist Our faid Enemies in an Invasion of Our Kingdoms, and for that Purpose are endeavouring to incite and stir up Rebellion and War against Us in this Kingdom; We have therefore thought it neceffary for the Safety of Our Kingdoms, to prevent all Perfons engaged in fuch Treafonable Defigns from paffing from Our faid Kingdom of Ireland into this Kingdom: and We do, for that Purpole, by and with the Advice of Our Privy Council, order, and do hereby flrictly charge and command, That, from and after the Twentieth Day of March inftant, no Perfon whatfoever be permitted to pais from Our faid Kingdom of Ireland into this Kingdom, except fuch Perfons as shall be in Our Service, and actually fo employed, and fuch Perfons as shall obtain a Paffport for that Purpofe from Our Lord Lieu-tenant of Our faid Kingdom of Ireland, his Chief or Under-Secretaries, the Mayor, or other Chief Magistrate, of fome City or Town in Ireland, or One of Our General Officers commanding Our Forces within the feveral Districts in Our faid Kingdom; and by and with the Advice aforefaid, Kingdom; and by and with the Advice aforelaid, We do further order, and hereby firicitly charge and command, that no Perfon whatfoever, (except as aforefaid,) coming from Our faid Kingdom of Irelaud, be permitted to land in this Kingdom with-out Our Licence for that Purpofe first obtained; and that all fuch Perfons (except as aforefaid) who shall land or attempt to land in this Kingdom, without fuch Licence as aforefaid, shall be forth-with taken into Custody, and detained in Custody with taken into Cuffody, and detained in Cuffody until Our Pleafure shall be further known; and We do further order and require, that all Perfons, having fuch Paffports as aforefaid, fhall produce the fame to fome Officer of Our Cuftoms at the tions as shall be fpecified in fuch Order or Orders,

Port or Place to which fuch Perfons shall come, before fuch Perfons shall be permitted to land at fuch Port or Place; and We do hereby, by and with the Advice aforefaid, strictly enjoin, require, and command all and fingular Juffices of the Peace, Mayors, Sheriffs, Bailiffs, Conitables, and all other Our Officers and Subjects, to use their utmost Endeavours for the due Execution of these Our Commands.

#### PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by an Act, paffed in the Twentyeighth Year of the Reign of His prefent Majefty, intituled, " An Act for regulating the Trade " between the Subjects of His Majefty's Colonies " and Plantations in North America, and in the "West India Islands, and the Countries belonging " to the United States of America, and between " His Majefty's faid Subjects and the Foreign Iflands in the Welt Indies," It is, amongft other Things, enacted, That it shall and may be lawful for His Majefty in Council, by Order or Orders to be iffued and published from Time to Time, to autho-rize, or by Warrant or Warrants, under His Sign Manual, to empower the Governor of Newfoundland for the Time being to authorize, in cafe of land for the Time being to authorize, in case of Neceffity, the Importation into Newfoundland of Bread, Flour, Indian Corn, and Live Stock, from any of the Territories belonging to the faid United States, for the Supply of the Inhabitants and Fishermen of the Island of Newfoundland, for the then enfuing Seafon only; provided always, that fuch Bread, Flour, Indian Corn, and Live Stock, fo authorized to be imported into the Island of fo authorized to be imported into the Island of

Warrant or Warrants, respectively, and except by British Subjects and in British-built Ships, owned by His Majesty's Subjects, and navigated according to Law. And whereas it is expedient and necellary that Provision be made for fully supplying the Inhabitants and Fishermen of the Island of Newfoundland, for the enfuing Seafon, with Bread, Flour, Indian Corn, and Live Stock; His Majefty doth thereupon, by and with the Advice of His Privy Coun-ed, hereby order and declare, That, for the Supply of the Inhabitants and Fishermen of the Island of Newfoundland, for the enfuing Seafon only, Bread, Flour, Indian Corn, and Live Stock may be imported into the faid Ifland from any of the Ter-ritories belonging to the faid United States, by British Subjects, and in British built Ships, owned by His Majesty's Subjects, and navigated according to Law, and which shall, within the Space of Seven Months previous to the Time of fuch Im-portation, have cleared out from some Port in Great Britain, or some other Part in His Majelly's Dominions in Europe, for which Purpole a Licence fhall have been granted by the Commiffioners of His Majefty's Cultoms in England or Scotland, or the Commiffioners of His Majefty's Revenue in Ire-land, or any other Perfon or Perfons who may be duly authorized in that Kingdom respectively, in the Manner and Form hereinafter mentioned; which Licence shall continue and be in Force for Seven Calendar Months from the Day of the Date upon which such Licence is respectively granted, and no longer; provided that no fuch Licence as aforefaid, granted after the Thirtieth Day of September, One thousand feven hundred and ninety-nine, shall be of any Force or Effect: And His Majesty is hereby further pleased to order, That the Master, or Person having the Charge or Command of any Ship or Veffel to whom fuch Licence shall be granted, shall, upon the Arrival of the faid Ship or Veffel at the Port, Harbour, or Place in the Island of Newfoundland, where he shall discharge such Bread, Flour, Indian Corn, and Live Stock, deliver up the faid Li cence to the Collector or other proper Officer of the Cultoms there, having first indorfed on the Back of fuch Licence the Marks, Numbers, and Contents of each Package of Bread, Flour, or In-dian Corn, and the Number of Live Stock, under the Penalty of the Forfeiture in the faid Act men-And the Collector or other proper Officer tioned. of the Cuftoms of Newfoundland is hereby enjoined and required to give a Certificate to the Master, or Perfon having the Charge or Command of fuch Ship or Veffel, of his having received the faid Licence, fo indorfed as before directed, and to transmit the fame to the Commiffioners of His Majesty's Customs in England or Scotland, or to the Commiffioners of His Majefty's Revenue in Ireland, refpectively, by whom fuch Licence was granted. Now be it known, That the faid [Perfon's Name] hath Licence to lade on board the faid Ship [Ship's Name] at and from any Port or Place be longing to the United States of America, Bread, Flour, Indian Corn, and Live Stock, the Produce of the faid United States, and no other Articles whatfoever, and to carry the faid Bread, Flour, Indian Corn, and Live Stock to fome Port or Place in the Island of Newfoundland; and on the Arrival of the faid Ship at any Port, Harbour, or Place of Discharge in Newfoundland, the Master, or Person having the Charge or Command of the faid Ship, is required and enjoined to deliver up the faid Licence to the Collector or other proper Officer of His Majefty's Cuftoms there, and to indorfe on the Back thereof the Marks, Numbers, and Contents of each Package of Bread, Flour, or Indian Corn, and the Number of Live Stock, and fhall thereupon receive. a Certificate thereof from the faid Collector or other proper Officer of the Cuftoms.
