TVIS Majefty having been pleafed to appoint the Right Honorable Sir George Yonge, Baronet, Knight of the Bath, to be Governor and Commander in Chief in and over the Settlement of the Cape of Good Hope, in South Africa, with its Territories and Dependencies; he this Day took the Oaths appointed to be taken by the Governors of His Majesty's Plantations.

St. James's, April 3, 1799. This Day Count d'Haslang had a Private Au-dience of His Majesty to notify the Death of the late Elector Palatine Duke of Bavaria, and to deliver his new Credentials, giving him the Character of Envoy Extraordinary and Minister Plenipotentiary from the prefent Elector Palatine Duke of Bavaria :

The Gentlemen to wear Black Coats, and Black or Plain White, or White and Gold, or White and Silver Stuff Waistcoats Full-trimmed, Colored Swords and Buckles.

And on Sunday the 14th Inftant the Court to go out of Mourning.
