H E following Addreffes of the General Affembly of the Church of Scotland, having been transmitted by the Earl of Leven, His Ma-jesty's High Commissioner, to his Grace the Duke of Portland, One of His Majefty's Principal Secre-taries of State, have been by him prefented to the King; which Addreffes His Majefty was pleafed to receive very gracioufly.

Most Gracious Sovercign,

HE Letter which it hath pleafed your Ma-jefty to addrcfs to this Meeting of the General Affembly of the Church of Scotland was received

with the most profound Respect and Gratitude. We account ourfelves highly honored by the Reprefentation of the Royal Perfon in our General Affembly as the gracious Symbol of the Connection between the Church and the State. We have We have beheld with much Satisfaction in many preceding Years this high Office committed to a Nobleman, whofe warm Attachment to your Majefty, whofe hereditary Affection for the Church of Scotland, whofe fleady Regard to Religion, and whofe many amiable Virtues render him eminently qualified to anfwer every Purpole of the Truft with which he is invefted; and we receive your Majefty's renewed Appointment of the Earl of Leven and Melvill as a Pledge of the paternal Love with which you have unceafingly regarded us.

We rely with entire Confidence upon the folemn Affurances of your Majesty's Determination to maintain and preferve the Church of Scotland in the complete Enjoyment of all its jult Rights and Privileges; and we shall study upon all Occasions to conduct ourfelves in fuch a Manner as may entitle us to hope for the Continuance of your Royal Approbation.

Your Majefty's Donation of One Thousand Pounds, for the Propagation of Christian Knowledge in the Highlands and Islands of Scotland, was received with the fincerest Gratitude, as a renewed Inflance of your perfevering Attention to the re-ligious Interefts of the People committed to our Care, and it shall be our Endeavour to apply it with Fidelity to the pious Purpole for which it is beftowed.

Placed in the perilous Days fo well deferibed in your Majesty's most gracious Letter, when the very Principles of Religion and Morality are denied by tome, and confounded by others ; and when wicked Men have derided every Thing which is grave and just and holy, we have unspeakable Confolation in thinking that we live under the Reign of a Prince whole exemplary Piety adorns the Throne, who condefcends to mention with Approbation the Zeal of the Church of Scotland, who calls us by his Authority to an undeviating Perfeverance in the Discharge of our Duty, and affures us of all the Encouragement and Support which the Circumfances of the Times require.

We liften with the most profound Respect to the folemn Charge which we receive from your Majefty, and it is our determined Refolution, in Compliance with that Charge, and in fulfilment of the Duties of our facred Office, that we will, through the Strength of the Lord Jefus, be inftant at all Scalons in feeking after Truth, in defending, teaching, and fpreading it; that we will labour by Precept and by Example, to aid the Caufe of Religion and Virtue in the World; that we will endeavour to difpel the dangerous Delufions of an arrogant and vain Philolophy, and of Science falfely to called; and in all our Ministrations will direct the Minds of the People over whom we exercise the Pastoral Care to the revealed Will of Alnighty God as the only infallible Standard of Truth and perfect Rule of Manners. We feel the facred Obligations of which your Majestyis graciously pleafed to remind us, that arife from our being, in the Words of our Great Mafter, "a City fet upon an Hill:" And we look up to Him for those Influences of His Spirit which may enable us fo to frame our Decifions that they may fecure the Refpect of our Brethren, and may guide them in all Matters of Doctrine and Difcipline.

Confcious that our Exertions, however unremitting and well directed, are of none avail without the Bleffing of Heaven, we ceafe not to offer our fer-vent Prayers to the Supreme Disposer of all Events, befeeching Him to avert from these Kingdoms those Errors which have brought Ruin and Defolation upon all who have embraced them. We blefs the Lord our God, who, becaufe he loved us, hath raifed up a Succeffion of Princes in the Illustrious Houfe of Hanover to be the Nursing Fathers of His Church. We pray that it may please Him to prosper all your Majestry's Defigns for the Good of . the Church of Scotland, and the Advancement of the Christian Religion; and, relying upon His Almighty Protection, we trust that, under the wife and vigorous Administration of your Majesty's Government, our Ecclesiaftical Establishment, which has been cheristed with warm Affection by the People of Scotland, and which has been the Means of Difference amongft all Ranks, the Knowledge and the Principles of pure and undefiled Religion shall be preferved from being shaken by external Violence, or undermuned by the Machinations of secret Foes: That the belt Bleffings of Heaven may descend

upon your Majefty, upon our Gracious Queen Charlotte, upon the Prince and Princess of Wales, and all the Royal Family; that your Majesty may long continue to reign in the Hearts of a pious, loyal, free, and happy People; and that after fwaying the British Sceptre for many Years with Felicity and Renown, you may be received into those Regions where an unfading Crown awaits the Faithful, are the earnest Prayers of,

WE, your Majesty's most dutiful and loyal Subjects, the Ministers and Elders of the Church of Scotland, met in the General Affembly, beg Leave to approach the Throne with Sentiments of the most affectionate Attachment to your Majefty's Perfon and Government.

Beholding with Reverence the Conduct of Providence in the Permiffion of those calamitous Events, which for Years paft have afflicted and defo-lated fo many of the neighbouring Nations, we feel the moft lively Gratitude to Almighty God when we contemplate the prosperous Condition of Great Britain. Preferved by the Wifdom of your Majefty's Councils from the Traitorous Attempts made to difturb its internal Tranquillity, this happy Coun-try flourishes even in the midst of War, and, communicating to its Allies a Portion of its own Vigour, it has been juftly regarded as the great Bul-wark railed by Divine Providence for refifting the Progrefs of those destructive Principles which threatened the total Subversion of Religion and good Government in every Quarter of the World.

We are fincerely grieved to learn that there are fill among us Men infentible to the ineftimable Bleffings we enjoy, but we truft that their Numbers are daily decreasing; and your Ma-jefty may be affured that the Church of Scotland, faithful to her Duty, will in her proper Sphere co-operate zealoufly with the Civil Power in counteracting their infidious Defigns. Amidst the general Satisfaction with which we contemplate the State of the Country, we embrace, with peculiar Pleasure the first Opportunity which our Meeting affords us of congratulating your Majefty on the fplendid Naval Victories gained in the Courle of laft Year by your Majesty's Arms at the Mouth of the Nile, and on the Coaft of Ireland, under the Con-duct of Lord Nelfon and Sir John Borlafe Warren : Victories, honourable in the highest Degree to the good and gallant Men by whom they were achieved, highly conducive national Security, and most important in their Confequences to the general Iffue of the War. And while our devout Acknowledgments rife to the Lord of Hofts, from whom alone cometh Wildom and Strength, on account of the brilliant Events, which, under your Majefty's more immediate Administration, have contributed so much to the Advantage of the common Caufe, we have beheld alfo, with the most grateful Satisfaction, the rapid Tide of Victory which has followed of late the Arms of your Majesty's Allies on the Continent ; and we cherifh the Hope that, by a Continuation of Succefs, your Majefty will be foon enabled, in concert with your Allies, to bring this arduous
