Extract of a Letter from Captain Griffiths, Commander of His Majefly's Ship Diamond, to Evan Nepean, Efq; dated at Spithead, the 12th Instant.

N the 29th Ultimo the Revolutionaire cap-tured L'Hipolite French Letter of Marque, from Cayenne, bound to Nantes, and in Latitude 46 Deg. N. and Longitude 24 Deg. W. we recaptured the Brig Margaret, from Greenock bound to Savannah, who had been taken but a few Hours before by the Determiné Freuch Ship Privateer then in Sight; and which, after a Chace of Four-teen Hours, was captured by the Revolutionaire. I have brought her to Spithead: she is a very compleat Vessel, fails uncommonly fast, and is well calculated for His Majesty's Service: she is pierced for Twenty-four Guns, mounts Eighteen Brass Twelve and Nine-Pounders, and had One Hundred and Sixty-three Men on board when taken.
