Copy of a Letter from Sir William Sydney Smith, Knight, Captain of His Majefly's Ship Tigre, to Evan Nepean, Efq; dated at Acre, the 3d of May, 1799.

SIR,

Have the Honor to enclose you Copies of my Letters to Earl Saint Vincent, of the 7th of April and 2d Inftant, for the Information of my Lords Commiffioners of the Admiralty; as alfo a Sketch of the Position of the Forces. The Enemy have made Two Attempts fince Vesterday Morning have made Two Attempts fince Yesterday Morning to force the Two English Ravelines, but were re-pulsed with Lofs. The Works have now Cannon mounted on them, and are nearly completed. We have thus the Satisfaction of finding ourfelves, on the Forty-fixth Day of the Siege, in a better State of Defence than we were the First Day the Enemy opened their Trenches, notwithstanding the Increase of the Breach which they continue to batter with Effect ; and the Garrifon, having occasionally closed with the Enemy in feveral Sorties, feel greater Confidence that they shall be able to refift an Assault, for which they are prepared.

Tigre, Saint Jean D'Acre Bay, MY LORD, April 7, 1799. Have the Honor to inform your Lordship, that as soon as the Return of fine Weather, after the Equinoctial Gale, allowed me to approach this un-fheltered Anchorage, I refumed my Station in the Bay with the Squadron under my Orders. I found the Enemy had profited, by our forced Abfence, to push their Approaches to the Counterscarp, and even into the Ditch of the North East Angle of the Town-Wall, where they were employed in mining the Tower, to increase a Breach they had already made in it, and which had been found impracticable when they attempted to ftorm on the 1it Inftant, The Alliance and Prize Gun-Boats, which had been caught in the Gale, had fortunately rode it out ex cept One; and Captain Wilmot had been fo inde-fatigable in mounting the Prize Guns, under the Direction of an able Officer of Engineers, Colonel Phelipeaux, that the Fire therefrom had already

flackened that of the Enemy; still, however, much was to be apprehended from the Effect of the Mine, and a Sortie was determined on, in which the British Marines and Seamen were to force their Way into Trenches and Seamen were to force their Way into it, while the Turkith Troops attacked the Enemy's Trenches on the Right and Left. The Sally tools place this Morning juft before Daylight; the Im-petuolity and Noile of the Turks rendered the Attempt to furprife the Enemy abortive, though in other Refpects they did their Part well. Lieux. nant Wright, who commanded the Seaman-Pioneen notwithflanding he received Two Shot in his Right Arm as he advanced, entered the Mine with the Pikemen, and proceeded to the Bottom of it, where he verified its Direction, and deftroyed all that could be defiroyed in its then State, by pulling down the Supporters. Colonel Douglas, to whom I had given the neceffary Step of Rank to enable him to command the Turkift Colonels, fupported the Seamen in this desperate Service with his usual Galmen in this delperate Service with his utual Gal-lantry, under the increafed Fire of the Enemy, bringing off Lieutenant Wright, who had fearcely Strength left to get out of the Enemy's Trench, from which they were not diflodged, as a for Mr. Janverin, Midfhipman of the Tigre, and the Reft of the Wounded. The Action, altogether, fpeaks for itfelf, and fays more than could be fail by me in Parife of all concerned. I feel doubly indebted to Praise of all concerned. I feel doubly indebted to Colonel Douglas for having preferved my gallant Friend Lieutenant Wright, whofe Life, I am happy to fay, is not defpaired of by the Surgeon. We have, however, to lament the Lofs of a brave and tried Officer, Major Oldfield, who commanded the Thefeus's Marines, and fell glorioufly on this Oc-cafion, with Two of the Men under his Command. Our Lofs in Wounded is Twenty-three, among which is Lieutenant Beatty, of the Marines, flightly. The Turks brought in above Sixty Heads, a greater Number of Mulquets, and some intrenching Tools, much wanted in the Garrison. A further Attack on the Enemy's Second Parallel was not to be at-tempted without a greater Number of Regular Troops. The Return of the Detachment was well covered by the Thefeus's Fire, Captain Miller having taken an excellent Polition to that Effect.

The Refult of our Day's Work is, that we have taught the Befiegers to respect the Enemy they have

to deal with, fo as to keep at a greater Diffance. The Apprehensions of the Garrison are quieted as to the Effect of the Mine, which we have befides learnt how to countermine with Advantage, and more Time is gained for the Arrival of the Reinforce-ments daily expected.

Tigre, moored under the Walls of Acre, May 2, 1799

'HE Enemy continue to make the most vigorous Efforts to overcome our Refistance in the Defence of this Place. The Garrifon has made occafional Sorties protected by our fmall Boats on their Flank with Field Pieces, in which the most effential Service has been performed by Lieutenant Brodie and Mr. Atkinfon of the Thefeus, and Mr. Joes, Malter of the Tigre, who commanded them.

Yesterday the Enemy, after many Hours heavy Cannonade from Thirty Pieces of Artillery brought from Jaffa, made a Fourth Attempt to mount the Breach, now much widened; but were repulled with Lofs. The Tigre moored on one Side and the Theseus on the other flank the Town Walls; the Gun Boats, Launches, and other Rowing Boats continue to flank the Enemy's Trenches to their great Annoyance. Nothing but Defperation can induce them to make the Sort of Attempts they do to mount a Breach practicable only by the Means of Scaling Ladders, under fuch a Fire as we pour in upon them; and it is impossible to fee the Lives even of our Enemies thus facrificed, and fo much Bravery missipplied, without Regret. Our Lofs is as per Lift enclosed, and we have therein to lament fome of the bravest and best among us. Captain Wilmot was shot on the 8th Ultimo, by a Rifleman, as he was mounting a Howitzer on the Breach : his Lofs is feverely felt.

We have run out a Ravelin on each Side of the Enemy's nearest Approach, in which the Marines of the Tigre and Thefeus have worked under a heavy and inceffant Fire from the Lnemy in a Way that commands the Admiration and Gratitude of the Turks, as it is evident the Flanking Fire produced from them contributed much to fave the Place Yesterday. Colonel Phelipeaux, of the Engineers, who projected and fuperintended the Execution, has fallen Sacrifice to his Zeal for this Service; want of Rest and Exposure to the Sun having given him a Fever, of which he died this Morning; our Grief for this Lofs is excellive on every Account. Colonel Douglas fupplies his Place, having hitherto carried on the Work under his Direction, and is indefatigable in completing it for the Reception of Cannon. I must not omit to mention, to the Credit of the Turks, that they fetch the Gabions, Farcines, and those Materials which the Garrison does not afford, from the Face of the Enemy's Works, fetting Fire to what they cannot bring away. The Enemy re-pair in One Night all the Mifchief we do them in the Day, and continue within Half Piftol Shot of the Walls in fpite of the constant Fire kept up from the Ramparts under the Direction of Lieutenaut Knight.

I hope I need not affure your Lordship that we fhall continue to do our Duty to the utmost of our Power, in fpite of all Obstacles; among which, Climate, as it affects Health; and the exposed Nature of our rocky Anchorage, are the most for-midable, fince they are not to be overcome, which I truft the Enemy are by our Exertions.

Inga', the 11th July, 1799. I Take the Liberty to acquaint you that on the 7th Inftant, being in Vigo Bay, I took and deftroyed Four finall Coafters, having on board.

empty Pipes from Ferrol to Vigo, and fent the Crews on Shore in a Fishing Boat. On the 9th, coming out of Marim Bay, fell in with the El Juego Spanish Schooner Privateer, commanded by Remao Rodrigues Trelles, of Ten Muskets, Ten Pistols, and Ten Sabres, manned with Sixteen stout Men, of the Burthen of about Ten Tons, quite new and coppered, had come from Feirol Two Days before, and had not taken any Thing ; which Veffel I brought to this Place.

HIS Majelly having reviewed the Yeomanry Cavalry and Volunteer Corps of the County of Kent, at the Mote, the Seat of the Right Honorable Lord Romney, Lord Lieutenant of the County, on the ift Inftant, the following Letter was, by His Majesty's Command, written to his Lordship on the Occasion, by the Right Honorable Henry Dundas, one of His Majefty's Principal Secretaries of State.

The Mote, August 1; 1799. MY LORD, I HAVE His Majesty's Commands to express the extreme Gratification he has received in reviewing the Volunteer Corps of the County of Notwithstanding all the Reports of their Kent. good Conduct, Loyalty, and Proficiency in their Military Duties, their Appearance in His Majefty's Prefence has far exceeded the most fanguine Expectation. I truft you will communicate to them, in the most forcible Manner you can, His Majesty's most cordial Approbation; I confeis myself unequal to the Charge of doing it in Terms fufficiently expreflive of His Majefty's Feelings.

I have it specially in Command from His Majesty to mention to your Lordship, that the Military Appearance of the Volunteer Corps of the County of Kent was but one Ingredient in that heartfelt Satisfaction His Majesty has this Day experienced in contemplating a Display of those Virtues and Manners which diftinguish the genuine Character of Englishmen, and that however much it may be improved, will never be impaired by the Example of the Person to whom His Majesty has committed the Charge of this great and respectable County.

The particular Day chosen for this Review naturally brought to His Majesty's Contemplation the Circumstances which, in fecuring the Constitution, placed at the fame Time his Family on the Throne of these Kingdoms, and after a Lapse of almost a Century, during which the fame System of Liberty and Law has remained inviolate, the Manifestations of Loyalty and Attachment His Majefty has met with have funk deep into his Heart, and made an Impreffion which never can be effaced.

Whereas it has been humbly reprefented to His Ma-jefty; that on Monday the 8th Day of this infant July, about Half pafl One o'Clock in the Morning, Mr. William Rutter, Sitter of the Cuflom-Houfe Boat flationed at Lymington, within the Port of Southampton, in the County of Hants, being out upon Duty with Four of his Men in the faid Boat to the Weflward of Hurft Cafile, near Mineway, he observed a Veffel coming in from Sea towards the Shore, which, fufpeting to be employed in fmuggling, he ordered his Men to row towards her for the Purpofe of cutting her off from the Shore : that on coming near the faid Veffel Mr. Rutter Effeovered her to be a Lugger of between Twenty and Thirty Tons Burthen, with Black Canvas Waiftcloths and Tallowed Bottom, carrying a Tanned Mainfail, Thirty Tons Burthen, With Black Carvas Waltclobs and Tallowed Bottom, carrying a Tanned Mainfail, White Forefail, Mizen, and Jib; and about Two o'Clock the fame Morning when he got within Forty Yards of the faid Lugger, near a Place called Beacon Bunny, about Three Hundred Yards from the Shore, he bailed her and enquired what Lugger fle was, upon which one of the Green who gues farding he the Afran which one of the Crew who was flanding by the After-Part of the Mainfail, which had been hojsted a few Minutes before, afted "What Boat is that?" and being Minutes before, afked "What Boat is that ?" and being anfavered that it was the Cuftom-Houfe Boat, he told Mr. Rutter, that he muft not come on board but keep off. Mr. Rutter then told the Crew on board the Lugger to bawl down their Sails, as he flould come on board of them prefently, upon which the fame Perfon again afked what Boat it was, and upon being an-fwered that it was the Lymington Cuftom-Houfe Boat, Jome Perfon on board the Lugger, and who was fland-ing near the Afterpart of the Mainfail, immediately fired with a Blunderbufs or Gun at the Boat, by which Charles Colborne, one of Mr. Rutter's Boatmen. which Charles Colorne, one of Mr. Rutter's Boatmen, was killed, and William Lyne, another of his Boatmen, was feverely wounded in the Right Arm : that Mr. Rutter then requested the Perfons on board the Lugger not to fire again, and they were told what had bap-pended to the Guston-House Boat, but no Answer being

pended to the Gustom-House Boat, but no Answer being returned, he directed the Remainder of his Men to row off as fast as possible. The faid Lugger was after-wards observed about Three Leagues to the Westward of the Needles, steering to the Southward. His Majesty, for the better discovering and bringing to Justice the Persons concerned in this Felony and Murder, is hereby pleased to promise His most gracious Partion to any one or more of the faid Offenders (except the Person who actually fired) who shall discover his or their Accomplices, fo that any one or more of them may be apprehended.
