GEORGE R.

HEREAS by an Act, passed in the Thirtyseventh Year of Our Reign, intituled, "An "Act to shorten the Time now required for giving "Notice of the Royal Intention of His Majesty, "His Heirs and Successors, that the Parliament fall meet and be holden for the Dispatch of "Business, and more effectually to provide for the Meeting of Parliament in the Case of a Demise of the Crown;" it is enacted, That whenever We shall be pleased, by and with the Advice of Our Privy Council, to issue Our Royal Proclamation, giving Notice of Our Royal Intention that Parliament shall meet and be holden for the Dispatch of Business on any Day, being not less than Fourteen Days from the Date of such Proclamation, the same shall be a full and sufficient Notice to all Persons whatever of such Our Royal Intention, and the Parliament shall thereby stand prorogued to the Day and Place therein declared, notwithstanding any previous Prorogation of the Parliament to any longer Day, and notwithstanding any former Law, Usage, or Practice to the contrary: And whereas Our Parliament now stands prorogued to Tuesday the Twenty-ninth Day of October next, and forasmuch as for certain Causes We are desirous that Our Parliament should meet on an earlier Day for the Dispatch of Business, We, by and with the Advice of Our Privy Council, do by this Our Royal Proclamation, publish and declare Our Royal Will and Intention, that Our faid Parliament shall meet and be holden on Tuesday the Twentyfourth Day of this instant September, for the Difpatch of divers weighty and important Affairs: And the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required to give Attendance accordingly at Westminster on the said Twenty-fourth Day of September.

Given at Our Court at Weymouth, the Ninth Day of September, One thousand seven hun-dred and ninety-nine, and in the Thirty-ninth Year of Our Reign.

MY LORD, 26th January 1799.
Have the Satisfaction to inform your Lordship that Yesterday, after a Chace of Eight Hours, I captured L'Intrepide French Privateer, of Twenty Brass Guns, Six's and Twelves, (Eighteen of which he hove overboard during the Chace,) and One Hundred and Sixty Men, out Forty-eight Days from Bourdeaux, commanded by Citizen Jean Baptiste Cherchy; has captured during her Cruise the Ships annexed, out of which I have recaptured as per inclosed List; the Caroline I have fent in chace of a Vessel in the S. W. which I understand, from the Captain of the Privateer, is the Jane of Liverpool, a Letter of Marque, which, much to the Credit of her

Captain, engaged the Privateer for Forty Minutes.
When the Privateer struck, the Sea was running so high that it was with the utmost Exertions of Lieutenants Russell and Brown that I was enabled to take Possession of her, happily without the Loss of the People, as the Launch and Jolly Boat went down in the Act of boarding her; and I have this Morning been enabled to exchange the Prisoners. It is her first Crusse, is coppered, and in light Winds sails uncommonly sast: nothing but a Gale would have enabled me to come up with her.

I directed all my Prizes to proceed to Lisbon, but fear from the strong Gales we have had at S.W. they have been forced to bear up for the Channel.

MY LORD, Have the Honor to inform your Lordship, that this Morning I retook the Chateau Margo English Brig, from Oporto bound to Limerick, that had been captured the Day before by Two Spanish Row-Boats; Four Hours afterwards I perceived Two small Luggers in Shore, one of which I captured after a Chace of Three Hours; proves to be the Diligente of Bajona, mounting Two Carriage Guns, with Swivels, &c. and Twenty-one Men; out Three Days from Villa Conda, without making a Capture; the other I ran on Shore in a Bay to the Northward of Oporto, and fent the Boats to destroy her: Night coming on they must have got her off, for the Boats returned without being able to find her: as the Mondovi is off there, I hope she may be enabled to pick her up.

MY LORD, Flora, at Sea, April 20, 1799 Aving thought it advisable to see the Letter of Marque I captured on the 16th Inftant, to the Southward of the Burlings, this Day, Cape Roxen bearing E. S. E. 15 or 20 Leagues, I fell in with a Schooner Privateer in the Act of boarding a Brig under American Colours, which, after a Chace of Fourteen Hours, I have the Satisfaction to inform your Lordship, I captured; she proves to be La Legere French Privateer of Bayonne, mounting Fourteen Guns, Eight-Pounders, and Sixty Men, (Four of her Guns she hove overboard during the Chace,) commanded by Citizen Malleux, out from Bayonne in Spain Six Days, has captured one Portuguese Brig. I have the greater Satisfaction in

making the above Capture, as the is only Six Months off the Stocks, is coppered, and fails very well; she intended cruifing for a Convoy that has failed from England for this Country, also for the Departure of the Brazil Fleet.

ŚIR. 29th Fuly 1799. Beg Leave to inform you, by an Order from Captain Smith, commanding His Majetty's Ship Hannibal, and Senior Officer of a Squadron cruifing off Havanna, dated May 14, 1799, I proceeded to New Providence, and having completed the Echo's Provisions and Water, I made the best of my Way to join the Squadron between the Colorados and the Dry Tortugas by the above Order; I remained there till the 3d of this Month, without meeting the Squadron, on which Day early in the Morning I faw Three Sail, the largest appearing the most suspicious, I immediately chaced; at Seven P. M. she hoisted French National Colours and fired a Shot; at Half Past. Nine being close up with her, and having returned a few Shot for her Broadside, she struck, and proved to be L'Amazon French Ship Letter de Marque, from Jacquemel, St. Domingo, bound to Bourdeaux, mounting Ten Six-Pounders, and Sixty Men, Cargo Coffee: on exchanging Prisoners, finding her People very fickly, with the Advice of my Officers, I put them into an empty Spanish Sloop I had taken a few Days before, and fent them for the nearest Spanish Port.
