His Majesty doth therefore. fome Time longer: His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, That no Person or Persons whosoever do, at any Time during the Space of Six Months, to commence from the said Seventh Day of November next, export, or attempt to export, transport, carry, or convey, or lade or lay on board of any Ship, Vessel, or Boat, in order to be exported, transported, carried, or conveyed out of this Kingdom, any Pot-Ash or Pearl-Ash, without Leave or Permission being first had and obtained from His Majesty, or His Privy Council, upon Pain of incurring the Forscitures inslicted by an Act, passed in the Thirty-fourth Year of His Majesty's Reign, intituled "An "Act for indemnifying all Persons who have been "concerned in advising or carrying into Exe"cution an Order of the Lords Commissioners of the Majesty's Transferrence of the Expression " His Majesty's Treasury respecting the Exportation " of Pot Ashes or Pearl-Ashes; for preventing Suits in consequence of the same; for authorising His "Majesty to prohibit the Exportation or carrying "Coastwife of Pot-Ashes or Pearl-Ashes, and for " making further Provisions relative thereto:" But it is, nevertheless, His Majesty's Pleasure, that nothing herein contained shall extend, or be confirmed to extend, to prevent the Exportation of the faid Articles to Ireland, or to His Majesty's Islands of Guernsey, Jersey, Alderney, Sark, or Man, or to His Majesty's Colonies or Plantations in America or the West Indies, or to Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies: prohibit, and command, that no Person or Person

London, November 9, 1799.
Yesterday Harvey Christian Coombe, Esq. Lord
Mayor Elect for the Year ensuring, was sworn at
Guildhall; when the Chair, and other Ensigns of
Mayoralty, were surrendered to him in the accustomed Manner.

This Day the new Lord Mayor, accompanied by the late Lord Mayor, the Aldermen, Recorder, and Sheriffs, in their Scarlet Gowns, went in their Coaches to the Water-fide, the Sword and Mace being carried before them, and the City Officers attending; and from thence proceeded in the City Barge, attended by the feveral Companies in their respective Barges, adorned with Streamers and Pendants, to Westminster; and having walked round the Hall, and solemnly saluted all the Courts, they went to the Exchequer Bar, and the new Lord Mayor did there take the Oaths appointed; and having recorded Warrants of Attorney in the proper Courts, returned by Water to Black Friars, and from thence in Coaches, with the usual Solemnity, to Guildhall, where a magnificent Entertainment was provided; at which were present several of the Foreign Ministers, the Great Officers of State, divers of the Nobility, Lords of His Majesty's Most Honorable Privy Council, the Judges, and many other Persons of Quality and Distinction.

Whitehall, November 2, 1799.

W Hereas it has been humbly represented to His Majesly, that on the 24th of July last, a Smuggling Lugger being observed by some Officers of the Revenue, in Gricketh or Kickith Bay, in the County of Carnarvon, then landing her Goods; Richard Bridgwater, Supervisor of Excise, Maurice Williams, Tide Surveyor of the Customs at Pullbely, in the said County, together with Two Tide Waiters and some other Officers in the Service of the Customs, went in a Boat in Pursuit of her: that when they came within about Three or Four Hundred Tards of the said Smuggling Vessel, (the Custom-House Colours being then stying in the Boat,) the Officers hailed her, upon which the Smugglers asked what Boat it was, and upon being told the King's Boat, they ordered the Officers to keep off or abide by the Consequence; but being told by the Officers that they should not, the Smugglers immediately stred a Musket, the Ball from which came very near the King's Boat; the Smugglers then fired Eight other Muskets, One of which passed between the Fore and Main-Mast of the King's Boat, and another close behind the Officer, Richard Bridgwater, and upon the Smugglers threatening to drive the Officers into the Water if they did not keep off, they returned without being able to board the said Smuggling Vessel.

The faid Vessel is about Thirty-three Tons Burthen, Black Sides, and without a Name, and had about Eight or Twelve Hands on board, low Stern, very narrow Waist Gunnell, and supposed to have been built at Dover, or in that Part of the Coast.

His Majefly, for the better discovering and bringing to Justice the Persons concerned in this Felony and Outrage, is hereby pleased to promise his most gracious Pardon to any One or more of the said Offenders, (except the Master or Commander on board the said Vistel, and the Person Persons who assually fired,) who shall discover his or their Accomplices, so that any One or more of them may be apprehended.
