# Whitehall, December 13, 1799.

The King has been pleafed to grant to the Molt Honorable Richard Marquis Wellefley, of Norragh, in the Kingdom of Ireland, and Baron Wellefley in this Kingdom, Knight of the Most Illustrious Order of St. Patrick, in confideration of his great and eminent public Services in the arduous Situation of Governor-General of the British Possefilions in the East Indies, from the Time of his taking upon him the faid Government to the glorious Termination of the War with the late Sultan of Myfore, his Royal Licence and Authority to bear, as an ho-norable Augmentation to his Coat of Arms, an Inefcutcheon Purpure charged with an Effoile radiated Wavy between Eight Spots of the Royal Tiger in Pairs faltierwife proper, reprefenting the Standard of the faid Sultan, taken at Seringapa-tam, and prefented to the faid Richard Marquis Wellesley, at Madras, on His Majesty's Birth-Day, the 4th of June 1799; and allo that a Repre-fentation of the faid Standard, and of the Tri-coloured Flags taken and prefented at the fame Time, be added to the Supporters and Creft of the faid Richard Marquis Wellefley; the fame being first duly exemplified according to the Laws of Arms, and re-corded in the Heralds' Office : and also to order, that His Majefty's faid Conceffion and efpecial Mark of his Royal Favor be registered in the College of Arms.

THEREAS the Time limited by His Majefty's Order in Council of the Twenty-fixth Day of June last, prohibiting the transporting into any Parts out of this Kingdom, any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rofin, Turpentine, Anchors, Cables, Cordage, Mafts, Yards, Bowfprits, Oars, Oakum, Oker, Sheet-Copper, or other Naval Stores; will expire upon the Twenty-fifth Day of this inftant December : And whereas it is judged expedient for His Majefty's Service, and the Safety of this Kingdom, that the faid Prohibition should be continued for fome Time longer; His Majefty doth therefore, with the Advice of His Privy Council, hereby order, require; prohibit, and command, that no Perfon or Perfons whofoever do at any Time, for the Space of Six Months, to commence from the faid Twenty-fifth Day of this inftant December, prefume to transport into any Parts out of this Kingdom, any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rofin, Turpentine, Anchors, Cables, Cordage, Malts, Yards, Bowiprits, Oars, Oakum, Oker, Sheet-Copper, or other Naval Stores, or ship or lade any of the Articles above mentioned on board any Ship or Veffel, in order to transporting the same into any Parts beyond the Seas, without Leave or Permiflion being first had and obtained from His Majefty or His Privy

Council, upon Pain of incurring the Forfeitures inflicted by an Act, paffed in the Thirty-third Year of His Majesty's Reign, intituled " An Act to ena-" ble His Majefty to reilrain the Exportation of Na-" val Stores, and more effectually to prevent the Ex-... portation of Salt-Petre, Arms, and Ammunition, " when prohibited by Proclamation or Order in " Council." But it is, neverthelefs, His Majefty's Pleafure, that nothing herein contained shall extend, or be confirued to extend, to any of His Majefty's Ships of War, or any other Ships or Veffels or Boats, in the Service of His Majefty, or employed or freighted by His Majesty's Board of Ordnance, or by the Commissioners of His Majefty's Navy; nor to prevent any Ship or Veffel from taking or having on board fuch Quantities of Naval Stores as may be necessary for the Use of fuch Ship or Veffel during the Courfe of her intended Voyage, or by Licence from the Lord High Admiral of Great Britain, or the Commiffioners of the Admiralty for the Time being ; nor to the Exportation of the faid feveral Articles to Ireland, or to His Majesty's Yards or Garrifons, or to His Majesty's Colonies or Plantations in America or the West Indies, or to Newfoundland, or to His Majefty's Forts and Settlements on the Coaft of Africa, or to the Island of St. Helena, or to the Britifh Settlements or Factories in the East Indies: Provided that, upon the Exportation of any of the faid Articles, for the Purpofes of Trade, to Ireland, or to His Majesty's Yards or Garrifons, or to His Majefty's Colonies and Plantations in America or the Weft Indies, or to the Island of Newfoundland, or to His Majesty's Forts and Settlements on the Coaft of Africa, or to the Island of St. Helena, or the British Settlements or Factories in the Eaft Indies, the Exporters of fuch Articles do first make Oath of the true Destination of the fame to the Places for which they shall be entered Outwards, before the Entry of the fame shall be made, and do give full and fufficient Security, by Bond, to the Satisfaction of the Commiffioners of His Majesty's Customs, to carry the faid Articles to the Places for which they are fo entered Outwards, and for the Purpofes fpecified, and none other; and fuch Bond shall not be cancelled or delivered up, until Proof be made, to the Satisfaction of the faid Commiffioners, by the Production, within a Time to be fixed by the faid Commiffioners, and specified in the Bond, of a Certificate or Certificates, in fuch Form and Manner as shall be directed by the faid Commissioners, shewing that the faid Articles have been duly landed at the Places for which they were entered Outwards. #### A PROCLAMATION, For giving Currency to a new Coinage of Copper Money, of Two-penny and One-penny Pieces, Half-penny Pieces and Farthings.

WHEREAS in Confequence of the unanimous Address of our Commons of Great Britain in Parliament affembled, We thought fit to order that certain Pieces of Copper should be coined, which should go and pais for One Penny and Two Pennies, and that each of such Pieces of One Penny should weigh One Ounce Avoirdupois, and that each of fuch Two-penny Pieces should weigh Two Ounces Avoirdupois, the intrinsic Value of fuch Pieces of One Penny and Two Pennies, Workmanship included; corresponding as nearly as poffible with the nominal Value of the fame refpectively; every fuch Picce having on one Side thereof Our Effigies or Portraiture, with Our Name or Title, and on the Reverfe, the Figure of Britannia, reprefented fitting on a Rock in the Sea, holding a Trident in her Left Hand, and a Branch of Olive in her Right Hand, with the Year of our Lord; And whereas Penny and Two-penny Pieces of Copper of the Weight and Defcription aforefaid having been coined accordingly, We did, with the Ad-vice of Our Privy Council, by Our Royal Proclamation, bearing Date the Twenty fixth Day of July in the Thirty-feventh Year of Our Reign, ordain, declare, and command, That fuch Pieces of Copper Money should be current and lawful Money of Our Kingdom of Great Britain, and thould pais and be received as current and lawful Money of Our faid Kingdom, that is to fay, fuch Penny Pieces as of the Value of One Penny, and fuch Two-penny Pieces as of the Value of Two Pennies, in all Payments and Transactions of Money; provided that no Perfon should be obliged to take more of such Copper Money, in any One Payment, than should be of the Value of One Shilling, after the Rate aforefaid: And whereas We have fince cauled great Quantities of fuch Penny and Two-penny Pieces to be coined and delivered, and We have also thought fit to order, That Halfpenny Pieces and Farthings fhould be coined, having allo on one Side thereof Our Effigies or Portraiture, with Our Name or Title, and on the Reverfe the Figure of Britannia, with the Year of our Lord; all which Two-penny Pieces, One-penny Pieces, Halfpenny Pieces, and Farthings, have been coined by Matthew Boultor, of Soho, in the County of Warwick, Efquire; and We do intend, from Time to Time, as Occafion shall require, to order like Two-penny Pieces, Onepenny Pieces, Halfpenny Pieces, and Farthings, or fome or one of them, to be coined in like Manner, and to be delivered at fuch Times and in fuch Quantities as We shall find to be necessary for the Purpofes of Circulation: We have therefore, with the Advice of Our Privy Council, thought fit to iffue this Our Royal Proclamation; and We do hereby ordain, declare, and command, That all fuch Pieces of Copper Money, fo already coined and iffued, and which shall hereafter be coined and iffued as aforefaid, fhall be current and lawful Money of Our Kingdom of Great Britain, and fhall pass and be received as current and lawful Money of Our faid Kingdom, (that is to fay); fuch Two-penny Pieces as of the Value of Two Pence, and fuch Penny Pieces as of the Value of One Penny; fuch Half-pence as of the Value of One Halfpenny, and fuch Farthings as of the Value of One Farthing : Provided that no Perfon shall be obliged to take more of fuch Two-penny and One-penny Pieces, in any one Payment, than fhall be of the Value of One Shilling, after the Rate aforefaid; or to take more of fuch Halfpenny and Farthing Pieces, in any one Payment, than fhall be of the Value of Sixpence, after the Rate aforefaid.

WHEREAS the Time limited by His Majesty's Order in Council of the Fifth Day of June laft, for prohibiting the Exportation out of this Kingdom, or carrying Coaffwife, Gunpowder or Saltpetre, or any Sort of Arms or Ammunition, will expire upon the Seventh Day of this inftant December: And whereas it is judged expedient for His Majeffty's Service, and the Safety of this Kingdom, that the faid Prohibition fhould be continued for fome Time longer: His Majefty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Perfon or Perfons whatloever (except the Master-General of the Ordnance for His Majesty's Service) do, at any Time during the Space of Six Months, to commence from the Seventh Day of this inftant December, prefume to transport into any Parts out of this Kingdom, or carry Coaftwife, any Gunpowder or Saltpetre, or any Sort of Arms or Ammunition, or fhip or lade any Gunpowder or Saltpetre, or any Sort of Arms or Ammu-nition, on board any Ship or Veffel, in order to transporting the fame into any Parts beyond the Seas, or carrying the fame Coaftwife, without Leave or Permillion in that Behalf first obtained from His Majefty, or His Privy Council, upon Pain of incurring and fuffering the respective Forfeitures and Penalties inflicted by an Act, paffed in the Twenty ninth Year of His late Majefty's Reign, intituled "An Act " to empower His Majefty to prohibit the Export-" ation of Saltpetre, and to enforce the Law for em-" powering His Majefty to prohibit the Exportation " of Gunpowder, or any Sort of Arms and Ammuni-" tion ; and also to empower His Majesty to restrain " the carrying Coaftwife of Saltpetre, Gunpowder, " or any Sort of Arms or Ammunition."-And the Right Honorable the Lords Commissioners of His Majefty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master |

Have just Time to communicate to my Lords L Commiffioners of the Admiralty, the Arrival of His Majetty's Schooner Netley off this Port with Two Spanish Lugger Privateers taken on the 14th Iustant and on this Day : also a Lugger taken on the 24th by His Majefty's Ship Caltor in Sight of the Netley, with which I bore up from Oporto agreeable to written Orders from Captain Gower-The Walfingham Packet is this Moment under our Stern, which will be a fufficient Apology for the Brevity of this Letter. On my Arrival at Lifbon I fhall do myfelf the Honor of transmitting the Particulars of my Proceedings, with the Account of Two additional Recaptures of Brigs from Newfoundland.

#### Head-Quarters, Morozzo, November 14, 1799.

IT gives me great Satisfaction to be able to Itate to your Lordship, that it is the Determination of the Commander in Chief to undertake imme-diately the Siege of Coni, and push it on with all full View 20th Refeltion has been added poffible Vigor. This Refolution has been adopted in confequence of the Events which have taken place fince the Battle of the 4th, and which prove the Defeat of the Enemy on that Day to have been most complete. The Prifoners taken on the 4th and 5th amount to Four Thousand Three Hundred, which Number is much greater than was at first fuppofed. The Austrians lost Two Thousand in Killed and Wounded. On the 11th the Division of General Ott attacked that Part of the Enemy which remained at Borgo Saint Dalmazzo, and drove them as far as Robillante. On the fame Day Major-General Somafiva purfued the French in the Valley of the Stura as far as Demonte, of which he took Pof-Majorfeflion, and made One Hundred Prifoners. General Gottersheim alfo obliged the French to evacuate the Villages of La Chuifa, Boves, and Poveragna. General Championet had affembled his whole Force at Mondovi, and upon the Mountains behind the River Ellero, as far as Monasterlo. As long as he occupied this Polition, it was impollible to undertake the Siege of Coni. General Melas therefore gave Orders that a general Attack should be made on the 13th. A Letter from Championet to Saint Cyr had been intercepted, which shewed that the latter was not able to purfue the Advan-tage which he had gained over General Kray in the lait Action which I had the Honor of flating to your Lordship. For this Reason the Division of General Metrowski, which had marched as far as Cherafco for the Purpole of reinforcing General Kray, was ordered to return to the Camp of the Trinita on the 12th, and to form the Left of the Attack on the Town of Mondovi. The Remainder of the Army marched in Two Columns. The one, by La Chiula, upon Monafterlo; the other, by Villa Nova, upon the Centre of the Enemy's Line. From the Difficulties of the Roads the Attacks were not made till very late, and the Enemy, without making much Refiftance, abandoned all his Politions. The People of Mondovi opened the Gates of the Lower Town to the Austrians. The French Army retired to Vico, and evacuated the Citadel of Mondovi in the Night.

MY LORD,

General Championet is retreating towards Ormia, and Major-General Bellegarde is fent with a con-fiderable Corps in his Purluit. The Auftrian Army marches this Day to Beinette, and will To-morrow take up the necessary Politions to cover the Siege. I never yet have feen Inveteracy and Deteflation of the French fo general, and carried to fuch Lengths as it is here: the whole People are armed; and, headed by a Prieft, perform the most wonderful Exploits. In the Beginning of the Campaign they took both Ceva and Mondovi from the French; and in the Action of Yelterday, a Body of Fifteen Thousand prevented a very strong Column of the Enemy from marching by a particular Road; the Country, being mountainous, is peculiarly favorable to their irregular Mode of fighting.
