E, taking into Our most serious Considera-tion the just and necessary War in which We are engaged, for the Maintenance of the Independence of Our Crown, for the Defence and Protection of the Commerce, and of the Rights and Liberties, Civil and Religious, of Our Subjects, and putting Our Trust in Almighty God, that He will gra-ciously bless Our Arms, both by Sea and Land, have refolved, and do, by and with the Advice of Our Privy Council, hereby command, That a Public Fast and Humiliation be observed throughout that Part of Our Kingdom of Great Britain called England, Our Dominion of Wales, and Town of Berwick upon Tweed, on Wednesday the Twelfth Day of March next; that so both We and our People may humble Ourselves before Almighty God, in order to obtain Pardon of Our Sins; and may, in the most devout and solemn Manner, send up Our Prayers and Supplications to the Divine Majesty, for averting those heavy Judge-ments which Our manifold Sins and Provocations have most justly deserved; and imploring His Blessing and Affistance on Our Arms, and for restoring and perpetuating Peace, Safety, and Prosperity to Us and Our Kingdoms: And we do strictly charge and command, That the said Publick Fast be reverently and devoutly observed by all Our loving Subjects in England, Our Dominion of Wales, and Town of Berwick upon Tweed, as they tender the Favor of Almighty God, and would avoid His Wrath, and Indignation; and upon Pain of such Punishment as We may justly inslict on all such as contemn and neglect the Performance of so relicious and neglect the Performance of the better gious and necessary a Duty. #### By the KING. APROCLAMATION,

For granting the Distribution of Prizes taken from the Persons inhabiting the Coasts and Ports of Genoa, and the Territories of the Pope, subsequent to the Twenty-eighth Day of September One thousand seven hundred and ninety-eight, the Date of His Majesty's Order in Council for granting General Reprisals against the Ships and Goods of the said Persons, then subject to the pretended Authority of Governments styling themselves the Ligurian and Roman Republics.

GEORGE HEREAS, by Our Order in Council dated the Twenty-eighth Day of September One thousand seven hundred and ninety-eight, We have ordered that General Reprifals should be granted against the Ships and Goods belonging to the Perfons inhabiting the Coasts and Ports of Genoa and the Territories of the Pope, then subject to the pretended Authority of Governments styling them-Telves the Ligurian and the Roman Republics, fo that, as well Our Fleet and Ships, as also all other Ships and Vessels that shall be commissionated by Letters of Marque or General Reprifals, or otherwife, by Our Commissioners for executing Our Office of Lord High Admiral of Great Britain, shall and may lawfully feize all Ships and Goods belonging to the faid Persons, and bring the same to Judgment in any of Our Courts of Admiralty within Our Dominions: We, being desirous to give due Encouragement to all Our faithful Subjects who may have lawfully feized any fuch Ships or Goods sub-fequent to the faid Twenty-eighth Day of September One thousand seven hundred and ninetyeight, or who shall hereafter seize such Ships or Goods (fave and except as to fuch Ships and Goods belonging to Persons inhabiting the Territories of the Pope, which may have been seized subsequent to the Twenty-seventh Day of September One. thousand seven hundred and ninety-nine, or which shall hereafter be seized,) and having declared in Council Our Intentions concerning the Distribution of all Manner of Captures, Seizures, Prizes, and . Reprifals of all fuch Ships and Goods already seized, or which shall be seized as aforesaid, do now make known to all Our loving Subjects, and all others

whom it may concern, by this Our Proclamation by and with the Advice of Our Privy Council, that Our Will and Pleasure is, that the neat Produce of all fuch Ships and Goods already taken or which shall be taken as aforesaid, the Right whereof is inherent in Us and Our Crown, be given to the Takers (save and except as aforesaid); and also, fave and except the Produce of fuch Prizes as are or shall be taken by Ships or Vessels belonging to Our Commissioners of Customs or Excise, the Disposition of which We reserve to Our further Pleafure, but subject to the Paymentof all such or the like Customs and Duties as the same are now, or would have been liable to, if the same were or might have been imported as Merchandize; and that the same may be so given in the Proportion and Manner hereinafter fet forth; that is to say, That all Prizes taken by Ships and Vessels having Commissions of Letters of Marque and Reprisals, (fave and except such Prizes as are or shall be taken by the Ships or Vessels belonging to Our Commissioners aforesaid,) may be sold and disposed of by the Merchants, Owners, Fitters, and others, to whom such Letters of Marque and Reprisals are granted, for their own Use and Benefit, after final Adjudication, and not before; and We do hereby further order and direct, That the neat Produce of all Prizes which are or shall be taken as aforesaid by any of Our Ships or Veffels of War, shall be for the entire Benefit and Encouragement of Our Flag Officers, Captains, Commanders, and other Commiffioned Officers in Our Pay, and of the Seamen, Marines, and Soldiers, on board Our faid Ships and Vessels at the Time of the Capture; and that fuch Prizes may be lawfully fold and disposed of by them and their Agents, after the same shall have been to Us finally adjudged lawful Prize, and not otherwise. The Distribution shall be made as follows; the Whole of the Neat Produce being first divided into Eight equal Parts:

The Captain or Captains of any of Our faid Ships or Veffels of War, who shall be actually on board at the taking of any Prize, shall have Three Eighth Parts; but in case any such Prize shall be taken by any of Our Ships or Vessels of War, under the Command of a Flag or Flags, the Flag Officer or Officers, being actually on board or directing and affifting in the Capture, shall have One of the faid Three Eighth Parts; the faid One Eighth Part to be paid to fuch Flag or Flag Officers in fuch Proportions, and Subject to fuch Regulations as are hereinafter-mentioned: The Captains of Marines and Land Forces, Sea Lieutenants, and Master on board, shall have One Eighth Part, to be equally divided amongst them: but that every Physician appointed, or hereafter to be appointed to a Fleet or Squadron of Our Ships of War, shall, in the Distribution of Prizes which are or shall be taken as aforesaid by the Ships in which he shall serve, or in which such Ship's Company shall be entitled to share, be classed with the Sea Lieutenants with respect to the faid One Eighth Part, and he allowed to share equally with them: provided such Physician be actually on board at the Time of taking of such

The Lieutenants and Quarter-Masters of Marines, and Lieutenants, Ensigns, and Quarter Masters

of Land Forces, Secretaries of Admirals or of Commodores, with Captains under them, Boat-fwains, Gunners, Purser, Carpenter, Master's Mates, Chirurgeon, Pilot, and Chaplain on board, shall have One Eighth Part, to be equally divided amongst them:

The Midshipmen, Captain's Clerk, Master Sailmaker, Carpenter's Mates, Boatswain's Mates, Gunner's Mates, Mafter at Arms, Corporals, Yeomen of the Sheets, Cockfwain, Quarter-Mafters, Quarter-Mafters Mates, Chirurgeon's Mates, Yeomen of the Powder-Room, Serjeants of Marines, and Land Forces on board, shall have One Eighth Part, to be equally divided amongst

The Trumpeters, Quarter-Gunners, Carpenter's Crew, Steward's Cook, Armourer, Steward's Mate, Cook's Mate, Gunsmith, Cooper, Swabber, Ordinary Trumpeter, Barber, Able Seamen, Ordinary Scamen, and Marines and other Soldiers, and all other Perfons doing Duty and affilling on board, shall have Two Eighth Parts, to be

equally divided amongst them.

Provided, That if any Officer being on board any of Our Ships of War at the Time of taking any Prize, shall have more Commissions or Offices than One, fuch Officer shall be entitled only to the Share or Shares of the Prizes which, according to the abovementioned Diffribution, shall belong to his Superior Commission or Office. And We do hereby strictly enjoin all Commanders of our Ships and Vessels of War taking any Prize, as soon as may be, to transmit, or cause to be transmitted to the Commissioners of Our Navy, a true List of the Names of all the Officers, Seamen, Marines, Soldiers, and others, who were actually on board Our Ships and Vessels of War under their Command at the Time of the Capture; which List shall contain the Quality of the Service of each Person on board, and be subscribed by the Captain or Commanding Officer, and Three or more of the Chief Officers on board. And We do hereby require and direct the Commissioners of Our Navy, or any Three or more of them, to examine, or cause to be examined, fuch Lifts by the Muster Books of fuch Ships and Vessels of War, and Lists annexed thereto, to see that fuch Lists do agree with the faid Muster Books and annexed Lists, as to the Names, Qualities, or Ratings of the Officers, Seamen, Marines, Soldiers, and others belonging to such Ships and Vessels of War, and upon Request forthwith to grant a Certificate of the Truth of any List transmitted to them, to the Agents nominated and appointed by the Captors to take Care and dispose of such Prize; and also upon Application to them (the said Com-missioners) they shall give, or cause to be given to the faid Agents, all fuch Lifts from the Muster Books of any such Ships of War, and annexed Lists, as the said Agents shall find requisite for their Direction in paying the Produce of such Prizes, and otherwise shall be aiding and affisting to the said Agents in all such Matters as shall be necessary. We do hereby further will and direct, necessary. We do hereby further will and direct, that the following Regulations shall be observed concerning the One Eighth Part hereinbefore mentioned to be granted to the Flag or Flag Officers who shall actually be on board at the taking of any Prize, or shall be directing or affishing therein: First,

That a Flag Officer, Commander in Chief, when there is but One Flag Officer upon Service, shall have to his own Use the said One Eighth Part of the Prizes taken by Ships and Vessels under his Command: Secondly, That a Flag Officer sent to command at Jamaica, or elsewhere, shall have no Right to any Share of Prizes taken by Ships or Vessels employed there, before he arrives at the Place to which he is fent, and actually takes upon him the Command: Thirdly, That when an inferior Flag Officer is fent out to reinforce a superior Flag Officer at Jamaica, or elsewhere, the superior Flag Officer shall have no Right to any Share of Prizes taken by the inferior Flag Officer before the inferior Flag Officer shall arrive within the Limits of the Command of the superior Flag Officer, and actually receive some Order from him: Fourthly, That a Chief Flag Officer returning Home from Jamaica, or elsewhere, shall have no Share of the Prizes taken by the Ships or Vessels left behind to act under another Command: Fifthly, That if a Flag Officer is fent to command in the Out-Ports of this Kingdom, he shall have no Share of the Prizes taken by Ships or Vessels, which have sailed from that Port by Order of the Admiralty: Sixthly, That when more Flag Officers than One ferve together, the Eighth Part of the Prizes taken by any Ships or Vessels of the Fleet or Squadron, shall be divided in the following Proportions; viz. if there be but Two Flag Officers, the Chief shall have Two Third Parts of the said One Eighth Part, and the other shall have the remaining Third Part; but if the Number of Flag Officers be more than Two, the Chief shall have only One Half, and the other Half shall be equally divided amongst the other Flag Officers: Seventhly, That Commodores with Captains under them shall be esteemed as Flag Officers with respect to the Eighth Part of Prizes taken, whether commanding in Chief or ferving under Command: Eighthly, That the First Captain to the Admiral and Commander in Chief of Our Fleet, and also the First Captain to Our Flag Officer appointed, or hereafter to be appointed, to command a Fleet or Squadron of Twenty Ships of the Line of Battle, and also the First Captain to Our Flag Officer appointed, or hereafter to be appointed, to command a Fleet or Squadron of Fifteen Ships of the Line of Battle, (provided such last mentioned Fleet or Squadron shall be composed of His Majesty's own Ships,) shall be deemed and taken to be a Flag Officer, and shall be entitled to a Part or Share of Prizes, as the junior Flag Officer of fuch Fleet or Squadron: and We do hereby further order, That in the case of Cutters, Schooners, and other Armed Vessels commanded by Lieu-tenants, the Share of such Lieutenants shall be Three Eighth Parts of the Prize, unless such Lieutenants shall be under the Command of a Flag Officer or Officers; in which Case the Flag Officer or Officers shall have One of the said Three Eighths, to be divided among such Flag Officer or Officers, in the Manner hereinbefore directed in the Case of Master or other Person acting as Second in Command, and the remaining One Third to the Pilot; but if there is no Pilot, then fuch Eighth Part to go wholly to the Master or Person acting as Second in Command: that the Share of the Chirurgeon, or Chirurgeon's Mate, (where there is no Chirurgeon,) Midshipmen, and Clerk and Steward, shall be One Eighth; that the Share of the Boat-Iwain's, Gunner's, and Carpenter's Mates, Yeomen of the Sheets, Sailmaker, Quarter-Master, and Quarter-Master's Mate, shall be One Eighth; and the Share of the Seamen, Marines, and other Persons on board affifting in the Capture, shall be Two Eighth But it is Our Intention, nevertheless, that the above Distribution shall only extend to such Captures as shall be made by any Cutter, Schooner, or Armed Vessel, without any of His Majesty's Ships or Veffels of War being present or within Sight of, and aiding to the Encouragement of the Captors, and Terror of the Enemy: but in case any of His Majesty's Ships or Vessels of War shall be present, or in Sight, that then the Officers, Pilots, Petty Officers, and Men on board such Cutters and Schooners, or Armed Vessels, shall share in the same Proportion as is allowed to Persons of the like Rank and Denomination, on board His Majesty's Ships and Vessels of War.

AT the Court at St. James's, the 12th of February 1800,

WHEREAS by an Act passed in the Twentyeighth Year of the Reign of His present Majefty, intituled, "An Act for regulating the Trade between the Subjects of His Majesty's Colonies " and Plantations in North America, and in the " West India Islands, and the Countries belonging sto the United States of America, and between His "Majesty's said Subjects and the Foreign Islands in the West Indies," It is, amongst other Things, enacted, That it shall and may be lawful for his Majelty in Council, by Order or Orders to be iffued and published from Time to Time, to authorite, or by Warrant or Warrants, under his Sign Manual, to empower the Governor of Newfoundland for the Time being to authorife, in case of Necessity, the Importation into Newfoundland of Bread, Flour, Indian Corn, and Live Stock, from any of the Territories belonging to the faid United States, for the Supply of the Inhabitants and Fishermen of the Island of Newfoundland, for the then enfuing Season only; provided always, that fuch Bread, Flour, Indian Corn, and Live Stock, To authorised to be imported into the Island of Newfoundland, shall not be imported except in conformity to such Rules, Regulations, and Restrictions as shall be specified in such Order or Orders, Warrant or Warrants, respectively, and except by British Subjects and in British-built Ships, owned by

that Provision be made for fully supplying the Inhabitants or Fishermen of the Island of Newfoundland, for the ensuing Season, with Bread, Flour, Indian Corn, Rice, and Live Stock; His Majesty doth thereupon, by and with the Advice of His Privy Council, hereby order and declare, That, for the Supply of the Inhabitants and Fishermen of the Island of Newfoundland, for the ensuing Season only, Bread, Flour, Indian Corn, Rice, and Live Stock may be imported into the faid Island from any of the Territories belonging to the faid United States, by British Subjects, and in British-built Ships, owned by His Majesty's Subjects, and navigated accord-ing to Law, and which shall, within the Space of Seven Months previous to the Time of fuch Importation, have cleared out from some Port in Great Britain, or some other Port of His Majesty's Dominions, in Europe, for which Purpose a Licence shall have been granted by the Commissioners of His Majesty's Customs in England or Scotland, or the Commissioners of His Majesty's Revenue in Ireland, or any other Person or Persons who may be duly authorised in that Kingdom respectively, in the Manner and Form hereinafter mentioned; which Licence shall continue and be in Force for Seven Calendar Months from the Day of the Date upon which fuch Licence is respectively granted, and no longer; provided that no fuch Licence as aforesaid, granted after the Thirtieth Day of September next, shall be of any Force or Effect: And His Majesty is hereby further pleafed to order, That the Master, or Person having the Charge or Command of any Ship or Veffet to whom fuch Licence shall be granted, shall, upon the Arrival of the faid Ship or Vessel at the Port, Harbour, or Place in the Island of Newsoundland, where he shall discharge such Bread, Flour, Indian Corn, Rice, and Live Stock, deliver up the faid Licence to the Collector or other proper Officer of the Customs there, having first indorsed on the Back of fuch Licence the Marks, Numbers, and Contents of each Package of Bread, Flour, or Indian Corn, Rice, and the Number of Live Stock, under the Penalty of the Forfeiture in the faid Act mentioned. And the Collector or other proper Officer of the Customs at Newfoundland is hereby enjoined and required to give a Certificate to the Mafter, or Person having the Charge or Command of such Ship or Veffel, of his having received the faid Licence, fo indorfed as before directed, and to transmit the same to the Commissioners of His Majesty's Customs in England or Scotland, or to the Commissioners of His Majesty's Revenue in Ireland, respectively, by whom such Licence was granted. Now be it known, That the faid [Perfon's Name] hath Licence to lade on board the faid Ship [Ship's Name] at and from any Port or Place belonging to the United States of America, Bread, Flour, Iudian Corn, Rice, and Live Stock, the Produce of the faid United States, and no other Article-whatever, and to carry the faid Bread, Flour, Indian Corn, Rice, and Live Stock to some Port or Place in the Island of Newfoundland: and on the Arrival of the said Ship at any Port, Harbour, or Place of Discharge in Newfoundland, the Master, or Person having the Charge or Command of the faid Ship, is required and enjoined to deliver up the faid Licence to the Collector or other proper Officer of His Majefty's Customs there, and to endorse on the Back thereof the Marks, Numbers, and Contents of each Package of Bread, Flour, or Indian Corn, Rice, and the Number of Live Stock, and shall thereupon receive a Certificate thereof from the faid Collector or other proper Officer of the Customs.

The KING's Most Excellent Majesty in Council. HEREAS by an Act passed in the Thirty-ninth Year of His Majesty's Reign, inti-tuled "An Act to allow the Importation of Spa-"nish Wool in Ships belonging to Countries in Amity with His Majesty," reciting that by an Act passed in the Thirty-third Year of His Majelly's Reign, to prevent Traiterous Correspondence with His Majesty's Enemies, and by several subsequent Acts Trade and Intercourse was prohibited between Great Britain and the Countries in Hostility with His Majesty, unless such Trade and Intercourse should be specially permitted by His Ma-jesty's Licence and Authority; and also reciting, that, for the Encouragement of the Manufactures of this Country, it was expedient to permit the Importation of Spanish Wool from any Place whatever in Ships or Vessels belonging to any Kingdom or State in Amity with His Majesty, it was enacted that it should be lawful to and for any Person or Persons to import into this Kingdom Spanish Wool from any Port or Place whatever, in Foreign Parts, in any Ship or Vessel belonging to any Kingdom or State in Amity with His Majesty, any Thing in the faid Act passed in the Thirty.

third Year of the Reign of His present Majesty, or any other Act or Acts of Parliament to the con-

trary in anywife notwithstanding.

And whereas Doubts have arisen, whether, according to the true Construction of the said Act of the Thirty-ninth Year of His Majesty's Reign, His Majesty's Subjects are thereby authorised to purchase and import Spanish Wool under Circumstances which would make the same liable to capture, as the Property of Subjects of His Majesty trading with the Enemy, unless the Licence of His Majesty should be first obtained for that Purpose: His Majesty, by and with the Advice of His Privy Council, is pleased to order, and it is hereby ordered, that it shall be lawful for any of His Majesty's Subjects to purchase and import into this Kingdom any Spanish Wool, in any Ship or Vessel belonging to any Kingdom or State in Amity with His Majelly, notwithstanding the Purchase and Importation thereof, may be deemed a trading with His Majelty's Enemics, and notwithstanding the same might be liable to Capture as the Property of His Majesty's Subjects trading with the Enemy, in case this Order had not been made.

Fawkener. fpectively appertain.

F any Person shall contract with, entice, or solicit, any Artificer in Wool, Iron, Steel, Brass, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries out of the King's Dominions, and shall be convicted thereof, upon Indictment or Information in any of the Courts at Westminster, or at the Affizes or Quarter Seffions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Perfon having been once convicted shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be-

If any of the King's Subjects, being such Artificers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the said Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercising my of the said Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister, or Consul of Great Britain, in the Country where fuch Artificers shall be, or by any Person authorised by such Ambassador, &c, or by one of the Secretaries of State, and fromhenceforth inhabit within this Realm; fuch Persons shall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Descent, Devise, or Purchase, and shall forfeit all Lands. Goods, &c. within this Kingdom, to His Majesty's-Use, and shall be deemed Alien, and out of His-

Majesty's Protection. Upon Complaint made, upon Oath, before any Justice of Peace, that any Person is endeavouring to seduce any such Artificer, or that any such Artificer hath contracted or is preparing to go out of His Majesty's Dominions, for the Purposes aforefaid, such Justice may fend his Warrant to bring the Person complained of before him, or before jome other Justice; and if it shall appear by the Oath of One Witness, or by Confession, that he was guilty of any of the faid Offences, fuch Justice may bind him to appear at the next Affizes or Quarter Seffions: And if fuch Person shall refuse to give Security, the Justice may commit him to Gaol till the next Affizes or Quarter Seffions, and until he shalk Sherwood, refigned. Dated February 12, 1800. The delivered by due Course of Law. And if any fuch Artificer shall be convicted, upon Indiffment, of any such Promise, Contract, or Preparation to go beyond the Seas, for the Purpose aforesaid, he shall give such Security to the King not to depart out of His Majesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security given.

IF any Person shall contract with, or endeavour to seduce any Artificer in Wool, Mohair, Cotton, or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland into any Foreign Country not within the Dominions of the Crown of Great Britain, and shall be convicted, upon In-dictment, or Information, in the Kings Bench at Westminster, or by Indictment at the Assizes or General Gaol Delivery for the County, &c. wherein such Offence' shall be committed in England, or by Indictment in the Court of Justiciary or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Dublin, if such Offence be committed in Ireland; the Person so convicted shall, for every Artificer contracted with or feduced, forfeit FIVE HUNDRED POUNDS, and shall suffer Imprifonment in the Common Gaol of the County or Stewartry wherein such Offeuder shall be convicted for Twelve Calendar Months, and until Forfeiture be paid: And in case of a subsequent Offence of the fame Kind, the Persons so again offending shall fusfer Imprisonment in the Common Gaol of the County or Stewartry wherein such Offender shall be convicted, for Two Years, and until such Forfeiture be paid.

If any Person in Great Britain or Ireland shall put on board any Ship or Boar, not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any such Tools or Utensils as are commonly used in, or proper for the Preparing, Working up, or Finishing of the Woellen or Silk Manusactures, or any Part of such Tools, he shall, for every Oftence, forfeit all such Tools, or Parts thereof, put on board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Seffici in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Essoin, &c. shall be

allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Majesty's Warehouses, all such Tools or Utensils prohibited to be exported, as such Officer shall find on board any Vessel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all Tools so seized shall, after Condemnation, be publicly sold to the best Bidder; and one Moiety of

the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize and secure the same:

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the said Tools, prohibited to be exported, to be put on board his Vessel, he shall, for every such Osserce, forfeit ONE HUNDRED POUNDS, to be recovered as the Penalties inslicted upon Persons exporting the Tools; and, if the Vessel belongs to His Majesty, the Captain shall not only forseit ONE HUNDRED POUNDS, but shall also forseit his Employment, and be incapable of any Employment under His Majesty.

If any Officer of the Customs in Great Britain or of the Revenue in Ireland, take, or knowingly suffer to be taken, any Entry outward, or sign any Cocket or Susserance for the Shipping or Exporting of any of the said Tools, or knowingly suffer the same to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforesaid, and also forfeit his Office, and be incapable of any Office

under His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the same.
