The KING's Most Excellent Majesty in Council. HEREAS the Time limited by His Majesty's Order in Council of the Thirtieth Day of October last, prohibiting the Exportation out of this Kingdom of any Sort of Rock Salt, will expire upon the Twenty-ninth Day of this instant April; And whereas it is judged expedient that the faid Prohibition should be continued for some Time longer, His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Person or Persons whatfoever do, at any Time, during the Space of Six Months, to commence from the faid Twentyninth Day of this instant April, export, or attempt to export, transport, carry or convey, or load or lay on board of any Ship, Veffel, or Boat, in order to be exported; transported, carried, or conveved out of any Port or Place in Great Britain, any Sort of Rock Salt whatfoever, without Leave of Permillion being first had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act passed in the Thirty fixth Year of His present Majesty's Reign, intituled " An Act for indemnifying all Persons " who have been concerned in adviting or carrying " into Execution an Order of His Majesty in " Council respecting the Exportation of Rock Salt, for preventing Suits in consequence of the " fame, for authoriting His Majesty to prohibit the " Exportation or carrying Coastwife of Rock Salt, and for making further Provisions relative there-" to:" His Majesty, nevertheless, by the Advice aforesaid, hath thought fit to order, that nothing herein contained shall prevent Rock Salt being carried Coastwife, under the usual Rules, Regulations, and Restrictions, nort he Exportation of the same

T the Court at St. James's, the 23d of April to Ireland, or to any other of His Majesty's Dominions, under the ufual Conditions and Regulations, and upon Security being given by the Exporter, and Two other Persons, (of whom the Master of Veffel shall be one,) by Bond, in such Penalty as shall be directed by the Commissioners of His Majesty's Customs, that the said Rock Salt shall be exported to some Port or Place in His Majesty's Dominions, and none other, and that a Certificate shall be produced, within Six Months from the Date of the Bond, if such Rock Salt shall be entered out for any Part of His Majesty's Dominions in Europe; and within Twelve Months, if for any Part of His Majesty's Dominions in America or the West Indies; and within Eighteen Months, if for any of the British Settlements or Factories in Asia or Africa, under the Hand of the Principal Officer of the Customs at the Port or Place where fuch Rock Salt shall be so landed; and if there shall be no Officer of the Customs, then under the Hand of the Chief Magistrate of the Place, tellifying that the faid Rock Salt has been duly landed at the Port or Place for which the fame was entered out.—And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Lords Commissioners of the Admiralty, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein as to them may respectively appertain.

Copy of a Letter from Mr. James Le Bair, Commander
of the Mayflower Private Ship of War, to Evan Nepean, Esq; dated at Guernsey the 17th Instant.

Have the Honor to acquaint you, for their Lordships' Information, that on the 8th Instant, Cape Penas, at Ten A. M. bearing S. W. Distance about Five Leagues, faw a Schooner on our Lee Beam standing to the Northward; at Noon perceived faid Schooner to tack and flanding for us; shortly after which she tacked again and stood off, we continuing to chace her; at Five P. M. came within a League of her, and shewed her our Colours, which she anfwered by hoisting the National Flag; at Eight it fell calm, in consequence of which we got out Sweeps and stood for her till Midnight: on the 9th, at Two A. M. lost Sight of her; at Five discovered her about Four Miles a-head, the Weather continuing to be calm; at Nine a Breeze fprung up, when we set Sail after her; at Three P. M. came within Gun-Shot of her, the always attempting to get off; at half past Three the took in Sail and hove to; at Four came a-breast of her within Musket-Shot, when we attacked and continued to enagage her for the Space of Five Hours, without altering our Polition; when she struck, and proved to be Le Troisieme Ferrailleur Privateer, belonging to Bourdeaux, commanded by François Lugeol, mounting Two Twelve-Pound Carronades and Twelve long Four-Pounders, Six of which are Brass, and manned with Sixty-eight Men, Three of whom were killed and Five wounded during the Action. Our Loss confisted in One Man killed and Four wounded.

This Schooner is about One Hundred and ninety Tons Measurement, quite new and coppered, had been Forty Days from Bourdeaux, during which Time she had captured the American Schooner Active, Jonathan Holbrook, Master, bound from Liverpool to Boston, and a Brig from Teignmouth to Newfoundland, which she burnt. Besides this I captured several Vessels during my Crusse, a List of which I have the Honor to subjoin, and remain, Sir, &c. &c. &c.
