PRESENT,

The KING's Most Excellent Majesty in Council. WHEREAS the Time limited by His Ma-jefty's Order in Council of the Thirtieth Day of October last, prohibiting the Exportation out of this Kingdom of any Sort of Rock Salt, will expire upon the Twenty-ninth Day of this instant April; And whereas it is judged expedient that the faid Prohibition should be continued for some Time longer, His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Person or Persons whatfoever do, at any Time, during the Space of Six Months, to commence from the faid Twenty-ninth Day of this inflant April, export, or attempt to export, transport, carry or convey, or load or lay on board of any Ship, Vessel, or Boat, in order to be exported, transported, carried, or conveyed out of any Port or Place in Great Britain, any Sort of Rock Salt whatsoever, without Leave or Permission being first had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act passed in the Thirty-sixth Year of His present Majesty's Reign, intituled " An Act for indemnifying all Persons "who have been concerned in advising or carrying into Execution an Order of His Majesty in Council respecting the Exportation of Rock "Salt, for preventing Suits in confequence of the fame, for authoriting His Majesty to prohibit the Exportation or carrying Coastwife of Rock Salt, and for making further Provisions relative theresto:" His Majesty, nevertheless, by the Advice aforesaid, hath thought fit to order, that nothing herein contained shall prevent Rock Salt being carried Coastwife, under the usual Rules. Regulations ried Coastwife, under the usual Rules, Regulations, and Restrictions, nor the Exportation of the same to Iteland, or to any other of His Majesty's Dominions, under the usual Conditions and Regulations, and upon Security being given by the Exporter, and Two other Persons, (of whom the Master of Vessel shall be directed by the Commissioners of His Master of His M jesty's Customs, that the said Rock Salt shall be ex-

ported to some Port or Place in His Majesty's Dominions, and none other, and that a Certificate shall be produced, within Six Months from the Date of the Bond, if such Rock Salt shall be entered out for any Part of His Majesty's Dominions in Europe; and within Twelve Months, if for any Part of His Majesty's Dominions in America or the West Indies; and within Eighteen Months, if for any of the British Settlements or Factories in Asia or Africa, under the Hand of the Principal Officer of the Customs at the Port or Place where fuch Rock Salt shall be so landed; and if there shall be no Officer of the Cuftoms, then under the Hand of the Chief Magistrate of the Place, testifying that the said Rock Salt has been duly landed at the Port or Place for Which the fame was entered out .- And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Lords Commissioners of the Admiralty, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein as to them may respectively appertain.

Admiralty-Office, April 29, 1800. Copy of a Letter from Vice-Admiral Dickson, Commander in Chief of His Majesty's Ships and Vessels in Yarmouth Roads, to Evan Nepean, Esq; dated the 27th April 1800.

SIR, **B**E pleafed to acquaint my Lords Commissioners of the Admiralty, that His Majesty's Hired Armed Lugger Lark, commanded by Lieutenant Wilson, arrived Yesterday in these Roads, and brought with him the Impregnable French Cutter Privateer of Fourteen Guns, which he boarded and took after an Hour's Action: while the Cutter was on Shore she was supported by the Fire of about One Hundred of the Enemy's Troops from behind-Sand Banks.

I enclose, for their Lordships' Information, Lieutenant Wilson's Letter to me on the Subject. Activity and Zeal of this Officer has destroyed one of the greatest Pells that infested this Coast; the Impregnable had been particularly successful during her former Cruises. ARCHIBALD DICKSON.

His Majefly's Hired Armed Lugger Lark, SIR, Tarmouth-Roads, April 26, 1800. Have the Honor to acquaint you, that I anchored in these Roads this Day with His Majesty's Armed Lugger Lark under my Command, with a French Cutter Privateer her Prize.

In pursuance of your Order I failed on the 19th | Instant, and took my Station off the Vlie Passage on the 21st at Half past Six A. M. At the Entrance of that Passage I discovered a French Cutter Privateer in Shore of me, which I chased and came up with, and who, after exchanging a few Shot, ran on Shore. I am forry to add I was not able to get Men enough to him, as totally to destroy him: a Neutral Vessel that came out of the Vlie Passage the 23d Instant, informed me she mounted Ten Guns, and had Thirty-fix Men on board; and that he had, after getting off proceeded to the Texel Road by the Inner Navigation.

On the 25th at Two P. M. I chased and came up with a French Cutter Privateer, who, after engaging me a little while, ran on Shore on the Vlie Island, where he defended himself pretty well for an Hour, when I perceived his Men were escaping to the Shore under the Cover and Protection of Troops to the Amount of about an Hundred. I immediately hoisted out my small Boat, and directed my larger one to follow, and, under the Fire of the Musketry from the Troops on Shore, boarded her, but not until the Crew had escaped: in our Endeavours to get the Cutter off we were confiderably annoyed by the Fire from the Troops; but having detached the large Boat further in Shore, I succeeded in dislodging them from the Sand Bank, behind which they had taken Shelter, and I was fortunate enough to get the Privateer off. She is called the Impregnable, mounts Fourteen Guns, Twelve of which are Three-Pounders, and Two are Nine-Pounders. She had on board during the Engagement about Sixty Men, as appears by her Log; and it also appears she had been particularly fuccessful during her former Cruizes. Lark has suffered in her Hull and Rigging, but fortunately had no Man killed or wounded:-Enemy we have Reason to suppose, from the State of the Vessel, suffered considerably; and several Men were killed on the Beach. I cannot speak too highly of Mr. Thomas Gettins the Master, as also the good Conduct and Bravery of the Crew of

As several Artificers and Manufacturers, Subjects of Great Britain, have, from Time to Time, gone into Foreign Countries to exercise their several Callings, contrary to the Laws of these Kingdoms, the following Abfracts of Acts of Parliament of Their late Majesties King George the First and Second, and of His present Majesty, for preventing such Practices, are published, for the Information of all Persons who may be ignorant of the Penalties they may incur by Disobedience to them: And it will be observed, that fuch Penalties likewise extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well as to the Artisicers or Manufacturers themselves.

Statute 5 George I. Chap. 27. F any Person shall contract with, entice, or solicit, I any Artificer in Wool, Iron, Steel, Brass, or Great Britain, and shall be convicted, upon Inother Metal, Clock-maker, Watch-maker, or any dictment or Information, in the Kings Bench at

other Artificer of Great Britain, to go into Foreign Countries out of the King's Dominions, and shall be convicted thereof, upon Indictment or Information in any of the Courts at Westminster, or at the Affizes or Quarter Seffions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Perfon having been once convicted shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be

paid.

If any of the King's Subjects, being such Artificers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the said Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercising ny of the said Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister, or Consul of Great Britain, in the Country where such Artificers shall be, or by any Person authorised by such Ambassador, &c. or by one of the Secretaries of State, and from henceforth inhabit within this Realm; fuch Persons shall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Descent, Devise, or Purchase, and shall forfeit all Lands, Goods, &c. within this Kingdom, to His Majesty's Use, and shall be deemed Alien, and out of His Majesty's Protection.

Upon Complaint made, upon Oath, before any Justice of Peace, that any Person is endeavouring to seduce any such Artiscer, or that any such Artificer hath contracted or is preparing to go out of His Majesty's Dominions, for the Purposes afore-said, such Justice may send his Warrant to bring the Person complained of before him, or before Jome other Justice; and if it shall appear by the Oath of One Witness, or by Confession, that he was guilty of any of the faid Offences, such Justice may bind him to appear at the next Affizes or Quarter Seffions: And if fuch Person shall refuse to give Security, the Justice may commit him to Gaol till the next Assizes or Quarter Sessions, and until he shall be delivered by due Course of Law. And if any such Artificer shall be convicted, upon Indictment, of any fuch Promise, Contract, or Preparation to go beyond the Seas, for the Purpose aforesaid, he shall give fuch Security to the King not to depart out of His Majesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security

If any of the above Offences shall be committed in Scotland, the same shall be prosecuted in the Court of Justiciary or the Circuits there.

Statute 23 George II. Chap. 13.

IF any Person shall contract with, or endeavour to seduce any Artiscer in Wool, Mohair, Cotton, or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland into any Foreign Country not within the Dominions of the Crown of Great Britain, and shall be convicted, upon InWestminster, or by Indictment at the Assizes or General Gaol Delivery for the County, wherein such Offence shall be committed in England, or by Indictment in the Court of Justiciary or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Dublin, if such Offence be committed in Ireland; the Person so convicted shall, for every Artificer contracted with or feduced, forfeit FIVE HUNDRED POUNDS, and shall suffer Impriforment in the Common Gaol of the County or Stewartry wherein fuch Offeuder shall be convicted for Twelve Calendar Months, and until Forfeiture be paid: And in case of a subsequent Offence of the same Kind, the Persons so again offending shall forfeit, for every Person contracted with or seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein fuch Offender shall be convicted, for Two Years, and until fuch Forfeiture be paid.

If any Person in Great Britain or Ireland shall put on board any Ship or Boat, not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any such Tools or Utenfils as are commonly used in, or proper for the Preparing, Working up, or Finishing of the Woollen or Silk Manufactures, or any Part of fuch Tools, he shall, for every Of-fence, forfeit all such Tools, or Parts thereof, put on board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Session in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Essoin, &c. shall be

allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to feize and fecure, in some of His Majesty's Warehouses, all such Tools or Utensils prohibited to be exported, as fuch Officer shall find on board any Veffel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all Tools so feized shall, after Condemnation, be publicly fold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall feize and fecure the fame.

If the Captain of any Veffel in Great Britain or Ireland knowingly permit any of the faid Tools, prohibited to be exported, to be put on board his Vessel, he shall, for every such Offence, forfeit ONE HUNDRED POUNDS, to be recovered as the Penalties inflicted upon Persons exporting the Tools; and, if the Vessel belongs to His Majesty, the Captain shall not only forfeit ONE HUNDRED POUNDS, but shall also forfeit his Employment, and be incapable of any Employ-

ment under His Majesty.

If any Officer of the Customs in Great Britain or of the Revenue in Ireland, take, or knowingly fuffer to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting of any of the faid Tools, or knowingly fuffer the fame to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforefaid, and also

forfeit his Office, and be incapable of any Office under His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the

Statutes 14, 21, 25, and 26 of His prefent Majesty. BY these Statutes the like Penalties and Forfeitures as above-mentioned are extended to Persons packing or putting on board any Vessel, not bound directly for some Port in Great Britain or Ireland, any Machine, Engine, Tool, Press, Paper, Utensil, or Implement whatfover, used in or proper for the working or finishing of the Cotton, Steel, or Iron Manufactures of this Kingdom, or any Part or Parts of fuch Machines or Implements, or any Models or Plans thereof; and all Captains of Ships and other Persons receiving or being in Possession of any such Articles, with an Intent to export the same to Foreign Parts, and all Custom-house Officers suffering an Entry to be made thereof, are respectively liable to the like Penalties as are above-mentioned, in the case of Tools and Utensil, used in the Woollen and Silk Manufactures.
