

concerning the Title of Duke of *Burgundy*, in which he has the more reason to persuade himself that they will be successful, seeing that he cannot but believe, that the most Christian King has been ill informed of the Right he has been told to have, to this new pretension, make founded upon the Treaty of *Nimeguen*, and the Cession thereby stipulated of the *Franche-Comte*; for, that that County never has had any thing of common with the Dutchy of *Burgundy*, and the King of *Spain's* Powers for the Treaty of *Nimeguen*, the Ratification of the Peace, and those for his Marriage, bore the Title of Duke of *Burgundy*, notwithstanding; the French made an exception to it; and that the States may be better informed in this matter; the said Envoye adds to the said Memorial, the Articles of several Treaties between the two Crowns, from the time of the Emperor *Charles* the V. that concerns the said Dutchy of *Burgundy*.

Paris, July 13. This day the King parted from *St. Germain's* with the Queen, the Dauphiness, and the other Ladies of the Court, for *Flanders*. Its said the Ladies will go no farther than *Cambray*. There seems to be but little appearance as yet, of accommodating the differences with the Court of *Rome*; and we are told, that the King has ordered, that all Couriers that come from thence, shall be stoppt at *Lions*. It is said, that the King has prolonged the term, which was sett the Spaniards, to declare themselves in, concerning the Title of Duke of *Burgundy*, for a month or six weeks.

Kinsale, June 22. The *Garland* Frigate, and the *Ruby* are now in this Harbor, being to take on board some Companies of the Earl of *Dumbartons* Regiment, and to carry them to *Tangier*; the rest of the Frigates appointed for that service, are hourly expected. This morning sailed the *Constant Warwick* to cruise.

Edenburg, June 30. About three weeks since Mr. *Donald Cargile*, a Preacher in the Field Conventicles, and Mr. *Hall* (who were both actually in the late Rebellion) being taken at *Queensferry*, there was found in their Portmantles, among other Treasonable and Seditious Papers, the draught of a new Covenant, by which they swear, To advance the Kingdom of Christ, and the true Reformed Religion; to extirpate Kingly Government and Prelacy, &c. which being brought before the Council, while their Lordships were searching into this Matter, a yet more execrable Paper was sent to them by General *Dalke*, being a Declaration, which was the 22 of this month Published and Affixed, after a solemn Procession, and Singing of Psalms, by 21 persons on the Cross at *Sanchar*, wherein they Declare, That for themselves, and all that will adhere to them, as the Representatives of the True Presbyterian Church, and Covenanted Nation of Scotland, They do disown *Charles Stewart*, who has been Reigning, or rather Tyrannizing, on the Throne of Brittain these years past, as having any Right or Title to, or Interest in the Crown of Scotland, or Government, as forfeited several years since, by His Perjury, and breach of Covenant with God and his Church, and Usurpation of His Crown, and Royal Prerogatives therein, &c. The General has likewise informed the Council, that he has discovered, that there is a Party of these Rebels, to the

number of about 70 in Arms, and that he has sent out several Parties in search of them, in order to the Apprehending and bringing them to condign punishment.

Plymouth, July 4. On Friday last arrived in this Port, the *Charles* Galley, and the *Swan* Frigate from the *Streights*; on board the First, Was the Earl of *Chiquin*, late Governor of *Tangier*. This morning arrived another of the Kings Ships, being Convoy to several Merchant Ships, bound home from *Smirna*, and other places, which are pass by to the Eastward.

Deal, July 4. Yesterday came into the Downs, the *London*, the *Bangale*, and the *Ann* from the *East Indies*.

Deal, July 6. Yesterday in the afternoon, came into the Downs, Three Merchant Ships; and last night, and this morning, 18 sail more; bound home from *Turkey*, and other parts.
