tioned, then certifying, whether the faid Ship or Veffel is or is not the fame, in which the Goods, Wares, and Merchandizes fo imported, were brought from Turkey, or from any of the Countries last-mentioned; and in Cafe the Ship or Veffel is the fame, the Master or other Person having the Charge or Command of such Ship or Vessel, is hereby re-quired to bring with him the Bill or Bills of Health granted at the Port, where any of the Goods were originally taken on board, or Copies thereof, attefted by a Notary Public : And if the Ship or Veffel, having on board fuch Goods, Wares, and Merchandizes, shall be other than that in which they were imported iuto any Port or Place in Holland, or any Port or Place whatever, at which there is not a regular Establishment for the Performance of Quarantine, the Mafter or other Perfon, having the Charge of fuch Ship or Veffel, is hereby required to bring with him a Declaration, made and attefted in like Manner as the Declaration before-mentioned, certifying, whether the faid Goods, Wares, and Merchandizes were imported into the Ports of the Countries last mentioned, in a Ship or Veffel, with or with-out a clean Bill of Health : And fuch Master or other Perfon having the Charge of any fuch Ship or Veffel, if the fame fhall be bound to the Port of Lon-don, or to the River of Thames or Medway, fhall forthwith produce fuch Declaration or Declarations (as the Cafe may be) to the Superintendant of Qua-rantine at Standgate Creek; or if the fame shall be bound to any of the Out-ports or Islands aforefaid, to the proper Officer of the Cuftoms employed in the Service of Quarantine at fuch Out-port or Place; and if it shall appear that none of the Goods, Wares, or Merchandizes, on board fuch Ship or Vefiel, are of the Growth, Produce, or Manufacture of Turkey, or of any Place in Africa within the Streights of Gibraltar, or in the Weft Barbary on the Atlantic Ocean, fuch Ship or Veffel, importing the fame, fhall not be obliged to perform Quaran-tine, but fhall, on Production of fuch Declaration to the proper Officer of the Cuftoms be admitted to an Entry in the ufual and legal Manner ; but if it shall appear, that fuch Goods, Wares, or Merchandize, or any Part thereof, are of the Growth, Produce, or Manufacture of any of the Countries last mentioned, then the Superintendant of Quarantine at Standgate Creek, or the proper Officer of the Cuftoms em-ployed in the Service of Quarantine at the Out-port or Place at which fuch Ship or Veffel shall arrive, as the Cafe may be, fhall take care that every fuch Ship and Veffel, as well as the Crew, Paffengers, and Cargo on board the fame, fhall perform Quarantine, according to the Nature of the Cafe, at fuch, and the fame Places as are hereinbefore appointed for the Performance of Quarantine, for the same Time, and in the fame Manner, as Ships and Veffels, their Crews, Passengers and Cargoes, coming from or through the Mediterranean, or from the West Barbary on the Atlantic Ocean, either with or without clean Bills of Health, are hereinbefore respectively required to perform Quarantine.

XXXIX. And it is hereby further ordered, That all Ships and Veffels arriving in the Ports of this Kingdom, or the Iflands of Guernfey, Jerfey, Alderney, Sark, or Man, having come from or through the Mediterranean, or from the Weft Barbary on the Atlantic Ocean, which, with their Crews, Paf-

fengers, and Cargoes, shall have previously performed Ouarantine in the Lazaret of Malta, Ancona, Venice, Mcsima, Leghorn, Genoa, or Marseilles, fhall, upon their Arrival, be put under Quarantine in fome of the Ports or Places hereinbefore appointed for the Performance of Quarantine, until the Master or other Persons having the Charge of fuch Ship or Vefsel, shall have produced to the Superintendant, or proper Officer of the Cuftoms employed in the Service of Quarantine, the proper Documents to prove that such Ship or Vessel, and the Crew, Paffengers, and Cargo on board the fame have duly performed Quarantine in one of the Lazarets last-mentioned; and upon fo producing such Documents the faid Ship or Veffel shall be forthwith admitted to report, and all Goods, Wares, and Merchandizes on board thereof, not hereinbefore enumerated in the First Class before stated, shall be admitted to an Entry; but all Goods, Wares, and Merchandizes on board any fuch Ship and Veffel, which are enumerated in the First Class before stated, shall in fuch Cafe perform a further Quarantine of Fifteen Days at fome one of the Ports or Places hereinbefore appointed for that Purpole, in fuch Manner as has been heretofore practifed.

XL. And it is hereby further ordered, That all Ships and Veffels which fhall receive any Perfons, or any Goods, Wares, or Merchandizes, or other Articles whatever, from on board any Ship or Veffel liable to or under Quarantine, fhall, together with the Cargo and Perfons on board thereof, perform the like Quarantine as the Ship or Veffel from which fuch Perfons, Goods, Wares, Merchandizes, or Articles fhall have been received.

XLI. And it is hereby further ordered, That notwithftanding any Thing herein contained, it fhall be lawful for His Majefty's Privy Council, from Time to Time, as they fhall fee Occafion, to make fuch Orders as they fhall fee fit, and as they have ufually done, for fhortening the Time of Quarantine to be performed by particular Ships or Veffels, or particular Perfons, Goods, Wares, Merchandizes, or Effects, or for wholly releafing particular Ships or Veffels, or particular Perfons, Goods, Wares, Merchandizes, or Effects from Quarantine, abfolutely or conditionally, and generally to mitigate the firld Performance of Quarantine in particular Cafes, as fpecial Circumftances fhall appear in their Judgment to require.

XLII. And it is hereby further ordered, That the Commanders of any of His Majefty's Ships of War, who fhall meet any Ship or Veffel liable to perform Quarantine, coming to any of the Ports of Great Britain, or of the Islands of Guernfey, Jerfey, Alderney, Sark, or Man; fhall take due care to prevent the Landing of any Goods, Wares, Merchandizes, or Pérfons from on board the fame, until they fhall be put under the Direction of the Superintendant of Quarantine at Standgate Creek, or of the Officers of. His Majefty's Cultoms employed in the Quarantine Service at any of the Out-ports or Places hereinbefore mentioned.

XLIL. And it is hereby further ordered, That the Commiffioners, and other Officers of His. Majefty's Cuftoms, do use their utmost Diligence and Care that all the Regulations for the Performance of Quarantine before directed be duly obferved.
