PRESENT,

The KING's Most Excellent Majesty in Council. HEREAS, in purfuance of the Powers vested in His Majesty by an Act passed in the Thirty-ninth Year of His Majesty's Reign, intituled "An Act for enabling His Majesty to pro-44 hibit the Exportation and permit the Importation of Corn; and for allowing the Importation of other Articles of Provision without Payment " of Duty, to continue in Force until Six Weeks " from the Commencement of the next Sellion of " Parliament;" His Majesty, by his Order in Council bearing Date the Sixteenth Day of October One thousand seven hundred and ninety-nine, was pleafed to prohibit, for the Term mentioned in the faid Order, the Exportation, or the loading or laying on board any Ship or Veffel, with Intent to export from any Port or Place of this Kingdom, any Wheat, Rye, Barley, Beer or Bigg, Peafe, Beans, Oats, or any Meal or Flour, or Bread, Bifcuit, or Malt made thereof, or any Indian Corn or Maize, or Meal, or Flour made thereof; such Prohibition to export not to extend to prohibit the Exportation of any Foreign Corn, or Meal, or Flour that should have been imported and warehoused in the Manner and on the Conditions mentioned in an Act passed in the Thirty first Year of His present Majesty's Reign, intituled "An Act " for regulating the Importation and Exportation " of Corn, and the Payment of the Duty on Fo-" reign Corn imported, and of the Bounty on 45 British Corn exported," and should not have been taken out of fuch Warehouse for Home Confumption; nor to prevent the carrying Coastwife, or carrying out, or the Exportation of the several Sorts of Corn, or other Articles as aforelaid, from this Kingdom for any of the Purpoles mentioned in the faid Act: And whereas His Majesty, by his

faid Order in Council of the Sixteenth of October One thousand seven hundred and ninety-nine, thought fit further to order that it should be lawful to import into any Port or Place of this Kingdom any Foreign Corn, or other Articles as aforefaid, in any British Ship or Vessel, or in any other Ship or Vellel belonging to Persons of any Kingdom or State in Amity with His Majesty, and navigated in any Manner whatever, without Payment of any Duty whatfoever; and also to take out of Warehouse for Home Consumption any such Foreign. Corn, or other Articles as aforefaid, without Payment of any Duty whatsoever: And His Majesty was likewife pleafed to order, that it should belawful to import into any Port or Place of this Kingdom, in any British Ship or Vessel, or in any other Ship or Veffel belonging to Perfons of any Kingdom or State in Amity with His Majesty, and navigated in any Manner whatever, without Payment of any Duty whatfoever, any Beans called Kidney or French Beans, Tares, Lentiles, Callivances, and all other Sorts of Pulfe; and also Bulls, Cows, Oxen, Calves, Sheep, Lambs, and Swine; Beef, Pork, Mutton, Veal, and Lamb, whether falted or otherwise; Bacon, Hams, Tongues, Butter, Cheese, Potatoes, Rice, Sago, Sago Powder, Tapioca, Vermicelli, Millet Seed, Poultry, Fowls, Eggs, Game, and Sour Crout: Provided always, that a due Entry should be made of all such Articles as aforefaid that should be so imported with the proper Officers of the Customs at the Port where the same should be imported, under the Penalties and Forfeitures in the faid Act mentioned; And whereas, by an Act passed in the present Solo fion of Parliament, intituled "An Act for con-" tinuing until the Expiration of Forty Days after " the Commencement of the First Session of Par-" liament that shall be begun and holden after the

Importation of Corn and other Articles of Pro- | thousand eight hundred and one, no Person or " vision without Payment of Duty; to the allow-" ing the Use of Sugar in the Brewing of Beer; " to the reducing the Duties upon Spirits distilled from Melasses and Sugar; and to the prohibiting " the making of Low Wines or Spirits from Wheat, " and certain other Articles, in that Part of Great " Britain called Scotland;" the faid feveral recited Acts, and all the Powers, Authorities, and Provifions therein contained, are continued as aforefaid; His Majesty is pleased, by and with the Advice of his Privy Council, to order, and it is hereby ordered, that the faid Prohibition to export Corn or other Articles as aforefaid, and the faid Permission to import, or take out of Warehouse, Foreign Corn or other Articles as aforefaid, and likewife to import certain other Articles of Provision, as expressed in the said Order of the Sixteenth Day of October One thousand seven hundred and ninetynine, with every Exception, Provifo, Rule, Regulation, and Restriction specified in the said Order respecting such Exportation, Importation, or taking out of Warehouse; and all Matters and Things in the faid Order contained, shall be and continue in Force until the Expiration of Forty Days after the Commencement of the First Session of Parliament that shall be begun and holden after the First Day of September One thousand eight hundred and one:-And the Right Honorable the Lords Commissioners of His Majesty's Treasury, are to give the necessary Directions herein accordingly.

The KING's Most Excellent Majesty in Council. WHEREAS by an Act passed in the present Session of Parliament, intituled "An Act " to authorife His Majesty from Time to Time \* to prohibit the Exportation of Provisions or " Food," it is enacted, that it shall be lawful for His Majesty, by Order in Council, from Time to Time to prohibit for a Time to be limited in fuch Order, either generally or particularly, and by Name or Description, the Exportation from this Kingdom of all or any Sort of Provision or Victual, or any Article or Articles whatfoever used, or which may be used as Food by Man, under such Restrictions and Regulations as His Majesty in Council shall think proper; and in like Manner from Time to Time to recal fuch Order in Part, or in the Whole, or make fuch Alteration therein as he shall think proper; His Majesly therefore, by and with the Advice of His Privy Council, and in pursuance of the Powers vested in him by the faid Act, has thought fit to order, and it is hereby ordered, that from and after the Date of this prefent Order, and until the first Day of October One

Perfons whatfoever shall export, or shall load, or lay on board any Ship or other Veffel with the Intent to export from any Port or Place in this Kingdom; the following Articles, viz: Bulls, Cows, Oxen; Calves, Sheep, Lambs, Swine, Beef, Pork, Mutton, Veal, Lamb, whether falted or otherwife; Bacon; Butter, Cheefe, Onions, Potatoes, and Pulse of any Sort, Barley hulled or Pearl Barley; but it is His Majesty's Pleasure, that nothing herein contained shall extend or be construed to extend to prohibit at any Time the Exportation or carrying out of such and so much of any such Provisions, Victuals, and other Articles of Food as shall be necessary to be carried in any Ship or Vessel on its Voyage out and Home for the Sustenance, Diet, and Support of the Commander, Master, Mariners, Passengers, and others, or for the Use and Suftenance of the Cattle, Live Stock, or other Animals on board of fuch Ship or Vessel, or for victualling or providing any of His Majesty's Ships of War, or other Ships or Veffels in His Majesty's Service, or for victualling or providing any of His Majesty's Forces, Forts, or Garrisons, or to prohibit at any Time the Exportation to the British Forts, Castles, or Factories in Africa, or for the Use of British Ships trading upon that Coast, which have usually been supplied with the same from Great Britain, or to prohibit the Exportation of any of the Articles above-mentioned to any of His Majesty's Colonies, Islands, or Plantations, or the Town of Gibraltar, provided Proof is made to the Satisfaction of the Commissioners of the Customs that the Articles fo exported are not of British Growth, Produce, or Manufacture; or to prohibit at any Time any Person or Persons from shipping or putting on board any Provisions, Victuals, or other Articles of Food as aforementioned, to be carried Coastwife (that is to fay) from any Port, Creek or Member, or Part of the Kingdom of Great Britain to any other Port, Creek, Member, or Part of the same refpectively, having fuch or the like Coast Sufference, Cocquet, or other Coast Dispatch for that Purpose; and on fuch and the like Security being given for the landing and discharging the same as now is, or hereafter may be by any Law or Laws, Act or Acts required in relation to the carrying Coastwife any Corn or other Articles, or any Goods, Wares, or Merchandizes: And the Right Honorable the Lords Commissioners of His Majesty's Treasury are to give the necessary Directions herein accordingly. The KING's Most Excellent Majesty in Council's HEREAS the Island of Curaçoa and its Dependencies, has been surrendered and placed under the immediate Protection of His Mas

jefty's Arms, and the Tenritory and Forts of the same are delivered up to His Majesty, and the said Island is now in His Majesty's Possession; His Majesty is thereupon pleased to order and declare, and it is hereby ordered and declared, that all His loving Subjects may lawfully trade to and from the said Island of Curaçoa, subject nevertheless, to the same Duties, Rules, Regulations, Conditions, Restrictions, Penalties, and Forseitures, to which the Trade to and from His Majesty's Colonies, Plantations, and Islands in the West Indies, is or shall be subject by Law.

And His Majesty is further pleased to order and declare, and it is hereby ordered and declared, that all Commodities being of the Growth, Produce, or Manufacture of the faid Island of Curaçoa, being in His Majesty's Possession, shall be permitted to be imported into any of the Ports of this Kingdom in British Ships owned by His Majesty's Subjects, and navigated according to Law, subject to the fame Duties, Rules, Regulations, Restrictions, Conditions, Penalties, and Forfeitures, as Articles of the like Sort are subject to, coming from His Majesty's Colonies, Plantations, or Islands in the West Indies; and the Right Honorable the Lords Commissioners of His Majesty's Treasury; and the Lords Commissioners of the Admiralty me to give the necessary Directions herein, as to them may respectively appertain. The KING's Most Excellent Majesty in Council. THEREAS the Time limited by His Majesty's Order in Council of the Twenty-eighth Day of May last, for prohibiting the Exportation out of this Kingdom, or carrying Coastwise, Gunpowder or Saltpetre, or any Sort of Arms or Ammunition, will expire upon the Seventh Day of this instant December: And whereas it is judged expedient for His Majesty's Service, and the Safety of this Kingdom, that the said Prohibition should be continued for some Time longer: His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Person or Persons whatsoever (except the Master-General of the Ordnance for-His Majesty's Service) do, at any Time during the Space of Six Months, to commence from the Seventh Day of this instant December, presume to transport into any Parts out of this Kingdom, or carry Coastwise, any Gunpowder or Saltpetre; or any Sort of Arms or Ammunition, or ship or lade any Gunpowder or Saltpetre, or any Sort of Arms or Ammunition, on board any Ship or Vessel, in order to transporting the fame into any Parts beyond the Seas, or carrying the same Coastwise, without Leave or Permission in that Behalf first obtained from His Majetty; or His Privy Council, upon Pain of incur-ring and fuffering the respective Forfeitures and Penalties inflicted by an Act, passed in the Twenty-ninth Year of His late Majesly's Reign, intituled "An Act " to empower His Majesty to prohibit the Export-" ation of Saltpetre, and to enforce the Law for emopowering His Majesty to prohibit the Exportation

" of Gunpowder, or any Sort of Arms and Ammuni" tion; and also to empower His Majelly to reflerain
" the catrying Conflictle of Saltpetre, Gunpowder,
" or any Sort of Arms or Ammunition."—And the
Right Honorable the Lords Commillioners of His

HEREAS the Time limited by His Majesty's Order in Council of the Twenty-eighth Day of May last, prohibiting the Transportation into any Parts out of this Kingdom, of the Wood called Lig. num Vitæ, will expire upon the Tenth Day of this inftant December: And whereas it is judged expedient for His Majesty's Service that the faid Prohibition should be continued for some Time longe His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Person or Persons whosever do, at any Time for the Space of Six Months, to com-mence from the faid Tenth Day of this indeat December, export, or attempt to export, transport, carry, or convey, or lade, or lay on board of any Snip, Veffel, or Boat, in order to be exported, transported, carried, or conveyed out of this Kingdom, any of the Wood called Lignum Vitæ, without Leave or Permission being first had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inslicted by an Act passed in the Thirty-fourth Year of His Majesty's Reign, intituled "An Act for indemnifying all Persons who have "been concerned in adviting or carrying into Exe-cution an Order of the Lords Commissioners of "His Majesty's Treasury respecting the Exportation " of Pot-Ashes or Pearl-Ashes; for preventing Suits " in consequence of the same; for authorizing His " Majesty to prohibit the Exportation or carrying "Coastwife of Pot-Ashes or Pearl-Ashes, and for " making further Provisions relative thereto:" But it is, nevertheless, His Majesty's Pleasure, that nothing herein contained shall extend, or be construed to extend, to prevent any Ship or Vessel from taking or having on board any of the faid Wood called Lignum Vitæ, which may be necessary for the Use of the said Ship or Vessel during the Course of her intended Voyage; nor to prevent the Exportation of the faid Wood called Lignum Vitæ to Ireland, or to His Majesty's Islands of Guernfey, Jersey, Alderney, Sark, or Man, or to His Majesty's Colonies or Plantations in America or the West Indies; or to Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies: Provided that, upon the Exportation of the faid Wood called Lignum Vitæ to Ireland, or to His Majelly's Islands of Guernfey, Jerfey, Alderney,

Sark, or Man, or to His Majesty's Colonies or Plantations in America or the West Indies, or to the Island of Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies, the Exporters of the faid Wood called Lignum Vitæ, do first make Oath of the true Destination of the same to the Places for which it shall be entered Outwards, before the Entry of the same shall be made, and do give full and sufficient Security, by Bond, to the Satisfaction of the Commissioners of His Majesty's Customs, to carry the faid Wood called Lignum Vitæ to the Places for which it is so entered Outwards, and none other; and fuch Bond shall not be cancelled, or delivered up, until Proof be made to the Satisfaction of the faid Commissioners, by the Production, within a Time to be fixed by the faid Commissioners, and specified in the Bond, of a Certificate or Certificates, in fuch Form and Manner as shall be directed by the said Commissioners, shewing that the faid Wood called Lignum Vitæ has been duly landed at the Places for which it was entered Outwards: And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the neceffary Directions herein as to them may respectively appertain. ## By the KING. A PROCLAMATION. GEORGE R.

HEREAS an Address has been presented to Us by Our Two Houses of Parliament, requesting Us to issue Our Royal Proclamation, recommending to all such Persons as have the Means of procuring other Articles of Food the greatest Economy and Frugality in the Use of every Species of Grain: We, having taken the said Address into Consideration, and being persuaded that the Prevention of all unnecessary Consumption of Corn will furnish one of the furest and most effectual Means of alleviating the present Pressure, and of providing for the necessary Demands of the Year, have, therefore, in pursuance of the said Address, and out of Our tender Concern for the Welfare of Our People, thought fit (with the Advice of Our Privy Council) to iffue this Our Royal Proclamation, most carneftly exhorting and charging all those of Our loving Subjects who have the Means of procuring other Articles of Food than Corn, as they tender their own immediate Interests, and feel for the Wants of others, to practife the greatest Economy and Frugality in the Use of every Species of Grain: And We do, for this Purpole, more particularly exhort and charge all Mafters of Families to reduce the Confumption of Bread in their respective Families, by at least One-Third of the Quantity confumed in ordinary Times, and in no Case to suffer the same to exceed One Quartern Loaf for each Person in each Week; to abstain from the Use of Flour in Pastry, and, moreover, carefully to restrict the Use thereof in all other Articles than Bread: And do also, in like

Manner, exhort and charge all Persons who keep Horses, especially Horses for Pleasure, as far as their respective Circumstances will admit, carefully to restrict the Consumption of Oats and other Grain or the Subsistence of the same. And We do hereby further charge and command every Minister; in his respective Parish Church or Chapel, within the Kingdom of Great Britain, to read, or cause to be read, Our said Proclamation, on the Lord's Day, for Two successive Weeks after receiving the said Proclamation.
