WHEREAS His Majesty has received Advice that a large Number of Vessels belonging to His Majesty's Subjects have been, and are detained in the Ports of Ruffia, and that the British Sailors navigating the fame have been, and now are detained as Prifoners in different Parts of Ruffia; and alfo that, during the Continuance of these Proceedings, a Confederacy of a hoftile Nature against the just Rights and Interests of His Majesty and His Dbminions has been entered into with the Court of St. Peter/burgh by the Courts of Denmark and Sweden refpectively; His Majefty, with the Advice of His Privy Council, is thereupon pleafed to order, as it is hereby ordered, that no Ships or Veffels belonging to any of His Majesty's Subjects be permitted to enter and clear out for any of the Ports of Russia, Denmark, or Sweden, until further Order: And His Majefty is further pleafed to order, that a general Embargo or Stop be made of all Ruffian, Danish, and Swedish Ships and Veffels whatfoever, now within, or which hereafter shall come into any of the Ports, Harbours, or Roads within the United Kingdom of Great Britain and Ireland, together with all Perfons and Effects on board the faid Ships and Veffels; but that the utmost Care be taken for the Prefervation of all and every Part of the Cargoes on board any of the faid Ships and Veffels, fo that no Damage or Embczziement whatever be fuf. tained .- And the Right Honorable the Lords Commissioners of His Majelly's Treasury, the Lords Commiffioners of the Admiralty, and the Lord Warden of the Cinque Ports, are to give the necef. fary Directions herein as to them may respectively appertain. The KING's Most Excellent Majesty in Council.

WHEREAS His Majefty has received Advice that a large Number of Veffels belonging to His Majefty's Subjects, have been, and are detained in the Ports of Russia, and that the Property of His Majesty's Subjects in Russia, has, by virtue of feveral Orders and Decrees, of the Ruffian Government, particularly one bearing Date the Twentyninth of November last, O. S. (corresponding with the Tenth of December N.S.) been feized, and directed to be applied in Violation of the Principles of Justice, and of the Rights of the feveral Perfons interested therein ; His Majesty, with the Advice of His Privy Council, is thereupon pleafed to order, as it is hereby ordered, that no Bills drawn fince the faid Twenty-ninth of November last, O. S. (corresponding with the Tenth of December N. S.) by or on Behalf of any Perfons, being Subjects of or reliding in the Dominions of the Emperor of Ruffia, skall be accepted, or paid, without Licence from One of His Majefty's Principal Secretaries of State first had in that Behalf, until further Signification of His Majesty's Pleasure, or until Provision shall be made in respect thereof by Act of Parliament; whereof all Perfons concerned are to take Notice, and govern themfelves accordingly.

WHEREAS it is expedient, for the Purpole of preventing any Danger from the Plague or other Infectious Difeafe' or Diffemper, of the Nature of the Plague, and for alcertaining whether



any Ship or Veffel about to enter any Port or Place, or the Mariners, Paffengers, or Cargo on board the fame, are liable to any Orders concerning Quarantine, to extend the Provisions, Regulations, and Directions, contained in His Majesty's Order in Council of the Twenty-ninth of July laft, concerning Quarantine, by directing that as often as any Ship or Veffel, the Cargo of which shall confift of any of the Articles enumerated or defcribed in the Thirty-eighth Section of His Majelty's faid Order in Council, fiall attempt to enter any Port or Place in Great Britain, or of the Isles of Guernfey, Jerfey, Alderney, Sark, or Man, whether fuch Port shall have been appointed for the Performance of Quarautine or not, certain Queffions and Interrogatories shall be put to the Commander, Master, or other Perfon having Charge of any fuch Ship or Veffel, in Manner hereinafter directed; and that fuch Commander, Master, or other Person shall answer the fame upon Oath ; His Majesty is pleased, by and with the Advice of His Privy Council, to order, and it is hereby ordered, that as often as any fuch Ship or Veffel shall attempt to enter into any Port or Place as aforefaid, whether fuch Port shall have been appointed for the Performance of Quarantine or not, fuch Officer of the Cultoms as shall be nominated or appointed for that Purpofe shall go alongfide fuch Ship or Veffel, at fuch Place as shall be convenient for the Purpofe, either within or without the Limits of any Port, and shall put to the Master, Commander, or other Person having Charge of fuch Ship or Veffel, the Queftions contained in the Fifth Section of the faid Order in Council, and also the following Questions, viz.

Have you any Cotton, Wool, Thread, or Yarn on board, or any of the Articles enumerated in the First Class of the faid Order in Council of the Twenty-ninth of July laft, repeating fuch feveral Articles?

Are any of the faid Goods or Articles which you have on board your Veffel, of the Growth, Produce, or Manufacture of Turkey, or of any Place in Africa within the Streights of Gibraltar, or in the West Barbary on the Atlantic Ocean?and shall require fuch Commander, Master, or other Perfon having Charge of fuch Ship or Veffel, to give a true Anfwer to all the faid Queffions upon Oath; and all fuch Officers of the Cuft_ms as shall be nominated or appointed for this Service, are hereby authorized and required to take fuch Examinations and Anfwers upon Oath accordingly; and the Commiffioners of His Majefty's Cuftoms shall appoint fuch Places for fuch Examinations as they shall deem molt convenient for the Purpole, in or for the feveral principal Ports, or shall appoint Veffels to be flationed at certain Places for that Purpole, and shall give Notice of the Places to appointed, and of the Places where any fuch Veffels shall be stationed, and likewife of the Time at which fuch

coming from different Countries; and all Makers, Commanders, or other Perfons having the Charge of Ships or Veffels coming or attempting to come into any Port or Place as aforefaid, are hereby ordered and required to bear up to fuch Places, and on no Pretence to avoid the fame; and alfo to bring-to on being hailed by any Veffel having any Officer of the Cuftoms on board appointed for the Purpose aforefaid. And the Right Honorable the Lords Commiffioners of His Majefty's Treafury, and the Lords Commissioners of the Admiralty are to give the neceffary Directions herein as to them may refpectively appertain. VHEREAS His Majeity, by His Order in Council of the Twenty-fifth Day of June laft, thought fit to prohibit the transporting into any Parts out of this Kingdom, any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rofin, Turpentine, Anchors, Cables, Cordage, Maits, Yards, Bowfprits, Oars, Oakum, Oker, Sheet-Copper, or other Naval Stores, for the Time thercin-mentioned : And whereas it is judged expedient for His Majefty's Service, and the Safety of this Kingdom, that the faid Proitibition fhould be continued for fome Time longer; His Majefty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Perfon or Perfons whofoever do, at any Time, for the Space of Six Months, to commence from the Date of this His Majefty's Order, prefume to transport into any Parts out of this Kingdom, any Pig-Ivon, Bar-Iron, Hemp, Pitch, Tar, Rofin, Turpentine, Anchors, Cables, Cordage, Mafts, Yards, Bowfprits, Oars, Oakum, Oker, Sheet-Copper, or other Naval Stores, or thip or lade any of the Articles abovementioned on board any Ship or Veilel, in order to transporting the fame into any Parts beyond the Seas, without Leave or Permiffion being first had and obtained from His Majefty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act, paffed in the Thirty-third Year of His Majesty's Reign, intituled "An Act to " enable His Majesty to restrain the Exportation of " Naval Stores, and more effectually to prevent the " Exportation of Salt-Petre, Arms, and Ammuni-" tion, when prohibited by Proclamation or Order in " Council :" But it is, neverthelefs, His Majefty's Pleafure, that nothing herein contained shall extend, or be confirued to extend, to any of His Majefty's Ships of War, or any other Ships or Veffels or Boats, in the Service of His Majefty, or employed or freighted by His Majefty's Board of Regulations shall take Place with regard to Ships | Ordnance, or by the Commissioners of His Maĵ.

from taking or having on board fuch Quantities of Naval Stores as may be necessary for the Use of fuch Ship or Veffel during the Courle of her intended Voyage, or by Licence from the Lord High Admiral of Great Britain, or the Commissioners of the Admiralty for the Time being ; nor to the Exportation of the faid feveral Articles to Ireland, or to His Majesty's Yards or Garrisons, or to His Majefty's Colonies or Plantations in America or the West Indies, or to Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the Britifh Settlements or Factories in the East Indies : Provided that, upon the Exportation of any of the faid Articles, for the Purpofes of Trade, to Ireland, or to His Majeliy's Yards or Garrifons, or to His Majefty's Colonies and Plantations in America or the West Indies, or to the Island of Newfoundland, or to His Majefty's Forts and Settlements on the Coaft of Africa, or to the Ifland of St. Helena, or to the British Settlements or Factories in the East Indies, the Exporters of fuch Articles do first make Oath of the true Destination of the fame to the Places for which they shall be entered Outwards, before the Entry of the fame shall be made, and do give full and fufficient Security, by Bond, to the Satisfaction of the Commissioners of His Majefty's Cuftoms, to carry the faid Articles to the Places for which they are fo entered Outwards, and for the Purposes specified, and none other; and fuch Bond shall not be cancelled or delivered up, until Proof be made, to the Satisfaction of the faid Commissioners, by the Production, within a Time to be fixed by the faid Commiffioners, and specified in the Bond, of a Certificate or Certificates, in fuch Form and Manner as shall be directed by the faid Commiffioners, shewing that the faid Articles have been duly landed at the Places for which they were entered Outwards. And the Right Honorable the Lords Commissioners of His Majefty's Treafury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein, as to them may respectively appertain.

Extract of a Letter from Admiral the Earl of St. Vincent, K. B. Ec. Ec. Ec. to Evan Nepcan, Efq; dated on board His Majefly's Ship Ville de Paris, in Torbay, the 12th January 1801.

Enclose Two Letters from Captain Sir Richard Strachan, Bart. detailing Particulars of the meritorious Exertions of himfelf, and the Officers under his Command, in intercepting the Enemy's Supplies.

His Majefly's Hired Cutter Nile, December 11, 1800.

SIR. Have the Honor to inform you, that the Veffels you fignalled us to chace, on the 6th Inftant, never came through the Passage, but rowed up Seal of Ireland in the Lord Chancellor's Abfence, along Shore again, and went under Fort Lomara;

I watched for them all Night, but in the Morning feeing them no more I left the Lurcher off the Morbihan, and proceeded to execute your farther Orders; on that Day I faw a Convoy courfing round Croilie of Fifteen or Sixteen Sail, but was in no Hurry to chace, rather permitting them to get nearer to St. Gildas, and in the Evening flood out, and made the neceffary Signals to Mr. Forbes; it fully anfwered my Expectations, as he being to windward turned them all, and they made for the Villain jult where I was; about Eight we took a finall one jult as the Battery of St. Jacques was hailing us, which I immediately manued and fent her with our own Boat along Shore, and by Four A. M. found ourfelves in Poffedhon of Five more; this is all they could attempt, as the whole Coafts were then alarmed, and the Battery of Notre Dame at the Entrance of the River Peners, kept up fo brifk a Fire as to fend Three Shot through the last Vessel; but the Spirit of our People was such that they were determined to have her out, and luckily only one Man was slightly fcratched with a Splinter; on joining the Lurcher in the Morning I found the had got Three more, making nine, the Particulars of which are expressed in the adjoined Lift; the Four largest are decked, and very capable of going to England, but the others cannot; fince the 7th Mr. Forbes has been con-tinually on the look-out, but not a fingle Vefiel, I believe, has ftirred fince.

Extract of a Letter from Captain Rowley Bullect, Commander of His Majefly's Ship Belliqueux, to Evan Nepean, Efq; dated at Rio Janeiro, the 24th August 1800.

O N Monday the 4th Day of Auguft, foon after Daylight, Four Sail were different from the Maft-Head in the North Weft Quarter, and apparently fleering about N. by E. At Seven A. M. they hauled their Wind, tacked, and flood towards us, upon which I bore down with the Whole of my Convoy: At Noon the Enemy perceived our Force, (which was greatly exaggerated in their Opinion by the warlike Appearance of the China Ships,) they bore up under a Prefs of Sail, and by Signal feparated.

I ftood for the largeft Ship, and notwithstanding the light and baffling Winds, we came up with her, and after a few Chace Guns, and a partial Firing for about Ten Minutes, at Half patt Five in the Afternoon (Tuefday) she firuck her Colours, and proved to be the French Frigate La Concorde, of Forty-four Guns, Eighteen-Pounders, and Four Hundred and Forty-four Men, commanded by Citizen Jean François Landolphe, Capitaine de Vaiffeau, and Chef de Division.

At Seven the fame Evening, the French Frigate La Medée, of Thirty-fix Guns, Twelve-Pounders, and Three Hundred and Fifteen Men, commanded by Citizen Daniel Coudein, flruck her Colours to the Bombay Caftle, Captain John Hamilton, and the Exeter, Captain Henry Meriton.

The above Frigates were of the Squadron which failed from Rochefort the 6th Day of March 1799, and having committed great Depredations on the Coaft of Africa, had refitted in the Rio de la Plata, and were now cruifing on the Coaft of Brazil.

La Franchife, of Forty-two Guns and Three Hundred and Eighty Men, commanded by Citizen Pierre Jurieu, efcaped by throwing a Part of her Guns overboard, and alfo her Anchors, Boats, and Booms, and by Night coming on; as did alfo an American Schooner, their Prize, fitted as a Cruizer.

On this Occafion I hope their Lordfhips will permit me to bear Teffimony of the Spirit of the Officers and Ship's Company of the Belliqueux; and I have peculiar Plealure in mentioning the Zeal and Activity I have ever found in Mr. Ebdon, my First Lieutenant, to whom I only do Justice in recommending him to their Lordfhips' Notice and Favor.

Too much Fraise cannot be given to the Captains, Officers, and Crews of the different Ships under my Convoy, for their ready Obedience to my

Signals, and for the whole of their Conduct on that] Day, particularly to Captains Hamilton and Meriton, who very gallantly purfued and captured the aforefaid Frigate, La Medée ; and alfo to Captain Torin, of the Coutts, and Captain Spens, of the Neptune, who with great Alacrity purfued La Franchefe, although they had not the good Fortune to come up with her, for the Reafons above affigned; and my beft Thanks are due to the Whole of the Commanders of the Ships under my Convoy, for their Affiltance in taking a Number of Frifoners on board their respective Ships.

We arrived at Rio Janeiro on Tuciday the 12th of August.

DUring my Stay off the Bar of Oporto I captured the Spanish Privateer Lugger San Jofef, alias Larcon, of Six Guns and Forty Men, out from Vigo, and had captured the Speedy Brig, one of our Convoy, and in an Hour more would have captured another, as the was within Hall when we faw her.
