A T the Court at St. James's, the 11th of February 1801,

PRESENT,

The KING's Molt Excellent Majefty in Council. 777 HEREAS by Order in Council, bearing Date the 28th of December 1796, His Mricity was pleafed, among other Things contained in the faid Order, to declare it to be His Pleafure, that no Goods, Wares, or Merchandize which should be imported into the Settlement of the Cape of Good Hope, or the Territories or Dependencies thereof, from any Part of His Majeity's Dominions should be subject to any Duty; His Majesty having taken into His Royal Confideration the present State of the Trade, Commerce, and Revenues of the faid Settlement, and the Territories and Dependencies thereof, is hereby pleafed, by and with the Advice of His Privy Council, to revoke, and doth hereby revoke fo much of the faid Order of the 28th of February 1796, as exempts from Duty any Goods, Wares, or Merchandize which shall, after due Notice to be given by the Governor of the faid Settlement, as hereinafter directed, be imported into the faid Settlement, or the Territories or Dependencies thereof, except Goods, Wares, and Merchandizes of the Growth, Produce, or Manufacture of Great Britalo or In-lund, and for much of the faid O h Britain or Ircland; and fo much of the faid Order Enall, from and after fuch due Notice, ceafe and determine: And His Majelty is further pleafed to declare, and it is hereby declared, that it fhall and may be lawful for the Governor of the faid Settle-ment, and of the Territorics and Dependencies thereof, for the Time being, to impose on all Goods, Wares, and Merchandize not of the Growth, Pro duce, or Manufacture of Great Britain or Ireland, awhich shall be imported into the faid Settlement, or the Territories or Dependencies thereof, from any Part of His Majefty's Dominions, after such due Notice, a Duty not exceeding Ten per Cent. on the Value thereof, fuch Duty to be rated and col-lected in the fame Manuer as is in Ule with regard to the Import Duty now levied at the faid Settlement, and the Territorics and Dependencies thereof, from and in Ships and Veffels belonging to the Subjects of Countries and States in Amity with His Majefty, and upon the Goods and Merchandizes imported in the fame.

Provided always, That the Commencement of fuch Duty shall be fixed in the Proclamation, or other lawful Instrument, which shall be made and iffued by the faid Governor for the Purpose of imposing such Duty, which Time shall not be lefs than Six Months from the Day of iffuing such Proclamation or other lawful Instrument: Aud provided alfo, That the Rate of Duty imposed on the Importation of Goods (not the Growth, Produce, or Manufacture of Great Britain or Ireland) from any Part of His Majesty's Dominions, when so imported in British-built Vessel, sowned and navigated according to Law, shall in no Case be so high as that which shall be imposed on the like Goods so imported in the Vessel's of Foreign States.

The KING's Most Excellent Majesty in Council.

WHEREAS His Majefty was pleafed, by His Order in Council, hearing Date the 14th of January laft, to order, and it was thereby ordered, That as often as any Ship or Veficl, the Cargo of which should conflit of any of the Articles enu-merated or described in Section Thirty eighth of His Majefty's Order in Council, bearing Date the 20th of July last, concerning the Performance of Quarantine, should attempt to enter any Port or Place in Great Britain, or of the Islands of Guerafey, Jerfey, Alderney, Sark, or Man, whether fuch Port shall have been appointed for the Performance of Quarantine or not, certain Questions and Interrogatories, fhould be put to the Commander, Mafler, or other Perfon having Charge of any fuch Ship or Veffel, in the Manner directed by the faid Order ; and that fuch Commander, Mafter, or other Perfon should answer the fame upon Oath: And whereas it has been reprefented to His Majefty, that it is extremely material that fome further Interrogatories, to be put to the Commander, Maller, or other Perlon having Charge of any fuch Ship or Veffel, should form a Part of the preliminary Examination, directed by His Ma-jesty's faid above recited Order, for the Purpose of afcertaining whether fuch Ship or Veffel may not have had Communication with any other Ship or
