T is this Day ordered by Their Lordships, that every Minister or Preacher, as well of the Eftablished Church in that Part of Great Britain called Scotland, as those of the Episcopal Communion, protected and allowed by an Act, passed in the Tenth Year of Her late Majesty Queen Anne, Cap. 7. intituled "An Act to prevent the 46 diffurbing those of the Episcopal Communion in "that Part of Great Britain called Scooland in the " Exercise of their Religious Worship, and in the " Use of the Liturgy of the Church of England; " and for repealing an Act passed in the Parliament " of Scotland, intituled An Act against irregular " Baptisms and Marriages," do, at some Time during the Exercise of the Divine Service in such respective Church, Congregation, or Assembly, put up Prayers and Thanksgivings to Almighty God for His Majesty's Recovery from his late dangerous Steph. Copy of a Letter from Captain Wolley, of His Majesty's Ship Arethusa, to Evan Nepean, Esq; dated Spithead, the 13th Instant.

SIR,

Have the Pleasure of informing you, that at Half past Nine on the Morning of the 12th, on our Way round, we fell in with and captured, after Six Hours Chase, the French Privateer Lugger Le Brave of Boulogne, of Fourteen Guns and Fifty-seven Men, on her first Cruize, perfectly New. THIS Day the Lords being met, a Message was fent to the Honorable House of Commons by Sir Francis Molyneux, Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorised by virtue of His Majesty's Commission for declaring His Royal Assented upon by both Houses, do desire the immediate Attendance of the Honorable House in the House of Peers to hear the Commission read; and the Commons being come thicker, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act for reviving and further continuing, until Six Weeks after the Commencement of the next Seffion of Parliament, several Acts made in the Thirty-eighth, Thirty-ninth, and Fortieth Years of His present Majesty's Reign, and in the last Seffion of Parliament, for empowering His Majesty to secure and detain such Persons as His Majesty shall suspect are conspiring against his Person and Government.
