PRESENT, The KING's Most Excellent Majesty in Council. HEREAS the Time limited by His Majefly's Order in Council of the Fourteenth Day of January last, prohibiting the Exportation into any Parts out of this Kingdom, of any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Roin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Bowsprits, Oars, Oakum, Oker, Sheet-Copper, or other Naval Stores, will expire upon the Fourteenth Day of July next: And whereas it is judged expedient for His Majesty's Service, and the Safety of this Kingdom, that the said Prohibition should be continued for some Time longer; His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Perfon or Persons whosoever do, at any Time, for the Space of Six Months, to commence from the laid Fourteenth Day of July next, prefume to transport into any Parts out of this Kingdom, any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchers, Cables, Cordage, Mask, Yards, Bowsprits, Oars, Oakum, Oker, Sheet Copper, or other Naval Stores, or ship or lade any of the Articles above-mentioned on board any Ship or Vessel, in order to transporting the same into any Parts beyond the Seas, without Leave or Permission being first had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forseitures inslicted by an Act, passed in the Thirty-third Year of His Majesty's Reign, intituled "An Act to "enable His Majesty to restrain the Exportation of " Naval Stores, and more effectually to prevent the " Exportation of Salt-Petre, Arms, and Ammuni-"tion, when prohibited by Proclamation or Order in "Council:" But it is, nevertheless, His Majesty's Pleasure, that nothing herein contained shall extend, or be construed to extend, to any of His Majesty's Ships of War, or any other Ships or Vessels or Boats, in the Service of His Majesty, or employed or freighted by His Majesty's Board of Ordnance, or by the Commissioners of His Majesty's Navy; nor to prevent any Ship or Vessel from taking or having on board such Quantities of Naval Stores as may be necessary for the Use of

T the Court at the Queen's House, the 27th of | fuch Ship or Vessel during the Course of her intended Voyage, or by Licence from the Lord High Admiral of Great Britain, or the Commissioners of the Admiralty for the Time being; nor to the Exportation of the faid feveral Articles to Ireland, or to His Majesty's Yards or Garrisons, or to His Majesty's Colonies or Plantations in America or the West Indies, or to Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies: Provided that, upon the Exportation of any of the faid Articles, for the Purpoles of Trade, to Ireland, or to His Majesty's Yards or Garrisons, or to His Majesty's Colonies and Plantations in America or the West Indies, or to the Island of New-foundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies, the Exporters of such Articles do first make Oath of the true Destination of the same to the Places for which they shall be entered Outwards, before the Entry of the same shall be made, and do give full and fufficient Security, by Bond, to the Satisfaction of the Commissioners of His Majesty's Customs, to carry the said Articles to the Places for which they are so entered Outwards, and for the Purpofes specified, and none other; and such Bond shall not be cancelled or delivered up, until Proof be made, to the Satisfaction of the faid Commissioners, by the Production, within a Time to be fixed by the faid Commisfioners, and specified in the Bond, of a Certificate or Certificates, in such Form and Manner as shall be directed by the said Commissioners, shewing that the faid Articles have been duly landed at the Places for which they were entered Outwards. And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein, as to them may respectively appertain.
