The KING's Moft Excellent Majefty in Council.

WHEREAS by an Act passed in the last Sef-fion of Parliament, intituled An Act to em-power His Majesty to regulate the Trade and Commerce to and from the Ille of Malta, until the figning a Definitive Treaty of Peace, and from thence until Six Weeks after the next Meeting of Parliament, and to declare the life of Malta to be Part of Europe, reciting, that the Island of Malta, with the Dependencies thereof, are now in the Possession of His Majesty, and that it is expedient, under the present Circumstances, that the Trade and Commerce to and from the fame should be regulated for a certain Time in fuch Manner as shall feem proper to His Majefty : It is enacted, that from and after the passing of that Act, and until the figning a Definitive Treaty of Peace, and from thence until Six Weeks after the next Meeting of Parliament, it shall and may be lawful for His Majesty, by and with the Advice of Eis Privy Council, by any Order or Orders to be iffued from Time to Time, to give fuch Directions, and make fuch Regulations, touching the Trade and Com-merce to and from the faid Isle, and the Depend-encies thereof as to His Majelty in Council shall appear most expedient and falutary, any Thing contained in an Act passed in the Twelfth Year of the Reign of His Majesty King Charles the Second, intituled An A& for the encouraging and increasing of Shipping and Navigation, or in an A& passed in the Seventh and Eighth Year of the Reign of His Majefty King William the Third, intituled An Act for preventing Frauds and regulating Abufes in the Plantation Trade, or any other Act or Acts of Parliament now in force, relating to His Majefty's Colonies and Plantations, or any other Act or Acts of Parliament, Law, Ulage, or Cultom to the contrary in anywife rotwithflanding :

And whereas it is judged expedient that the Port of La Valette, in the Island of Malta, should be declared a Free Port for the Importation into and Exportation from the fame, of all Sorts of Goods and Merchandizes in trading Ships or Veffels be-

Treaty of Peace, and from thence until Six Weeks after the next Meeting of Parliament, unless His Majefty shall, in the mean Time, otherwife order; subject neverthelefs to fuch Regulations for the Security of the Poffeffion of the Island of Malta and its Dependencies, and the Protection of the Health of the Garrifon and Inhabitants thereof, as may be now in force, or fhall, from Time to Time, be deemed neceffary or expedient in that Behalf :

And it is hereby further ordered, That the fame Drawbacks and Bounties, and upon the fame Terms and Conditions which now are or hereafter may be allowed by Law upon the Exportation of any Goods and Merchandizes to the Island of Minorca or to Gibraltar, shall and may be allowed upon the Exportation of the like Goods and Merchandizes to the Port of La Valette, in the Island of Malta.

And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Bord Lieutenant of Ireland, are to give the necessary Directions herein, as to them may refpectively appertain.

## PRESENT,

The KING's Molt Excellent Majefty in Council.

WHEREAS the Time limited by His Ma-jefty's Order in Council, of the Eleventh of February laft, prohibiting the exporting into any Parts out of this Kingdom, of any Sheet Copper,

or Copper in Boltstaves, Bars, Sheets, Rings, and ] Nails, or of Copper in fuch a State as may be eafily converted into, or made useful as a Naval Store, will expire upon the Twelfth Day of August next; and whereas it is expedient for His Majesty's Service, and the Safety of this Kingdom, that the faid Prohibition should be, in Part, continued for some Time longer, His Majefty doth, therefore, with the Advice of His Privy Council, hereby order, require, and command, that no Perfon or Perfons whofoever, do at any Time for the Space of Six Months, to commence from the faid Twelfth Day of August next, prefume to export out of this Kingdom to any Parts beyond the Seas, within the Limits of Europe, any Sheet Copper, or Copper in Boltstaves, Bars, Sheets, Rings, and Nails, or any Copper capable of being converted into a Naval Store, or thip, or lade any of the Articles above-mentioned, on board any Ship or Veffel in order to exporting the fame beyond the Seas, without Leave or Permiffion being first had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act paffed in the Thirty third Year of His Majesty's Reign, Cap. 2. and allo by an Act passed in the Thirty-fourth Year of His Majesty's Reign, Cap. 34: But it is His Majesty's Pleasure, that nothing herein contained shall extend or be construed to extend to the Exportation of any of the aforefaid Articles from Great Britain to Ireland, or from Ireland to Great Britain, respectively, or to any Exportation of any of the faid Articles, by, or on board of His Ma-jefty's Ships of War, or any other Ships, or Veffels, or Boats in the Service of His Majefty, or employed or freighted by His Majelty's Board of Ordnance, or by the Commissioners of His Majelty's Navy; nor to prevent any Ship or Veffel from taking or having on board fuch Quantities of the faid Articles as may be neceffary for the Ufe of fuch Ship or Veffel during the course of her intended Voyage, or to any Exportation thereof by Licence from the Lord High Admiral of Great Britain, or from the Commiffioners of the Admiralty for the Time being, or from the Lord Lieutenant of Ireland; nor to the Exportation of the faid feveral Articles to His Majefty's Yards and Garrifons within the Limits of Europe, nor to the Exportation of any of the faid Articles to any Port or Place without the Limits of Europe, provided that in cafe of the Exportation to any Port or Place without the Li-mits of Europe, either of Copper being a Naval Store, or of Copper capable of being converted into a Naval Store, the Exporters thereof, do first make Oath of the true Defination of the faid Articles to the Port or Place without the Limits of Europe, for which the fame shall respectively be entered outwards, before the Entry of the fame shall be made, and do give full and fufficient Security by Bond, to the Satisfaction of the Commiffioners of His Majesty's Cultoms in Great Britain, or to the Commillioners of His Majefty's Revenue in Ireland, as the Cale may be, to carry the faid Articles to the Port or Place, without the Limits of Europe, for which the fame shall respectively be entered outwards, and fuch Bond shall not be cancelled or delivered up until Proof be made to the Satisfaction of the Commiffioners of His Majelly's Cuftoms in Great Britain, or of the Commissioners of His Ma- | Death, or such other Paulitament as they shall be

### PROCLAMATION, А

For pardoning fuch Seamen and Marines as have deferted, and shall return into His Majesty's Service on or before the First Day of September next.

GEORGE R.

HEREAS We are defirous to give all due Encouragement to fuch Seamen as may have deferted from any of Our Ships, and shall be willing to return to Our Service : We have thought fit, by and with the Advice of Our Privy Council, to publish this Our Royal Proclamation, and do hereby promife Our molt gracious Pardon to all fuch Deferters as shall repair on board any of Our Ships or Veffels on or before the First Day of Sep-tember next; and We do hereby further promife Our molt gracious Pardon to all fuch Seamen as having deferred are now belonging to fome One of Our Ships (in which Ship they are hereby permitted to continue), and do declare that fuch Deferters shall be entitled to receive all Wages that may be due to them in the Ship from which they may have deferted, at the Time of fuch Defertion; and We do also hereby premile Our most gracious Pardon to all Marines who may have deferted from Our Service, and shall, on or before the said. First Day of September next, furrender themfelves at the Head Quarters of the Marines established at Portimouth, Plymouth, or Chatham, or to any Recruiting Party of Our faid Forces; and We do hereby declare that all Scamen and Marines fo furrendering themfelves as aforefaid thall be releafed and difcharged from all Profecutions, Imprifonments, and Penalties commenced or incurred by Reafon of any fuch Offence; but We do hereby further declare that all fuch Deferters, whether Seamen or Marines, who fhall not, on or before the faid First Day of September next, furrender themfelves on board One of Our Ships or Veffels of War, or at the Head Quarters of the Marines effablished at Portsmonth, Plymouth, or Chatham, or to fome Recruiting Party of the faid Forces, or who shall bereafter ablent themfelves from the Ships to which they belong, or from the Marine Quarters, without Leave from their Commanding Clicers, shall be tried at a Court Martial, and being found guilty shall be deemed untit Objects of Our Royal Mercy, and shall fuifer the Punishment of

## PROCLAMATION FOR PARDONING DESERTERS.

War Office, August 4, 1801. WHEREAS it has been reprefented to the Kiag, that there are at this Time feveral Deferters from the different regular Corps in His Majefty's Land Service, who might be induced to return to their Duty by an Offer of His Majefty's

condemned to fuffer by Sentence of the faid gracious Pardon, and that fuch an inftance of His Royal Clemency would have a due Influence upon their future Behaviour : His Majefty has been gracioufly pleafed to grant his Free Pardon to all Deferters from his regular Laud Forces, who shall furrender thandelves, on or before the 10th Day of September next, to the Commanding Officer of any Regiment, or to any of the Superintending Field Officers of the Recruiting Service, whole

Stations are mentioned in the Margin hereof, or to the Inspector General of the Recruititg Service in the Isle Marlborough. of Wight.

Such Deferters, if able-bodied Men, and fit for Service, shall be fent to the Regiments from which they respectively deferted, or be appointed to fuch Regiments as His Majefty may be pleafed to command; and, Birmingham. when fo placed, shall not be liable to be claimed by any other Corps to which they may formerly have belonged.

And whereas many of the faid Deferters may have enlifted in other regular Corps, and are now ferving therein, His Majesty is graciously pleased to extend to such Deferters the Benefit of this Pardon; and to direct, that they shall continue to

ferve in the Corps wherein they now are, without being under the Neceffity of declaring themfelves Deferters, in order to entitle them to the Benefit of this Pardon; and they shall not be liable, at any future Time, to be claimed by the Regiments in which they formerly ferved : But this Claufe is not to extend to Deferters enlifted by the Corps railing Recruits for General Service ; which Deferters are only to be entitled to their Pardon on declaring themfelves in the Ifle of Wight to be fuch, and. being there transferred to fome established Regigiment.

Any Soldier who may defert after these His-Majefty's gracious Intentions are made public, fhall not be included in the above Pardon; but be proceeded against with the utmost Severity.

# TO OFFICERS ON HALF-PAY.

War-Office, August 1, 1801. LL Officers on the Half Pay of the Land A Forces, relident in Great Britain and Ireland, who are not ferving in the Militio, or who do not hold Offices under Government, are kereby required immediately to transmit to the General Ofbeers commanding in the Diffricts within which they refpectively relide, an Account, in Writing, of their Age, patt Services, and prefent Place of Abode, in order that their Services may be called for as Circumftances shall render it expedient : And fuch as think themfelves, from Age or Infumities, fuch as think themieives, from 1830 and anfit for further Service even in this Country, are the Perperts with follicient Vouto accompany their Reports with falileient V chers of their Inability, and the Caufes thereof.

Such Officers on Half-Pay as are ferving in the Militia, or are otherwife employed under Govern-ment, Officers of the Yeomaury and Voluateer

Corps excepted, whole Reports are to be made to the Generals commanding in Districts as above mentioned,) are to transmit fimilar Accounts to the Secretary at War, fpecifying also the Nature of the Public Situations which they posses.

The General Officers commanding in Districts will make Returns to the Secretary at War of the Names of the Officers who shall report themselves in purfuance of the above Notice. And every Officer who shall neglect to make his Report, either to the Commander of a Diftrict or to the Secretary at War, according to the Circumstances of his Situation, within One Month from the Date hereof, will be confidered as otherwife provided for, or dead, and his Name will be ftruck off the Half-Pay Lift accordingly.
