A PROCLAMATION,

Declaring the Coffation of Arms, as well by Sea as Land, agreed upon between His Majefly and the French Republic, and enjoining the Obfervance thereof.

GEORGE R:

7 HEREAS Preliminaries for refloring Peace between Us and the French Republic were figned at London on the First Day of this instant October, by the Plenipotentiary of Us, and by the Plenipotentiary of the French Republic : And whereas, for the putting an End to the Calamities of War, as foon and as far as may be possible, it hath been agreed between Us, and the French Republic, as follows; that is to fay, That as foon as the Preli. minaries shall be figned and ratified, Friendship should be established between Us and the French Republic, by Sea and Land, in all Parts of the World, and that all Hoftilities should cease immediately; and in order to prevent all Caufes of Complaint and Dispute which might arise on account of Prizes which might be made at Sea, after the Signature of the Preliminary Articles, it has been alfo reciprocally agreed, That the Veffels and Effects which might be taken in the British Channel and in the North Seas, after the Space of Twelve Days, to be computed from the Exchange of the Ratifications of the Preliminary Articles, should be reftored on each Side ; That the Term should be One Month from the British Channel and the North Seas as far as the Canary Islands inclusively, whether in the Ocean or in the Mediterranean ; Two Months from the faid Canary Islands, as far as the Equator; and laftly, Five Months in all other Parts of the World, without any Exception, or any more particular De. fcription of Time or Place: And whereas the Ratifications of the faid Preliminary Articles between Us and the French Republic were exchanged by the respective Plenipotentiaries of Us, and of the French | which are or may be in Force.

Republic, on the Tenth Day of this inflant October, from which Day the feveral Terms above-mentioned of Twelve Days, of One Mouth, of Two Months, and Five Months, are to be computed : And whereas it is Our Royal Will and Pleafure, That the Ceffation of Hollilities between Us and the French Republic fhould be agreeable to the feveral Epochs fixed between Us and the French Republic, We have thought fit, by and with the Advice of our Privy Council, to notify the fame to all Our loving Subjects; and We do declare, That Our Royal Will and Pleafure is, and We do hereby ftrictly charge and command all Our Officers both at Sea and Land, and all other Our Subjects whatfoever, to forbear all Acts of Hostility, either by Sea or Land, against the French Republic, and their Allies, their Vaffals or Subjects, from and after the respective Times above-mentioned, and under the Penalty of incurring Our highest Difpleafure.

And foraf-much as, for certain Caules, We are defirous that Our Parliament which now flands prorogued to Thursday the Twenty-second Day of this instant October, without Notice having been given requiring the fame then to meet for the Difpatch of Bufinels, fhould meet on an early Day thereafter for the Difpatch thereof, We, by and with the Advice of Our Privy Council, do, by this Our Royal Proclamation, publish and declare Our Royal Will and Intention, that Our faid Parliament shall Aand prorogued to, and shall meet and be holden
