NCLOSED I transmit to you a Copy of a Letter from Lieutenant Newton Starck, of the Milbrook Schooner, stating his Capture of a Spanish Privateer called the Baptista; and one from Captain Hollis, of the Thames Frigate, informing me of the Capture of the Sparrow Spanish Priva-teer by the Boats of the faid Ship in a spirited and gallant Manner, which I pray you to lay before my Lords Commissioners of the Admiralty.

His Majesty's Schooner Milbrook, off SIR, Cadiz, September 21, 1801.

Beg Leave to inform you, that on the 15th Inflant, being off Cape Montego in His Majesty's Schooner Milbrook, under my Command, to put myself under your Orders, I perceived a small Spanish Privateer, which, after a long Chase, I succeeded in securing: her Name is the Baptista, mounting Eight Guns, and was laden with a valuable Cargo of English Prize Butter, with which she was on her Passage from Vigo to Seville.
