Downing-Street, January 2, 1802. DISPATCH from the Refident of the Ho-A norable East India Company at Amboyna, deted 6th July 1801, of which the following is an Extract, has been received by the Court of Directors of the East India Company, and communi-cated to the Right Honorable Lord Hobart, One of His Majefly's Principal Secretaries of State.

I Do myfelf the Honor to congratulate your Lordílaip, in Council, on the important Event of the Surrender of Ternate to the British Arms, which was delivered over, by Capitulation, to Colonel Burr on the 21st Ultimo.

The Dutch Governor made a most refolute Re-The Dutch Governor made a molt resolute Re-filtance, having defended the Place with uncommon Firmnels for Fifty-two Days, though, I am forry to add, at the Expence of the poor Inhabitants, who perifhed, by Famine, from Ten to Twenty a Day, from our ftrong Blockade by Sea and Land. During this excellent Difposition of our Military and Marine Encode the latter under the Command

and Marine Forces, the latter under the Command of that gallant Officer Captain Hages, the annual Supplies for the Enemy were intercepted through his Vigilance, which certainly contributed, in a high Degree, to the ultimate Success of the Enterprife. The Value of the captured Property taken by the Squadron amounts to a Lack and Fifty Thoufand Dollars.

The Difficulties the Honorable Company's Forces by Sea and Laud had to encounter on this arduous Service, and the Spirit and Intrepidity which they manifelted during a Siege of nearly Two Months, do them infinite Credit, and have feldom or ever been exceeded in this Part of the Globe. The Accounts we have received of the Strength of Fort Orange, and its numerous detached Batteries, proved exceedingly erroneous, in fo much that Co-lonel Burr declares the Place to be extremely ftrong by Nature, and most excellently improved by Act, with a powerful Garrifon, and fo well provided with Arms and Ammunizion, as to throw Difficulties in the Way of our Force, which were as diffreffing as unexpected; they, however, perfevered and kept their Ground with fo much Bravery and Refolution as to compel the Enemy to furrender their different strong Holds, one after the other, until the principal Fort and Town were so completely blockaded both

by Sea and Land, and fo reduced by Famine, as to make them fue for Conditions, which, I understand, are very fatisfactory.

I am happy to inform your Lordship, in Council, that, arduous as this Service was, and much as our Forces were exposed to the repeated Attacks of the Enemy, the Lofs of Killed and Wounded of the Troops does not amount to above Nine or Ten; that of the Marine does not exceed Twelve Seamen.
