PRESENT, The KING's Moft Excellent Majefty in Council.

THEREAS the Time limited by His Majefty's Order in Council of the Twenty-feventh Day of June laft, prohibiting the Exportation into any Parts out of this Kingdom, of any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rofin, Turpentine, Anchors, Cables, Cordage, Mafts, Yards, Bowfprits, Oars, Oakum, Oker, Sheet-Copper, or other Naval Stores, will expire upon the Fourteenth of this inftant January : And whereas it is judged expedient for His Majefty's Service, and the Safety of this King-dom, that the faid Prohibition should be continued for some Time longer; His Majefty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Perfon or Perfons whofoever do, at any Time, for the Space of Two Months, to commence from the Fourteenth Day of this inftant January, prefume to transport into any Parts out of this Kingdom, any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rolin, Turpentine, Anchors, Cables, Cordage, Malts, Yards, Bowsprits, Oars, Oakum, Oker, Sheet-Copper, or other Naval Stores, or ship or lade any of the Articles abovementioned on board any Ship or Vessel, in order to transporting the fame into any Parts beyond the Seas, without Leave or Permission being first had and obtained from His Majefty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act, paffed in the Thirty-third Year of His Majefty's Reign, initialed "An Act to "enable His Majefty to reflrain the Exportation of "Naval Stores and more all formation." " Naval Stores, and more effectually to prevent the "Exportation of Salt-Petre, Arms, and Ammuni-"tion, when prohibited by Proclamation or Order in "Council :" But it is, neverthelefs, His Majefty's Pleafure, that nothing herein contained fhall extend, or be construed to extend, to any of His Majefty's Ships of War, or any other Ships or Veffels or Boats, in the Service of His Majefty, or em-ployed or freighted by His Majefty's. Board of Ordnance, or by the Commiffioners of His Ma-jefty's Navy; nor to prevent any Ship or Veffel from taking or having on board fuch Quantities of Naval Stores as may be neceffary for the Ufe of

T' the Court at St. James's, the 13th of Ja- 1 fuch Ship or Veffel during the Course of her intended Voyage, or by Licence from the Lord High Admiral of Great Britain, or the Commissioners of the Admiralty for the Time being; nor to the Exportation of the faid feveral Articles to Ireland, or to His Majefty's Yards or Garrifons, or to His Majefly's Colonics or Plantations in America or the Weft Indics, or to Newfoundland, or to His Majefty's Forts and Settlements on the Coaft of Africa, or to the Island of St. Helena, or to the Bri-tish Settlements or Factories in the East Indies : Provided that, upon the Exportation of any of the faid Articles, for the Purpoles of Trade, to Ire-land, or to His Majelty's Yards or Garrifons, or to His Majefty's Colonics and Plantations in America or the Welt Indies, or to the Ifland of Newfoundland, or to His Majesty's Forts and Settle-ments on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies, the Exporters of fuch Articles do first make Oath of the true Destination of the fame to the Places for which they shall be entered Outwards, before the Eutry of the fame shall be made, and do give sull and sufficient Security, by Bond, to the Satisfaction of the Commissioners of His Majefty's Cuftoms, to carry the faid Articles to the Places for which they are fo entered Outwards, and for the Purpofes fpecified, and none other; and fuch Bond fhall not be cancelled or delivered up, until Proof be made, to the Satisfaction of the faid Commillioners, by the Production, within a Time to be fixed by the faid Commi-fioners, and specified in the Bond, of a Certificate or Certificates, in fuch Form and Mauner as shall be directed by the faid Commiffioners, flewing that the faid Articles have been duly landed at the Places for which they were entered Outwards. And the Right Honorable the Lords Commissioners of His Majefty's Treafury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the neceffary Directions herein, as to them may respectively appertain.
