The KING's Most Excellent Majesty in Council. HEREAS the Time limited by His Majesty's · Order in Council of the Second Day of December last, prohibiting the Exportation out of this Kingdom, or carrying Coastwife, Gunpowder or Saltpetre, or any Sort of Arms or Ammunition, will expire upon the Seventh Day of this instant February: And whereas it is judged expedient for His Majesty's Service that the said Prohibition should be continued for some Time longer; His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Person or Persons whatsoever (except the Master General of the Ordnance for His Majesty's Service) do, at any Time during the Space of Two Months, to commence from the Seventh Day of this inftant February, presume to transport into any Parts out of this Kingdom, or carry Coastwife, any Gunpowder or Saltpetre, or any Sort of Arms or Ammunition, or ship or lade any Gunpowder or Saltpetre, or any Sort of Arms or Ammunition, on board any Ship or Vessel, in order to transporting the same into any Parts beyoud the Seas, or carrying the same Coastwise, without Leave or Permission in that Behalf first

obtained from His Majesty, or His Privy Council, upon Pain of incurring and fuffering the respective Forfeitures and Penalties inflicted by an Act, paffed in the Twenty-ninth Year of His late Majesty's . Reign, intituled " An Act to empower His Ma-"jetty to prohibit the Exportation of Saltpetre, " and to enforce the Law for empowering His Ma-" jesty to prohibit the Exportation of Gunpowder, " or any Sort of Arms and Ammunition; and also " to empower His Majesty to restrain the carrying " Coastwife of Saltpetre, Gunpowder, or any Sort " of Arms or Ammunition."-And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General of the Ordnance, and His Majesty's Secretary at War, are to give the necessary Directions herein, as to them may respectively appertain.
