Westminster, February 25, 1802. HIS Day the Lords being met, a Message was fent to the Honorable House of Commons by Sir Francis Molyneux, Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorized by virtue of His Majesty's Commission for declaring His Royal Assent to several Assengreed upon by both Houses, do desire the immediate Attendance of this Honorable House in the House of Peers to hear the Commission read; and the Commons being come thither, the faid Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the faid Acts, was read accordingly, and the Royal Assent given to

An Act for raising a further Sum of Money, by Loans or Exchequer Bills, for the Service of Great Britain for the Year One thousand eight hundred and two.

An Act for continuing the Premiums allowed to Ships employed in and for enlarging the Limits of the Southern Whale Fishery.

An Act to amend so much of an Act made in the Twenty-ninth Year of the Reign of His late Majefly King George the Second, intituled An Act for explaining, amending, and rendering more effectual an Act made in the Twenty-Second Year of His present Majesty's Reign, intituled An Act for making a Free Market for the Sale of Fish in the City of Westminster, and for preventing the fore-stalling and monopolizing of Fish, and for allowing the Sale of Fish, under the Dimensions mentioned in a Clause contained in an Act of the First Year of His late Majesty's Reign, in case the same are taken with a Hook, as relates to the Sale of Eels.

The Lord Chancellor has appointed Thomas Fooks, of Sherborne, in the County of Dorfet, Gent. to be a Master Extraordinary in the High Court of Chancery.

Whitehall, February 27, 1802. As several Artificers and Manufatturers, Subjects of Great Britain, have, from Time to Time, gone into Foreign Countries to exercise their several Callings, His Majesty's Dominions, as such Court shall think

contrary to the Locus of these Kingdoms, the following Alstraits of Ads of Parliament of Their late Majeflies King George the First and Second, and of His prefent Majefly, for preventing such Practices, are published; for the Information of all Persons who may be ignorant of the Penulius they may iron by Disobediente to them: And it will be observed, that such Penulius likewife extend to toose who are any ways concerned or instrumental in the Sending or Entiring Artificers or Manufacturers out of thefe Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well as to the Artistcers or Manufacturers themselves.

Statute 5 George 1. Chap. 27. IF any Person shall contract with, entice, or solicit, any Artificer in Wool, Iron, Steel, Brass, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries out of the King's Dominions, and faull be convicted thereof, upon Indictment or Information in any of the Courts at Westminsler, or at the Affizes or Quarter Sellions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Perfon having been once convicted shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be

If any of the King's Subjects, being such Artificers, shall go into any Country out of His Majelly's Dominions, to exercise or teach the said Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercising any of the said Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister, or Consul of Great Britain, in the Country where fuch Artificers shall be, or by any Person authorised by such Ambassador, &c. or by one of the Secretaries of State, and from henceforth inhabit within this Realm; fuch Perfons shall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Defcent, Devile, or Purchase, and shall forfeit all Lands, Goods, &c. within this Kingdom, to His Majesty's Use, and shall be deemed Alien, and out of His

Majesty's Protection.

Upon Complaint made, upon Oath, before any Justice of Peace, that any Person is endeavouring to seduce any such Artisicer, or that any such Artificer hath contracted or is preparing to go out of His Majesty's Dominions, for the Purposes aforefaid, fuch Justice may fend his Warrant to bring the Person complained of before him, or before fome other Justice; and if it shall appear by the Oath of One Witness, or by Confession, that he was guilty of any of the faid Offences, fuch Justice may bind him to appear at the next Affizes or Quarter Seffions: And if fuch Person shall refuse to give Security, the Justice may commit him to Gaol till the next Assizes or Quarter Schoons, and until he shall be delivered by due Course of Law. And if any such Artificer shall be convicted, upon Indictment, of any such Promise, Contract, or Preparation to go beyond the Seas, for the Purpose aforesaid, he shall-

reasonable, and shall be imprisoned till Security. .given.

If any of the above Offences shall be committed in Scotland, the same shall be prosecuted in the Court of Justiciary or the Circuits there.

## Statute 23 George II. Chap. 13.

IF any Person shall contract with, or endeavour to seduce any Artisteer in Wool, Mohair, Cotton, or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland into any Foreign Country not within the Dominions of the Crown of Great Britain, and shall be convicted, upon Indictment or Information, in the Kings Bench at Westminster, or by Indictment at the Assizes or General Gaol Delivery for the County, &c. wherein such Offence shall be committed in England, or by Indictment in the Court of Justiciary or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Dublin, if fuch Offence be committed in Ireland : the Person so convicted shall, for every Artificer contracted with or feduced, forteit FIVE HUNDRED POUNDS, and shall suffer Imprifonment in the Common Gaol of the County or Stewartry wherein fuch Offeuder shall be convicted for Twelve Calendar Months, and until Forfeiture be paid: And in case of a subsequent Offence of the fame Kind, the Persons so again offending thall forseit, for every Person contracted with or seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein fuch Offender shall be convicted, for Two Years, and until such Forfeiture be paid.

If any Perfon in Great Britain or Ireland shall put on hoard any Ship or Boat, not bound directly to Some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any fuch Tools or Utenfils as are commonly used in, or proper for the Preparing, Working up, or Finishing of the Woollen or Silk Manufactures, or any Part of such Tools, he shall, for every Oftence, forfeit all fuch Tools, or Parts thereof, put on board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Seffion in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Essoin, &c. shall be

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to feize and fecure, in some of His Majesty's Warehouses, all such Tools or Utentils prohibited to be exported, as such Officer shall find on board any Vessel not bound directly to some Port in Great-Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all Tools so seized shall, after Condemnation, be pubkely fold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall feize and secure the same.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the faid Tools, |

prohibited to be exported, to be put on board his Vestel, he shall, for every such Offence, forfeit ONE HUNDRED POUNDS, to be recovered as the Penalties inflicted upon Perfons exporting the Tools; and, if the Vessel belongs to His Majelly, the Captain shall not only forfeit ONE HUNDRED POUNDS, but shall also forfeit his Employment, and be incapable of any Employment under His Majelty.

If any Officer of the Customs in Great Britain or of the Revenue in Ireland, take, or knowingly fuffer to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting of any of the faid Tools, or knowingly fuffer the fame to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforefaid, and also forfeit his Office, and be incapable of any Office under His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the fame.

Statutes 14, 21, 25, and 26 of His prefent Majesty. BY these Statutes the like Penalties and Forfeitures as above-mentioned are-extended to Perfons packing or putting on board any Vessel, not bound directly for some Port in Great Britain or Ireland, any Machine, Engine, Tool, Press, Paper, Utensil, or Implement whatfover, used in or proper for the working or finishing of the Cotton, Steel, or Iron Manufactures of this Kingdom, or any Part or Parts of fuch Machines or Implements, or any Models or Plans thereof; and all Captains of Ships and other Persons receiving or being in Possession of any such Articles, with an Intent to export the same to Foreign Parts, and all Custom-house Officers fuffering an Entry to le made thereof, are respectively liable to the like Penalties as are above-mentioned, in the case of Tools and Utenfils used in the Woollen and Siik Manusactures.
