The KING's Most Excellent Majesty in Council.

THEREAS the Time limited by His Majesty's Order in Council, of the Tenth of February last, prohibiting the exporting into any Parts beyond the Seas, within the Limits of Europe, of any Sheet Copper, or Copper in Boltstaves, Bars, Sheets, Rings, and Nails, or of Copper in such a State as may be easily converted into, or made useful as a Naval Store, will expire upon the Twelfth Day of April next; And whereas it is judged expedient for His Majesty's Service, that the said Prohibition should be continued for some Time longer, His Majesty doth, therefore, with the Advice of His Privy Council, hereby order, require, and command, That no Person or Persons whosever do, at any Time during the Space of Two Months, to commence from the Twelfth Day of April next, presume to export out of this Kingdom to any Parts beyond the Seas, within the Limits of Europe, any Sheet Copper, or Copper in Boltstaves, Bars, Sheets, Rings, and Nails, or any Copper capable of being converted into a Naval Store, or ship, or lade any of the Articles above-mentioned, on board any Ship or Veffel in order to exporting the same beyond the Seas, without Leave or Permission being first had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act passed in the Thirty third Year of His Majesty's Reign, Cap. 2. and also by an Act passed in the Thirty-fourth Year of His Majesty's Reign, Cap. 34: But it is nevertheless His Majesty's Pleasure, that nothing herein contained shall extend or be construed to extend to the Exportation of any of the aforesaid Articles from Great Britain to Ireland, or from Ireland to Great Britain, respectively, or to any Exportation of any of the faid Articles, by, or on board of His Majesty's Ships of War, or any other Ships, or Vessels, or Boats in the Service of His Majesty, or employed or freighted by His Majesty's Board of Ordnance, or by the Commissioners of His Majesty's Navy; nor to prevent any Ship or Veffel from taking or | spectively appertains
