HEREAS a Definitive Treaty of Peace

Republick, His Catholick Majesty, and the Batavian Republick, hath been concluded at Amiens, on the Twenty-seventh Day of March last, and the Ratifications thereof have been duly exchanged: In Conformity thereunto, We have thought fit hereby to command that the same be published throughout all Our Dominions: And We do declare to all Our loving Subjects Our Will and Pleasure, that the faid Treaty of Peace and Friendship be observed inviolably as well by Sea as Land, and in all Places whatsoever; strictly charging and commanding all Our loving Subjects to take Notice hereof, and to conform themselves thereunto accordingly.

THEREAS by an Act passed in the Thirtyfourth Year of Our Reign, intituled, An A& for the further Encouragement of British Mariners, and for other Purposes therein mentioned, various Provisions are made which are directed to take Effect from and after the Expiration of Six Months from the Conclusion of the then existing War, to be notified in Manner therein mentioned; and it is thereby further enacted, that, for the Purposes of the faid Act, the Conclusion of the faid War shall be holden to be from the Time that the fame shall be notified by Our Royal Proclamation, or Order in Council, to be published in the London Gazette: And whereas a Definitive Treaty of Peace has been duly ratified between Us, the French Republick, His Catholick Majesty, and the and Friendship between Us, the French Batavian Republick; We have therefore thought

fit, by and with the Advice of Our Privy Council, for the Purposes of the said Act, hereby to notify and declare the Conclusion of the said War, by this Our Royal Proclamation, to be published in the London Gazette; and We do direct the same to be published accordingly.
