#### PROCLAMATION, A For a Public THANKSGIVING.

## GEORGE R.

JHEREAS by Our Proclamation of the Twenty-fixth Day of April last, We did appoint and command, that a General Thankfgiving to Almighty God should be observed throughout that Part of Our Kingdom called Scotland, upon Tuesday the First Day of June next: And whereas it hath been represented to Us, That the faid Day will be inconvenient for the Celebration thereof, on account of the Sitting of the General Affembly of the Church of Scotland : We, therefore, have thought fit, by the Advice of Our Privy Council, to iffue this Our Royal Proclamation, hereby appointing and commanding, that the faid General Thankfgiving to Almighty God, be obferved throughout that Part of Our Kingdom called Scotland, upon Thurfday the Seventeenth Day of June next, inflead of Tuefday the First Day of June next: And We do firicily charge and command, That the faid Publick Thanksgiving be reverently and decently observed by all Our loving Subjects in Scotland, on the faid Seventeenth Day of June next, as they tender the Favour of Almighty God, and would avoid His Wrath and Indignation, and upon Pain of fuch Punishment as We may justly inflict on all fuch as contemn or neglect the Performance of fo religious a Duty: Our Will and Pleasure is therefore, and We charge, That this Our Proclamation feen, ye pais to the Market Crofs of Edinburgh, and all other Places needful, and there, in Our Name and Authority; make Publication thereof, that none pretend Ignorance; and Our Will and Pleafure is, That Our Solicitor do caufe printed Copies hereof to be fent to the Sheriffs of the feveral Shires, Stewarts of Stewartries, and Bailiffs of Regalities, and their Clerks, whom We ordain to fee the fame published : And We appoint | Sir Francis Molyneux, Gentleman Uffer of the

them to fend Copies thereof to the feveral Parifs Churches within their Bounds, that upon the Lord's Day immediately preceding the Day above-mentioned, the fame may be published and read from the Pulpits immediately after Divine Service.

## PRESENT,

The KING's Most Excellent Majesty in Council.

T is this Day ordered by His Majesty in Council That the Prohibitions now fublishing under divers Orders of His Majefty in Council, on the Exportation out of this Kingdom or carrying Coaftwife, Gunpowder, Saltpetre, or any Sort of Arms or Ammunition; and on the Exportation of certain Articles of Naval Stores; and of the Wood called Lignum Vitæ; and also the Prohibition on the Exportation of any Sheet Copper, or Copper in Bolt Staves, Bars, Rings, Sheets, or Nails, or any Copper capable of being converted into a Naval Store, to any Parts beyond the Seas' within the Limits of Europe, be, and the feveral Prohibitions are hereby taken off: And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master General of the Ordnance, and His Majefty's Secretary at Wary are to give the neceffary Directions herein, as to them may respectively appertain. An Act to enable the Lords Commiffioners of His Majelty's Treafury of Great Britain to iffue Exchequer Bills on the Credit of fuch Aids or :Supplies as have been or fhall be granted by Parliament for the Service of Great Britain for the Ycar One thousand eight hundred and two.

An Act for repealing the Duties on Income; for the effectual Collection of Arrears of the faid Duties, and accounting for the fame; and for charging the Annuitics specifically charged thereon upon the Confolidated Fund of Great Britain.

An Act for improving the Tinmouth Callle 'Light House and 'Light, and for authorising additional Light Duties in respect of such Improvement.

An Act for continuing the Term and altering and enlarging the Powers of Two feveral Acts paffed in the Twenty-fixth Year of the Reign of His late Majefty King George the Second, and in the Nineteenth Year of the Reign of His prefent Majefty, for repairing the Road from Afhby-de-la-Zouch, in the County of Leicefter, through Burton upon-Trent, in the County of Stafford, and to the Cock Inn, in Tutbury, in the faid County.

An Act for making and maintaining a Turnpike-Road from a Place called the Crown-Hill, in the Town of Newent, in the County of Gloucester, to join the Turnpike-Road leading from the City of Hereford towards Newnham, in the County of Gloucester; and alfo another Road leading from the Bottom of Kilcott-Hill, in the Parish of Newent aforefaid, towards the Town and Forest of Deane, in the County of Gloucester, with a Branch from the fame towards Ledbury, in the County of Hereford.

An Act for authorifing the Truffees of the Will of the Honorable Richard Walpole to fell certain Parts of his Copyhold Effates, in the County of Norfolk, for the Payment of his Debts.

## Westminster, May 7, 1802.

THIS Day the Lords being met, a Meffage was fent to the Honorable Houfe of Commons by Sir Francis Molyneux, Gentleman Ufher of the Black Rod, acquainting them, that The Lords, authorifed by virtue of His Majefly's Commission for decharing His Royal Affent to several Ads agreed upon by sboth Houfes, do desire the immediate Attendance of the Honorable Houfe in the Houfe of Peers to hear the Commission read; and the Commons being come thither, the faid Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Affent to the faid Acts, was read accordingly, and the Royal Affent given to An Act for granting to His Majefty certain Duties on Goods imported into, and exported from Great Britain, and on the Tonnage of Ships and Veffels entering outwards or inwards in any Port of Great Britain, to or from foreign Parts.

An A& for permitting French Wines to be imported into Great Britain, in Bottles or Flasks, under certain Restrictions.

An Act to continue until Three Months after any Reftriction imposed by any Act of the present Seffion of Parliament on the Bank of England, from iffuing Cash in Payments shall cease, an Act made in the Parliament of Ireland, in the Thirty-feventh Year of the Reign of His present Majesty for confirming and continuing the Restrictions on Payments in Cash by the Bank of Ireland.

An Act to require Overleers and Guardians of the Poor to keep a Register of the feveral Children who shall be bound or assigned by them as Apprentices, and to extend the Provisions of an Act passed in the Twentieth Year of the Reign of His prefent Majesty to the binding of Apprentices by Houses of Industry, or Establishments for the Poor, which have been authorised to to do by subsequent Acts.

An Act to authorife the Advancement of further Sums of Money out of the Confolidated Fund for completing the Canal and other Works, which, by an Act paffed in the Thirty-ninth Year of His prefent Majefty's Reign, intituled An Act for rendering more commodious, and for better regulating the Port of London, were directed to be made and done by the Mayor, Aldermen, and Commons of the City of London, in Common Council affembled.

An Act for opening feveral new Streets in the Town of Kilmarnock, and County of Ayr; for altering and widening fome of the Streets, Lanes, and Paffages within the faid Town; for building Two new Bridges over the Water of Kilmarnock for removing the prefent Slaughter Houfes in the faid Town, and building new ones, and a Town-Hall and Guard Houfe; for enlarging and repairing the Gaol or Tolbooth; for enlarging the Burial Ground of the faid Town; for paving the faid Town and Places adjoining thereto, and removing Nuifances and Annoyances therein; and for extending the Jurifdiction of the Magiltrates of the faid Town over certain adjacent Lands.

An Act for building and maintaining a Houfe of Correction in and for the City and County of Aberdeen, and for raifing a Fund for defraying the Charges of apprehending, proferuting, and fubfifting Criminals, Rogues, and Vagabonds found within the faid City and Liberties thereof.

An Act to repeal an Act paffed in the Twelfth Year of the Reign of His prefent Majefty King George the Third, intituled An Act for draining the Low Grounds and Carrs lying in the feveral Parifhes, Townfhips, and Places of Keyingham, Keyingbam Marfh, Ryhill, and Camerton, Burftwick, and Skeckling, Burton Pidfea, and Ridgmont, Ottringham, Halfham, Owftwick, Roofs, Rimfwell, Tunftall, Waxholme, Elfternwick, Lelley, Humbleton, Fitling, Hilfton, Garton, Albrough, Flinton, and Sanfterne, within the Seignory of Holdernefs, and Eaft Riding of the County of York ; and to render more effectual the Drainage of all and ingular the Lands and Grounds within the faid Leveral Parifhes, Townfhips, and Places, and within all other Townships, Hamlets, and Places within, or Parcel, or Member of the feveral Parifhes mentionened, or any of them refpectively.

An Act for amending, widening, improving, and keeping in Repair the Road leading from, or nearly from, Porthaethway Ferry, otherwife called Gangor Ferry, in the County of Caernarvon, to or near a Pentre Voelas, in the Parish of Llanufydd, in the County of Denbigh.

An Act for altering, amending, and enlarging the Powers of fo much of an Act paffed in the Forty-first Year of the Reign of His prefent Majesty for repairing the Roads from the Town of Stockbridge, in the County of Southampton, to the City of Winchefter, and from the faid City, through Bellmour-Lane, to the Top of Stephen's Caftle-Down, near the Town of Bishop's Waltham, in the faid County, and from the faid City of Winchefter, through Otterborne to Bar Gate, in the Town and County of the Town of Southampton, as relates to the South District of the Southampton Road.
