7 HEREAS a Definitive Treaty of Peace and Friendship between Us, the French Republick, His Catholick Majefty, and the Ba-tavian Republick, hath been concluded at Amiens, on the Twenty feventh Day of March laft, and the Ratifications thereof have been duly exchanged : In Conformity thereunto, We have thought fit hereby to command that the fame be published throughout all Our Dominions: And We do declare to all Our loving Subjects Our Will and Pleafure, that the faid Treaty of Peace and Friendship be observed inviolably as well by Sea as Land, and in all Places whatfoever; strictly charging and commanding all Our loving Subjects to take Notice hereof, and to conform themfelves thereunto accordingly.

PROCLAMATION, Declaring the Conclusion of the War.

GEORGE R.

WHEREAS by an Act passed in the Thirty-fourth Year of Our Reign, intituled, An Act for the further Encouragement of British Mariners, and for other Purposes therein mentioned, various Provisions are made which are directed to take Effect from and after the Expiration of Six Months from the Conclusions of the then exifting War, to be notified in Manner therein mentioned ; and it is thereby further enacted, that, for the Purpoles of the faid Act, the Conclusion of the faid War shall be holden to be from the Time that the fame shall be notified by Our Royal Proclamation, er Order in Council, to be published in the London Gazette : And whereas a Definitive Treaty of Peace has been duly ratified between Us, the French-Republick, His Catholick Majefty, and the mighty God, and upon Pain of fuffering fuch Pu-

Batavian Republick ; We have therefore thought fit, by and with the Advice of Our Privy Council, for the Furpoles of the faid Act, hereby to notify and declare the Conclusion of the faid War, by this Our Royal Proclamation, to be published in the London Gazette; and We do direct the fame to be published accordingly.

PROCLAMATION, For a Public THANKSGIVING.

HEREAS it has pleafed Almighty God, in His great Goodnels, to put an End to the hate bloody, extended, and expensive War, in which We were engaged; We therefore, adoring the Di-vine Goodness, and duly confidering that the great and publick Bleffings of Peace do call for publick and folemn Acknowledgments, have thought fit, by the Advice of Our Privy Council, to issue this Our Royal Proclamation, hereby appointing and com-manding, That a General Thankfgiving to Al-mighty God, for thefe His Mercies, he obferved throughout those Parts of Our United Kingdom called England and Ireland, on Tuesday the First Day of June next: And for the better and more flexibut Solemnization of the fame, We have given Directions to the Most Reverend the Archbishops, and the Right Reverend the Bishops of England, to compole a Form of Prayer fuitable to this Occa-tion, to be used in all Churches and Chapels, and other Places of publick Worship, and to take Care for the timely difperfing of the fame throughout their respective Dioceses : And We do strictly charge and command, That the faid Publick Day

PROCLAMATION, For a Public THANKSGIVING.

GEORGE R.

WHEREAS by Our Proclamation of the Twenty-fixth Day of April laft, We did appoint and command, that a General Thankfigiving to Almighty God fhould be observed throughout that Part of Our Kingdom called Scotland, upon Tuefday the First Day of June next: And whereas it hath been reprefented to U:, That the faid Day will be inconvenient for the Celebration thereof, on account of the Sitting of the General Affembly of the Church of Scotland : We, therefore, have thought ht, by the Advice of Our Privy Council, to iffue this Our Royal Proclamation; hereby appointing and commanding, illut the faid General Thankligiving to Althighty God, be obferved throughout that Part of Our Kingdom called Scotland, upon Thursday the Seventeenth Day of June next, initead of Tuesday the First Day of June next: And We do strictly charge and command, That the faid Publick Thanksgiving be reverently and decently observed by all Our loving Subjects in Scotland, on the fald Seventeentli Day of June next. as they tender the Favour of Almighty God, and would avoid His Wrath and Indignation, and upon Pain of fuch Punifhment as We may jully inflict on all fuch as contemn of neglect the Performance of to religious a Duty: Our Will and Pleafure is therefore, and We charge, That this Our Proclamation feen, ye pals to the Market Crofs of Edinburgh, and all other Places needful, and there, in Our Name and Authority, make Publication thereof, that none pretend Ignorance; and Our Will and Pleafure is, That Our Solicitor do caufe printed Copies hereof to be fent to the Sheriffs of the feveral Shires, Stewarts of Srewartries, and Bailiffs of Regalities, and their Clerks, whom We ordain to fee the fame published : And We appoint them to fend Copies thereof to the feveral Parish Churches within their Bounds, that upon the Lord's Day immediately preceding the Day above-men-tioned, the fame may be published and read from the Pulpits immediately after Divine Service.

The humble Address of the Lord Mayor, Aldermen, and Commons of the City of London, is Common-Cohneil allembled.

May it pleafe your Majeffy, WE, your Majeity's moit dutiful and loyal Sub-jects, the Lord Mayor, Aldermen, and Commons of the City of London, in Common-Council affembled, beg Leave to approach the Throne with the most lively Sentiments of Allegiance, Gratitude, and Affection, to congratulate you? Mejelly on the Return of Peace to the United Kingdom, over which Providence has placed your Majefty, not more confpicuoufly to govern than to blefs.

They will perceive that a faithful Adherence to the Laws, and a Reverence for the Conftitution that framed them, are infeparable : and that, by their unshaken Loyalty to their Sovereign, their unfwerving Attachment to the revered System of our Anceltors, that Conflictution has, under Providence, been hitherto preferved, and will be able to flem the Torrent of Ages yet to come. Your Majefty's loyal Citizens of London renew

IIS Majelty having been pleafed to order that there shall be a Watch Light on the Northern Coaft of Bornholm, to guide the Navigators of the Baltic, we give Notice, That Examination having been made of the most convenient Place from whence the Light might be most diffinctly feen, as well by those who come from the Weft as by those who · come from the East and the North, and who wish to pals between Bornholm and the Coaft of Sweden, a Light-Houfe has been conftructed on the Mountain called Steileberg, which is fituated, by the Compafs, about a Quarter of a Mile from the Northernmost Bay of Bornholm. In confequence of the Height of this Mountain, this Light-Houfe will be 272 Feet above the Level of the Water. Although it is lighted by Means of a Coal Fire, it is furrounded by a Glafs Cafe or Lanthorn of 14 Feet Diameter, conftructed upon a New Principle, fo that, in all Weathers, the Flame will rife without Interruption, and the Light will be augmented

by it, because that Part of the Cule or Lanthorn which is on the Land Side, and every Part from whence the Light cannot be feen at Sea, is a Wall, the Interior of which is covered with Plates of palifted Block-Tin.

This Light-Houfe will be lighted up for the first Time, on the 24ll June 1802, and afterwards it will be continued according to the Terms of the Ordonnance of the 21ft March 1705, and of the Proclamation of the 1ft February 1799, fo that in Summer, that is from Eafter-Day to Michaelmas Day, it will be kept burning from an Honr after Sunfet till Sunrife, and in Winter, that is, from Michaelmas-Day to Eafler Day, from Half an Hour after Sunfet till Sunrife.
